Renaissance Society of America

The RSA recently overhauled its funding structure, so we thought now would be a good time to feature them. "The Renaissance Society of America is the largest international learned society devoted to the study of the era 1300–1700.... Members identify with one or more disciplinary groups. The number of these groups has grown over the years, reflecting the field's vibrancy and diversity. They are Americas, Art and Architecture, Book History, Classical Tradition, Comparative Literature, Digital Humanities, Emblems, English Literature, French Literature, Germanic Literature, Hebraica, Hispanic Literature, History, Humanism, Islamic World, Italian Literature, Legal and Political Thought, Medicine and Science, Music, Neo-Latin Literature, Performing Arts and Theater, Philosophy, Religion, Rhetoric, Women and Gender."

"The Society awards a number of competitive fellowships to members each year supporting individual research projects and publications that advance scholarly knowledge about the period 1300-1700. The purpose of the fellowships, both residential and non-residential, is to support members who need to travel to archives, libraries, and historic sites to conduct short-term research (usually 1–2 months), and then to publish their results for the scholarly community and the general public." **The deadline for all applications is September 15, 2018.**

The RSA supports residential fellowships in all disciplines and short-term research library fellowships for art historians:

- The RSA-Bodleian Library Fellowship, Oxford University, UK,
- The RSA–Patricia H. Labalme Fellowship, Centro Vittore Branca at Fondazione Giorgio Cini, Venice, Italy

In addition, "The Renaissance Society of America will award up to thirteen RSA research fellowships in amounts of \$3,000 for research travel. All applicants for a Short-Term Research Fellowship are automatically considered for the Kristeller Fellowship, and may indicate if they also wish to be considered for the Palisca and Pedretti Fellowships, if eligible."

- Paul Oskar Kristeller Fellowship in all subjects
- RSA Short-Term Research Fellowship in all subjects. These are usually divided evenly between Senior, Junior, and Non-doctoral scholars.
- Claude V. Palisca Fellowship in Musicology

Art Historians may also apply for "up to five Samuel H. Kress Mid-Career Research and Publication Fellowships of \$3,000 each. These fellowships are intended especially to support the costs of publication in the history of art, but in some cases may be awarded for research travel costs for art history projects."

Sage Advice for Competitive Proposals

Barnard's own Sponsored Research Manager, Pamela Tuffley, is currently pursuing a graduate degree in Research Administration at Johns Hopkins University. (We're all very proud here in Institutional Funding and Sponsored Research.) This installment of Sage Advice digs into her prodigious and aptly titled textbook, *Research Administration and Management*, for insights into the **peer review process**.

Generally, "peer reviewer" means someone with expertise relevant to the parameters of the request for proposal. Pamela E. Miller, Ph.D., the author on the chapter on "Peer Review and Project Implementation and Evaluation," states that "the agency tries to find panelists within the same or related scientific discipline that have had peer-reviewed journal and book publications as well as external funding from recognized private or governmental funding agencies. Often a funding agency chooses reviewers whom the agency has supported with grant or contract funds in the past."

Miller refers to research conducted by the text book editors, Elliot C. Kulakowski, Ph.D., FAHA, and Lynne U. Chronister, MPA, to warn that, "biases do occur." "The peer review process is often unduly affected by biases for or against specific theoretical frameworks, methodologies, investigators, and institutions." Some agencies, including the National Science Foundation, try to offset the danger of bias by allowing applicants to list reviewers they would prefer not review their proposals. Otherwise, the "applicant can only hope that the other peer reviewers will counteract any unwarranted negative review.... Ultimately, the best defense is a good offense: in short, write a good proposal!" Easier said than done. See Sage Advice in past newsletters for tips on how to plan, write, and not bungle a proposal.

The author offers a pointer: "Under the federal Freedom of Information Act (FOIA), many agencies will provide novice applicants with copies of successful proposals to be used as a guide (not to be copied verbatim) that illustrate the agency's proposal criteria."

She also advises scholars to sit on peer-review panels themselves to improve their grant-writing skills, and she spends some time discussing how to go about securing such an invitation. "The question of how to get noticed, if one is a researcher, has one good answer: publish, publish, and publish! Another good answer is to present papers at professional conferences where you work is likely to be noticed by program officers in attendance." Conversely, "go to other conference sessions, especially those that indicate that the research was funded by an external agency. The presenter is likely to be a peer reviewer, and there maybe an agency representative in the audience. Pay attention to what is presented and ask interesting questions! "

Perhaps stating the obvious, Miller also suggests, "if a program officer or an agency representative wants to talk about your research, make yourself available!" (I realize that's the fourth exclamation point I've quoted. The author appears to have a fondness for them—unusual for a textbook, wouldn't you say?) Miller even goes so far as to suggest that researchers "monitor the Federal Register for opportunities to comment on proposed agency guidelines.... Submission of well-thought-out suggestions can give your name recognition."

News from the NSF

The Next NSF Grants Conference will be held November 8-9, 2018, in New Orleans, LA. Registration will open Thursday, September 6th at 12:00 PM EST.

For additional details and to sign up to receive information about this conference and other events, visit the Grants Conference website.

Key officials representing each NSF program directorate, administrative office, Office of the General Counsel and Office of the Inspector General will participate in the two-day conference. The conference is designed for new faculty, researchers, educators and administrators who want to gain insight into a wide range of important and timely issues at NSF including: the state of current funding; the proposal and award process; and current and recently updated policies and procedures.

Topics will include:

- An introduction to NSF;
- NSF's proposal preparation and merit review process;
- Award management;
- Conflict of interest policies;
- New programs and initiatives;
- Cross-disciplinary and special interest programs; and
- Breakout sessions by discipline.

NSF's Promising Practices – an update on NSF's February notice regarding Harassment-Free Research Workplaces

NSF's Promising Practices portal "will serve as a living resource for the community to utilize in bolstering anti-harassment policies and practices at NSF-funded organizations. This resource houses a collection of standards of behaviors tailored to field sites, facilities, ships, and conferences. It also provides a collection of federal definitions, reporting practices, organizational responses to reporting, and other practices that were

established to improve climate and culture. NSF welcomes feedback from the community on this portal; feedback, suggestion for practices, and other comments may be submitted via NSF's Harassment Portal Feedback Form."

From NIH eSubmission Items of Interest - July 31, 2018:

"Where Do I Put the [Application] Information I Know [NIH and Reviewers] Want, But Didn't Ask For?

You want to give staff and reviewers ALL the information you think they need to provide a thorough review of your proposal. There is certainly nothing wrong with that - right? Well, actually it depends. The application guide and funding opportunity announcement provide very specific guidance on what to include in your application and, in some cases, there are page limits you must stay within to convey the requested information.

If you have information that doesn't fit in page-limited attachments like your Specific Aims and Research Strategy, rework those attachments until you tell the best story possible within the confines of the page limits. Do not try to stuff that extra information into other non-limited fields of the application forms. Similarly, if you have information that doesn't have a "natural home" based on our instructions, don't include it. There are several form fields with tempting names like "Appendix," "Other Attachments," "Other Requested Information," and "Other Clinical Trial-related Attachments." DO NOT use those fields unless requested to do so in the application guide or announcement.

Why not? Even if you have the best of intentions, you need to resist the temptation to force fit information into your application where it doesn't belong. The page limits and guidance are there for fairness and you may find your application pulled from consideration if you try to get around them (NOT-OD-11-080)."

News and Grant Opportunities

"The Duplication Balancing Act [between the Research Strategy attachment and the PHS Human Subjects and Clinical Trials Information form]

The application guide statement "do not duplicate information between the Research Strategy attachment and the PHS Human Subjects and Clinical Trials Information form" appears to be causing some angst in the community. In fact, our new human subjects form invites a certain amount of overlap between the sections. It would be difficult, for example, to provide a "Brief Summary" of a protocol without talking about information captured elsewhere in the application. The point we were actually trying to make is that we don't want you to copy and paste blocks of text into multiple places in your application. Your Specific Aims and Research Strategy should include enough human subjects and clinical trial information to tell a cohesive and complete story. The human subjects form is meant to provide structured, supporting details for the study (sorry, it isn't just extra space to expound on the research strategy). The Brief Summary in the Protocol Synopsys section of the human subjects form aligns with what the public would see in ClinicalTrials.gov without the benefit of the full application. It should hit the key points at a very high level in as close to plain language as possible. The bottom line is there will be some overlap of information within your application, but reviewers should not be reading blocks of text copied verbatim into multiple sections of the application."

William T. Grant Foundation Institutional Challenge Grants

Deadline: September 17, 2018

"The award supports research institutions to build sustained research-practice partnerships with public agencies or nonprofit organizations in order to reduce inequality in youth outcomes. Research institutions will need to address four important goals:

- Build a sustained institutional partnership with a public agency or nonprofit organization that serves young people in the United States.

Deadline: September 30, 2018

Google Faculty Research Awards are structured as seed funding to support one graduate student for one year and are awarded as an unrestricted gift." <<more>>

National Geographic Foundation Early Career Grant and Exploration Grant

Deadline: October 3, 2018

"All proposed projects should be bold, innovative, and potentially transformative and have a primary focus in conservation, education, research, storytelling, or technology. Projects should also align to one of our three focus areas. We do not usually consider applications that support strictly laboratory or collections work. Grants are awarded on the basis of merit and exist independent of the Society's other divisions. Please note that this is a highly

competitive grant program; we receive many more applications than we are able to fund."

School for Advanced Research Residential Scholars

<u>Deadline</u>: November 5, 2018 (first Monday in November of every year)

Resident scholars may approach their research from the perspective of anthropology or from related fields such as history and sociology. <u>Deadline</u>: November 1, 2018

Fellowships will be awarded for 2018-2019 in Sculpture and the History of Art and Architecture "The Howard Foundation awards a limited number of fellowships each year for independent projects in selected fields, targeting its support specifically to early mid-career individuals, those who have achieved recognition for at least one major project....

Fellowships are offered in a five-year sequence of fields. Successful candidates are given the option of postponing receipt of their fellowship, so as to make the Howard competition accessible to those whose personal plans do not line up exactly with the year in which awards are offered in their fields." <<mor>

Harvard University Loeb Classical Library Fellowships

Deadline: November 1, 2018

"The Loeb Classical Library Foundation awards fellowships to qualified scholars to support research, publication, and other projects in the area of classical studies. Fellowships will normally range from \$1,000 to \$35,000, and may occasionally exceed that limit in the case of unusually interesting and promising projects. Applicants must have faculty or faculty emeritus status at a college or university at the time of application and during the entire time covered by the fellowship. Fellowships may be used for a wide variety of purposes. Examples include publication of research, enhancement of sabbaticals, travel to libraries or collections, dramatic productions, excavation expenses, or cost of research materials." <<more>>

University of Wisconsin Institute for Research in the Humanities Solmsen Post-doctoral Fellowships

Deadline: November 2, 2018

The program "offers five Solmsen Fellowships each year to scholars outside UW-Madison working in the humanities on European history and culture in the classical, medieval, and/or early modern periods before 1700. Projects on the relationship of pre-1700 Europe to other parts of the world are also welcome. Fellows are expected to be in residence throughout the academic year (except for short research trips, lectures, conferences, etc.) and may extend their residency through the following summer on a non-stipendary basis."

Pollock-Krasner Foundation Individual and Organization Grants

Deadline: rolling

"The Pollock-Krasner Foundation's mission is to aid, internationally, those individuals who have worked as artists over a significant period of time. The Foundation's dual criteria for grants are recognizable artistic merit and financial need, whether professional, personal, or both.... The Foundation welcomes, throughout the year, applications from visual artists who are painters, sculptors and artists who work on paper, including printmakers. There are no deadlines. The Foundation encourages applications from artists who have genuine financial needs that are not necessarily catastrophic. Grants are intended for a one-year period of time."

EDUCATION

National Council of Teachers of Mathematics PreK-6 Classroom Research

Deadline: November 2, 2018

"The purpose of this grant is to support and encourage classroom-based research in precollege mathematics education in collaboration with college or university mathematics educators. For 2018-19, grants with a maximum of \$6,000 each

will be awarded to mathematics educators or classroom teachers* currently teaching mathematics at the grades Pre-K-6 level. The research must be a collaborative effort involving a college or university mathematics educator (a mathematics education researcher or a teacher of mathematics learning, teaching, or curriculum) and one or more grades Pre-K-6 classroom teachers."

Center for Ethics & Education Research Grants

Deadline: November 6, 2018

"The Center will make awards of up to \$40,000 for research projects in philosophy as it relates to educational policy and practice. We encourage applicants to understand educational policy and practice in broad terms, including issues that directly relate to K-12 schools and higher education institutions, but also concerning policies that influence children's growth and development in the family and other institutions. We also encourage diverse kinds of philosophical research ranging from the highly abstract to the highly applied. " <<mor>

SOCIAL SCIENCE

Archaeological Institute

<u>Deadline</u>: November 1, 2018 The Archaeological Institute has a number of opportunities coming due at the beginning of

opportunities coming due at the beginning of November. Some give preference to early career researchers, so be sure to click through to the specific listing for eligibility details.

Trust for Mutual Understanding Grants

<u>Deadline</u>: November 1, 2018, and May 1, 2019 "The Trust for Mutual Understanding awards grants to American nonprofit organizations to support direct exchange in the arts and the environment between professionals from the United States and TMU's geographic region: the Baltic States; Central Asia; Central, East, Southeast Europe; Mongolia; and Russia. Priority consideration is given to projects that involve direct, in-depth professional interaction, with the potential for sustained collaboration; that show evidence of professional accomplishment and innovation; and/or that respond to social contexts and engage local communities."

National Radio Astronomy Observatory Jansky Fellowship Program

Deadline: November 1, 2018

"The Jansky Fellowship Program supports outstanding postdoctoral scientists whose research is broadly related to the mission and scientific goals of the National Radio Astronomy Observatory (NRAO), which operates two worldclass research facilities: the Atacama Large Millimeter/submillimeter Array and the Very Large Array. As a Jansky Fellow, you will have a unique opportunity to contribute to and learn from the development and delivery of the largest and most capable radio telescopes in the world. Research that employs NRAO telescopes in multiwavelength collaborations is encouraged. Candidates with interests in radio astronomy techniques, instrumentation, computation, and theory are encouraged to apply. Applicants should describe how their research or technical interests couple with NRAO telescopes or science."
