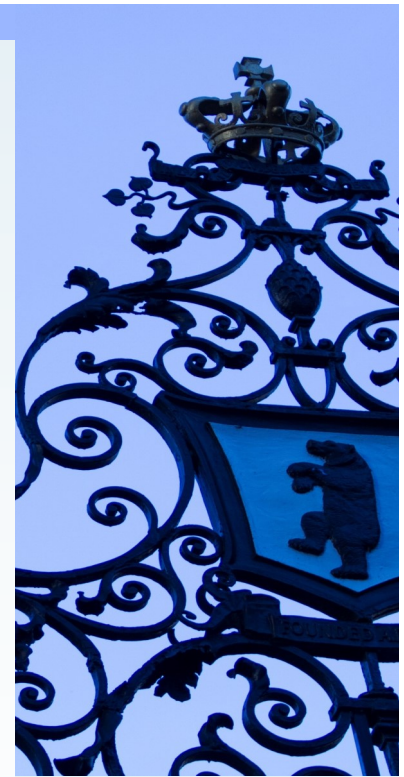

Featured Funder

Art Omi

As is fitting for a special issue on fellowships, here's an overview of Art Omi, whose primary mission is to host residential fellowships from around the world to support practitioners of the creative arts and writers in any field .

Art Omi describes its philosophy as guided by the principle “that artistic expression transcends economic, political, and cultural boundaries.” To this end, the organization has hosted more than 2,000 artists, including visual artists, writers, musicians, and dancers from more than 100 countries. “By forming community with creative expression as its common denominator, Art Omi creates a sanctuary for the artistic community and the public to affirm the transformative quality of art.”

Art Omi runs five different residency programs at their campus in Columbia County, New York, two hours north of New York City by train. Each year, ten to thirty artists participate in each program, which focuses on a separate discipline. The residencies are staggered throughout the year and tailored to provide support for:

- Writers of fiction, nonfiction, theater, film, poetry, etc. (Spring and Fall)
- Translators (Fall)
- Architects (Winter)
- Artists (Early Summer)
- Dancers (Mid-Summer)
- Musicians (Late Summer)

Art Omi residency programs create a communally oriented space that fosters the exchange of ideas. Shared meals are provided throughout the residencies, as well as the opportunity to enjoy the amenities on the grounds. The creative work done during the residencies often results in on-campus exhibitions and performances in the Benenson Center and the 500 acres of rolling meadows, wetlands, and woods that comprise The Fields Sculpture Park. All residencies provide free accommodations, food, local transport, and public programming. Travel to and from the residency is not provided.

Currently, applications are open for the fall Writers program and Translation Lab. They are due on July 15. In 2018, deadlines for the architecture and visual art program were in October; dance and music were in January. For more information and to apply online, click [here](#).

Besides the residential fellowships, Art Omi also supports and honors artists through the Francis J. Greenburger Awards, which grants an unrestricted \$12,500 prize to “established artists whom the art world knows to be of extraordinary merit but have not been fully recognized by the public,” as selected by Francis J. Greenburger, Founder and Chairman of Art Omi. To explore biographies of past winners and award presenters, click [here](#). Art Omi also runs vibrant programs for children and teens, including a summer camp where fellows can perform or present for the young attendees.

The grounds, exhibition spaces, and cafe are open to the public, so if you find yourself near Ghent, NY, stop by for a stomp through the sculpture-filled meadows, a stroll through the galleries, and a nice cup of tea.

Sage Advice for Competitive Proposals

Advice for “Writing Effective Grant Proposals for Individual Fellowships in the Humanities and Social Sciences”

In [this article](#) posted on the Carleton College website, Susan Stanford Friedman, of University of Wisconsin-Madison, covers the major components grant-seekers need to consider while writing proposals for fellowships in the humanities and social sciences. Some of the highlights are:

First, plan that most funders of Fellowships “expect a publication to result from the grant, most likely a book, not an edited collection, and not an article unless your field typically publishes research in the form of refereed articles.”

Stanford Friedman identifies “**The Big Three Questions**” all proposals should cover:

“(1) What you are doing; (2) How you are doing it; (3) Why it is significant.” In fact, she suggests that writers summarize the answers to all three within the first paragraph. She gives some tips on the “What” and “How,” such as how much detail to include and how to avoid seeming too “thesis-driven.” She sees the “Why” as an opportunity to argue how one’s work adds to or questions previous scholarship in the field. That discussion, in turn, provides writers the chance to survey the field, while avoiding a space-consuming literature review. By situating the research within the discipline, applicants can assure readers of the relative worth of the research. “Even though we might all believe as scholars that knowledge as an end in itself should be justification enough, not all knowledge gets research funding. Therefore, you need to explain why your project deserves the grant.”

Another crucial consideration Stanford Friedman covers is the **Audience**. Who makes up grant review panels is different at each funding organization, and it could pay to know your audience. The National Endowment for the Humanities (NEH), for example, invites a panel of faculty specialists who make recommendations to the staff who in turn assemble a slate for the National Council who then advise the Chairman. The ultimate decision rests with the Chairman. (See the [News section](#) for reports of changes to the initial phases of review.) The American Council of Learned Societies (ACLS) uses a multidisciplinary panel, in which case, one can assume a high level of education among reviewers but not a familiarity with the finer points, the technical language, or “the divisive debates” of one’s field. Of the latter Stanford Friedman says, “it won’t help your proposal if you ‘go bland,’ try to be ‘safe,’ to hide what it is you are doing,” but it’s always wise to tread lightly on potential mine fields.

The **Parts of a Grant Proposal** become important as writers plan how to lead their reviewers through their thinking. Stanford Friedman suggests sub-headings or “clear, strong, direct topic sentences.” She says, “proposals tend to include a description of the project, a statement about its necessity or contribution, a chapter outline; and a schedule of research,” where one can make sure reviewers know one’s past accomplishments without seeming unseemly.

She also offers tips to help applicants strategize around **Letters of Recommendation**, asking colleagues, but also “journal editors or referees of your work, editors of collections, convenors of conference panels” so that the letters present a balanced, complete picture of an applicant’s skills and career.

Lastly, Stanford Friedman explores “**The Russian Roulette Factor**.” She says, “Getting a grant sometimes feels like a crapshoot, the luck of the draw. Not getting a grant can feel like a terrible judgment on your worth as a scholar.” In other words, grant awards can often feel arbitrary—or not—based on the answer one receives. She reminds applicants, importantly, “Many people (if not all) who get a grant deserve it, but many who do not succeed deserve it just as much.” See the complete article [here](#).

FROM THE NEH

The NEH has made significant changes to its Fellowship Guidelines—a writing sample will now be required:

From the guidelines/FAQs

"Applicants must submit a writing sample that demonstrates the applicant's ability to express ideas and make a clear argument. It should be in the style of the proposed project. Evaluators will use the sample to assess the clarity of your writing as well as your knowledge of the subject area. The writing sample can be either from the proposed project (preferred) or from a recent publication, but it should not be more than five years old. It must be from a single piece of work and single-authored. For junior scholars, an excerpt from your dissertation is acceptable if you are applying for your first book project. The writing sample may not be more than ten double-spaced pages, including any footnotes or endnotes, and may not include a table of contents, an outline, or an abstract of the proposed work (information of this sort belongs in the narrative). In preparing the sample, leave one-inch margins and use a font no smaller than eleven point. You may single-space footnotes or endnotes. If the sample is a PDF of a published work, its length must not exceed the equivalent of ten double-spaced pages in eleven-point typescript. If the sample has been published, you must indicate this and list the publication on your résumé."

Also, some of our colleagues who attended the CUR Dialogues reported that the NEH will be

piloting a new system of peer reviews for the Fellowship program. A three-person panel with a specific scope (such as 19th-century American history) will conduct an initial review of applications. Those selected will then be reviewed by a full peer review panel that has a broader scope (e.g., American and British history), as is customary.

University of London School of Advanced Study Institute/Consortium Fellowships—in England

Deadlines: Various

"The nine institutes within the School of Advanced Study offer a number of visiting research fellowships in their specialist subject areas. The Institutes offer a number of visiting and research fellowships in legal studies, classical studies, Commonwealth studies, English studies, historical research, Latin American studies, modern languages, philosophy, and the classical tradition of Europe. The fellowships vary in length and in the stipend amounts. The application deadlines vary between the Institutes." <<more>>

Netherlands Institute for Advanced Study Fellowships—in the Netherlands

Deadline: April 15, 2019

"NIAS offers individual fellowships to scholars who wish to carry out advanced research in the humanities and the social sciences. For five or ten months, scholars are offered the time and space to work on a topic of their own choice. Scholars must have at least 3 years of post-Ph.D. degree academic experience and have already made a considerable contribution to their field. The fellowships provide a stipend and housing accommodations." <<more>>

PEN America

Writing for Justice Fellowship

Deadline: May 15, 2019

"The PEN America Writing for Justice Fellowship aims to harness the power of writers and writing in bearing witness to the societal consequences of mass incarceration by capturing and sharing the stories of incarcerated individuals, their families, communities, and the wider impact of the criminal justice system....

The Writing for Justice Fellowship is open-genre, and proposed projects may include—but are not limited to—fictional stories; works of literary or long-form journalism; theatrical, television or film scripts; memoirs; poetry collections; or multimedia projects. The most competitive applications will demonstrate how the proposed project will engage issues of reform, fuel public debate, crystallize concepts of reform, and facilitate the possibility of societal change." <<more>>

Deadline: May 1, 2019

Academic Cross-Training Fellowship

Deadline: May 3, 2019 for letters of inquiry

"Fellowship program is intended to equip recently tenured philosophers and theologians with the skills and knowledge needed to study Big Questions that require substantive and high-level engagement with empirical science.

Each ACT Fellowship will provide up to \$217,400 for up to 3 contiguous years of support for a systematic and sustained course of study in an empirical science such as physics, psychology,

biology, genetics, cognitive science, neuroscience, or sociology. Acceptable courses of study might range from a plan to audit undergraduate and graduate-level courses to a plan to earn a degree in an empirical science. Fellows may undertake their study at their home institution or another institution. All fellows must have a faculty mentor in their cross-training discipline." <<more>>

Einstein Forum

Einstein Fellowship—in Germany

Deadline: May 15, 2019

"The Einstein Forum and the Daimler and Benz Foundation are offering a fellowship for outstanding young thinkers who wish to pursue a project in a different field from that of their previous research. The purpose of the fellowship is to support those who, in addition to producing superb work in their area of specialization, are also open to other, interdisciplinary approaches – following the example set by Albert Einstein. The fellowship includes living accommodations for five to six months in the garden cottage of Einstein's own summerhouse in Caputh, Brandenburg, only a short distance away from the universities and academic institutions of Potsdam and Berlin."

DAAD German Academic Exchange Service Research Stays for University Academics and Scientists—in Germany

Deadline: May 15, 2019

"DAAD grants provide foreign academics and scientists with an opportunity to carry out research and continue their education in Germany. The aim of this particular programme is to support short-term research stays and thus promote the exchange of experience and networking amongst colleagues. Research stays can be funded at state or state-recognised institutions of higher education or non-university research institutes in Germany and last one to three months, providing monthly payments as well as travel allowances." <<more>>

New York Public Library

Martin Duberman Visiting Fellowship

Deadline: For 2018 deadline was May 31. 2019 deadline has not yet been posted.

"The Martin Duberman Visiting Scholar program at The New York Public Library fosters excellence in LGBT studies by providing funds for scholars to do research in the Library's preeminent LGBT historical collections. The fellowship is open to both academic faculty and independent scholars who have made a significant contribution to the field.... The awardee will be expected to spend a minimum of three months researching at the Library and at other archives relevant to their topic in the New York City area, to give a public talk on their work, and to write a short piece about their project for the Library's website." <<more>>

Library of Congress

Kluge Center Fellowship—in Washington, DC

Deadline: July 15, 2019

"The John W. Kluge Center at the Library of Congress invites qualified scholars to conduct research at the Kluge Center using the Library of Congress collections and resources for a period of four to eleven months.... The Kluge Center especially encourages humanistic and social science research that makes use of the Library's large and varied collections. Interdisciplinary, cross-cultural, or multi-lingual research is particularly welcome. Among the collections available to researchers are the world's largest law library and outstanding multi-lingual collections of books and periodicals. Deep special collections of manuscripts, maps, music, films, recorded sound, prints and photographs are also available."

Radcliffe Institute for Advanced Study at Harvard University Fellowship—in Cambridge, MA

Deadline: for 2018 it was September 13. 2019 deadline has not yet been posted.

"As a fellow, you will focus on your individual project while benefiting from a dynamic, multidisciplinary community at Harvard University."

Fellows—women and men—are at the forefront of the arts, journalism, humanities, sciences, and social sciences." ... "Applications in all academic disciplines, professions, and creative arts are encouraged, and there are a few areas of special interest:

- Applications related to the broad theme of the human body, which is a one-year initiative across the programs of the Radcliffe Institute
- Applications that involve the study of women, gender, and society, which is a commitment rooted in Radcliffe's unique history
- Applications that draw on the resources of the Schlesinger Library on the History of Women in America, which is part of the Radcliffe Institute and one of the foremost archives on women's history

Notre Dame Institute for Advanced Study Research Support Fellowship—in Indiana

Deadline: For 2018 it was September 17. 2019 deadline has not yet been posted.

"For scholars, artists, and scientists pursuing outstanding research in all disciplines — including the arts, engineering, humanities, law, and formal, natural, and social sciences — with projects that are creative, innovative, or align with the intellectual orientation of the NDIAS. Projects that integrate questions of value, meaning, or purpose in the analyses are encouraged. The Institute seeks applicants with excellent records of accomplishment pursuing fellowships for periods ranging from three weeks to a full academic year." <<more>>

John Simon Guggenheim Fellowship

Deadline: For 2018 it was September 19. 2019 deadline has not yet been posted.

"Guggenheim Fellowships are intended for individuals who have already demonstrated exceptional capacity for productive scholarship or

exceptional creative ability in the arts....The Foundation receives approximately 3,000 applications each year. Although no one who applies is guaranteed success in the competition, there is no prescreening: all applications are reviewed. Approximately 175 Fellowships are awarded each year." <<more>>

American Council of Learned Societies Fellowships

Deadline: For 2018 it was September 26. 2019 deadline has not yet been posted.

"ACLS invites research applications from scholars in all disciplines of the humanities and related social sciences. Faculty appointments are not required. The ultimate goal of the project should be a major piece of scholarly work by the applicant, which can take the form of a monograph, articles, digital publication(s), critical edition, or other scholarly resources. The ACLS Fellowship program does not fund creative work (e.g., novels or films), textbooks, straightforward translation, or pedagogical projects. ACLS Fellowships are intended as salary replacement to help scholars devote six to twelve continuous months to full-time research and writing. The awards are portable and are tenable at the fellow's home institution, abroad, or at another appropriate site for research. (1) An ACLS Fellowship may be held concurrently with other fellowships and grants and any sabbatical pay, up to an amount equal to the candidate's current academic year salary." <<more>>

American Council of Learned Societies Collaborative Research Fellowship

Deadline: Fellowships are for two years. ACLS did not run a 2018 deadline and offered no fellowships for the 2019-20 year, but we expect it to run in 2019-20 for fellowships beginning fall 2020. The deadline for the 2017-18 year was September 27, 2017

"The goal of the project should be a tangible research product (such as joint print or web publications) for which at least two collaborators

will take credit.... The aim of the fellowship program is to support scholarship that highlights the intellectual significance and innovation of collaborative research." <<more>>

Fulbright U.S. Scholar Program

Deadline: September 16, 2019

"The Core Fulbright Scholar Program offers over 500 teaching, research or combination teaching/research awards in over 125 countries. Opportunities are available for college and university faculty and administrators as well as for professionals, artists, journalists, scientists, lawyers, independent scholars and many others. In addition to several new program models designed to meet the changing needs of U.S. academics and professionals, Fulbright is offering more opportunities for flexible, multi-country grants." <<more>>

Wilson Center Fellowship—in Washington, DC

Deadline: October 1, 2019

"Through an international competition, the Center offers 9-month residential fellowships. The Wilson Center invites scholars, practitioners, journalists and public intellectuals to take part in its flagship international Fellowship Program. Fellows conduct research and write in their areas of interest, while interacting with policymakers in Washington and Wilson Center staff and other scholars in residence. The Center accepts policy-relevant, non-advocacy fellowship proposals that address key challenges confronting the United States and the world." <<more>>

American Academy in Berlin

Berlin Prize

Deadline: For 2018, the deadline was October 5, 2018. Applications for 2019 will open in late May.

"Each year the Academy welcomes about two dozen fellows to the Hans Arnhold Center, on Lake Wannsee. The Academy also hosts a small number of invited Distinguished Visitors for shorter stays of one to four weeks, and organizes a diverse public program that includes lectures and presentations by resident fellows, Distinguished Visitors, and guest speakers. In addition to placing a high priority on the independent work of its fellows, the

Academy is in a unique position to aid fellows in establishing professional networks, both in Berlin and beyond. The Academy's public atmosphere, which actively encourages fellows to introduce their work to wider audiences, serves its mission of fostering transatlantic ties through cultural exchange." <<more>>

Obama Foundation Fellowship

Deadline: For 2018, the deadline was October 6. Deadline for 2019 has not yet been posted.

"The Obama Foundation Fellows will be a diverse set of community-minded rising stars – organizers, inventors, artists, entrepreneurs, journalists, and more – who are altering the civic engagement landscape. By engaging their fellow citizens to work together in new and meaningful ways, Obama Foundation Fellows will model how any individual can become an active citizen in their community.... Our two-year, non-residential Fellowship will offer hands-on training, resources, and leadership development. Fellows will also participate in four multi-day gatherings where they will collaborate with each other, connect with potential partners, and collectively push their work forward. Throughout the program, each Fellow will pursue a personalized plan to leverage Fellowship resources to take their work to the next level." <<more>>

European University Institute

Max Weber Programme for Postdoctoral Studies Fellowship—in Florence

Deadline: For 2018, the deadline was October 25. Deadline for 2019 has not yet been posted

"The Max Weber Programme is the largest international postdoctoral programme in the Social Sciences and Humanities in Europe. It offers around 50-55 fully funded Fellowships to suitably qualified researchers from anywhere in the world who work in or across the relevant disciplines of the EUI (Economics, History, Law and Social and Political Sciences and their subfields). The working language of the Programme is English. The aim of the MWP is to provide Fellows with the experience of membership of a vibrant academic community, to which they make a central contribution. It is unique in offering a structured Programme

covering all aspects of an academic career, including support for academic writing in English, applying for research grants, the opportunity to teach in some of Europe's leading universities and to develop a strategy for a successful approach to the academic labour market." <<more>>

Columbia Institute for Ideas and Imagination Faculty Fellowship—in Paris

Deadline: For 2018, the deadline was October 26. The application portal for 2020-21 will open in Summer 2019.

"The Columbia Institute for Ideas and Imagination, based at Reid Hall in Paris, offers approximately seven full fellowships annually to Columbia faculty. The Institute encourages applications in all disciplines and on any topic from candidates interested in participating in a creative community of scholars, artists, and thinkers. The fellows will each receive \$37,500 per term, or \$75,000 for a full academic year (September through May), an office at the Institute in Paris, and access to Columbia's libraries and various research facilities in Paris and in Europe. We welcome projects from those working in any area of the humanities, the humanistic social sciences, and conceptual dimensions of the natural and applied sciences, as well as from visual artists, filmmakers, writers, and other creative thinkers. In order to be eligible to apply, Columbia faculty should indicate their school and departmental affiliation. We welcome group projects although each participant in the group must apply individually and will be considered on his or her own merits." <<more>>

Smithsonian Institute Mpala Research Center Mpala Postdoctoral and Senior Fellowship—in Kenya

Deadline: For 2018, the deadline was November 1. Deadline for 2019 has not yet been posted.

"The purpose of the Mpala Postdoctoral Fellowship is to promote the study of biology, anthropology, geology, hydrology, material science, social science, soil science or related areas. Projects must be tenable in residence at

Smithsonian Institution facilities and Mpala Research Centre.... Fellowships are offered by the Smithsonian Institution to provide opportunities for graduate students, predoctoral students, and postdoctoral and senior investigators to conduct research in association with members of the Smithsonian professional research staff, and to utilize the resources of the Institution." <<more>>

Smithsonian Institution National Museum of American History, Lemelson Center for the Study of Invention and Innovation Arthur Molella Distinguished Fellowship—on site activity is flexible

Deadline: For 2018, the deadline was November 1. Deadline for 2019 has not yet been posted.

"The Lemelson Center for the Study of Invention and Innovation is accepting applications for the Arthur Molella Distinguished Fellowship at the Smithsonian Institution's National Museum of American History (NMAH). We seek to appoint an experienced author or senior scholar (at the associate/full/emeritus professor level or equivalent) from the history of technology, science and technology studies, business history, museum studies, STEAM education, or an allied field (Smithsonian staff are not eligible). The specific arrangement is flexible: the Molella Distinguished Fellow may use the funds as a sabbatical supplement; for several short-duration visits; for a single residency focused on research and writing; or for a series of lectures leading to a major publication."

Deadline: November 1, 2019
