Featured Funder

The Wilson Center

The Wilson Center in Washington, DC, bills itself as “the nation’s key non-partisan policy forum. In tackling global issues through independent research and open dialogue, the Center informs actionable ideas for Congress, the administration, and the broader policy community.” It’s goal is “to unite the world of ideas to the world of policy by supporting pre-eminent scholarship and linking that scholarship to issues of concern to officials in Washington.”

If “tackling global issues” sounds broad and linking “scholarship...to officials in Washington” sounds ambitious, it may help to know that the Center divides itself into eleven Regional and six Thematic Programs. The Regional divisions encompass the globe with greater and lesser granularity, from the Africa and Asia Programs to the Mexico Institute and the Kissinger Institute, which concentrates on China. The Polar Initiative strikes one as even more globe-spanning—especially after Professor Pfirman’s lecture, “Once and Future Arctic”—as it seeks to “raise awareness about critical issues facing the Arctic and Antarctic by pursuing research, dialogue, and robust programmatic activity.” Each program has its own “regional and topical focuses.” For example, gender issues are of particular relevance to the Brazil Institute and the Middle East Program, among other concerns.

The Center also maintains six Thematic Programs, some of which have sub-programs:

- The Digital Futures Project
- The Global Sustainability and Resilience Program
- Global Women’s Leadership Initiative
- History and Public Policy Program
- Science and Technology Innovation Program

Almost all funding available for scholars is offered in support of Fellowships to be conducted on site at the Center. Faculty who want to pursue the policy implications of their research may consider if the resources and environment at the Wilson Center would enhance their work. "Through an international competition, the Center offers 9-month residential fellowships. The Wilson Center invites scholars, practitioners, journalists and public intellectuals to take part in its flagship international Fellowship Program. Fellows conduct research and write in their areas of interest, while interacting with policymakers in Washington and Wilson Center staff and other scholars in residence. The Center accepts policy-relevant, non-advocacy fellowship proposals that address key challenges confronting the United States and the world." **The deadline is October 2, 2018.**

The Kennan Institute offers several other Fellowships and research grants “applicants from diverse, policy-oriented sectors such as media, business, local government, law, civil society, and academia to examine important political, social, economic, cultural, and historical issues in Russia, Ukraine, and the region.” Deadlines vary. <<more>> The Cold War International History Project also offers support on a rolling deadline for archival research on the Cold War, especially “translation and transcription” and “document acquisition and duplication.” <<more>>

Sage Advice for Competitive Proposals

Maybe “Useful Information” would be a better title for this installment aimed to give you a sampling of what we in Barnard Sponsored Research can do for you, our esteemed faculty. Do You Need Funding?

- We can work closely with you throughout the application process to help you think through budgets, timelines, and ways to present your work that might align with the funder’s or RFP’s aims.
- Government agencies and certain other funders sometimes have complex applications. We can help you navigate them.
- We can handle the online submission requirements, such as converting to pdf, after a careful review, and uploading.

- Some organizations and agencies engage in a “just in time” process or conversation before formally granting an award. We are available to assist you through that process.

Fellowship Opportunities

GENERAL INTEREST AND CROSS DISCIPLINARY

National Institutes of Health Ethical, Legal, and Social Implications of Genomic Research Small Research Grant Program (R03)

Deadline: June 16, 2018

"This Funding Opportunity Announcement (FOA) invites Small Research Grant (R03) applications to study the ethical, legal and social implications (ELSI) of human genome research. These applications should be for small, self-contained research projects, such as those that involve single investigators. Of particular interest are projects that propose normative or conceptual analyses, including focused legal, economic, philosophical, anthropological, or historical analyses of new or emerging issues. This mechanism can also be used for the collection of preliminary data and the secondary analysis of existing data." <<more>>

Harvard University Radcliffe Institute for Advance Study Fellowship Programs

Vermont Studio Center

Deadline: June 15, October 1, 2018 and February 15, 2019

Non-fellowship applications accepted on a rolling basis.

"the largest international artists' and writers' residency program in the United States. Our mission is to provide studio residencies in an inclusive, international community, honoring creative work as the communication of spirit through form." "We offer over 120 fellowships per year to artists and writers of outstanding talent. A fellowship covers the full cost of a VSC residency (some awards also include an additional stipend for travel/lost income/etc). At each of our three annual deadlines (February 15th, June 15th, and October 1st), our fellowship offerings change. In addition to some donor-driven awards with special eligibility requirements, there are always a number of general, merit-based VSC fellowships for which all applicants are considered." <<more>>

American Academy of Religion Collaborative Research Grants

Deadline: August 1, 2018

"Collaborative grants are intended to stimulate cooperative research among scholars who have a focus on a clearly identified research project. They may also be used for interdisciplinary work with scholars outside the field of religion, especially when such work shows promise of continuing beyond the year funded. Collaborative project proposals are expected to describe plans for having the results of the funded. Collaborative project proposals are expected to describe plans for having the results of the research published. Grants can provide funds for networking and communication. Funds may also be used to support small research conferences. Conference proposals will be considered only if they are used to support small research conferences. Conference proposals will be considered only if they are designed primarily to advance research."

National Endowment for the Arts Media Arts Grants

Deadline: July 12, 2018

Projects eligible for 7/12/18 deadline include creation, education, and resources for artistic and professional development.

Projects eligible for 2/15/18 deadline include exhibition, presentation, distribution, and preservation activities.

"The National Endowment for the Arts is committed to support activities that reflect the dynamic, diverse, and evolving nature of the media arts field. Applicants may apply in this Art Works category for media arts projects that support creation, exhibition, education, and distribution of historic and contemporary artworks in all genres and forms that use electronic media, film and technology (analog & digital; old and new) as an artistic medium or a medium to broaden arts appreciation and awareness (of any discipline). Foundation for Contemporary Art Emergency Grants

Deadline: rolling

Created in 1993, Emergency Grants provides prompt funding for innovative visual and performing artists who: Have unanticipated, sudden opportunities to present their work to the public when there is insufficient time to seek other sources of funding Incur unexpected or unbudgeted expenses for projects close to completion with committed exhibition or performance dates"

Deadline: rolling

"This grant aims to support projects that will further understanding of Japanese arts and culture. Successful projects may be granted up to \$5,000. Priority will be given to those projects that have secured additional funding from sources other than the Japan Foundation." [<<more>>](#)

SOCIAL SCIENCE

Fulbright Distinguished Chair in International Relations at University of Sao Paulo (USP)

Deadline: August 1, 2018

At the University of Sao Paulo (USP), main campus, "[t]each graduate and undergraduate courses, develop collaborative research with faculty and, subject to agreement of the academic committees of the Institute of International Relations at USP, teach courses and/or advanced seminars in topics to be defined. In addition to being a prestigious academic exchange program, the Fulbright Program is designed to expand and strengthen relationships between the people of the United States and citizens of other nations and to

promote international understanding and cooperation. To support this mission, Fulbright Scholars will be asked to give public talks, mentor students, and otherwise engage with the host community, in addition to their primary research or teaching activities." <<more>>

Harry Frank Guggenheim Foundation Research Grants

Deadline: August 1, 2018

"The foundation welcomes proposals from any of the natural and social sciences and the humanities that promise to increase understanding of the causes, manifestations, and control of violence and aggression. Highest priority is given to research that can increase understanding and amelioration of urgent problems of violence and aggression in the modern world. Questions that interest the foundation concern violence and aggression in relation to social change, intergroup conflict, war, terrorism, crime, and family relationships, among other subjects." <<more>>

National Science Foundation Law & Social Sciences (LSS) Grants

Deadline: August 1, 2018 and January 1, 2019

"The Law & Social Sciences Program considers proposals that address social scientific studies of law and law-like systems of rules. The Program is inherently interdisciplinary and multi-methodological. Successful proposals describe research that advances scientific theory and understanding of the connections between law or legal processes and human behavior. Social scientific studies of law often approach law as dynamic, made in multiple arenas, with the participation of multiple actors. Fields of study include many disciplines, and often address problems including though not limited to:

1. Crime, Violence and Punishment
2. Economic Issues
3. Governance
4. Legal Decision Making
5. Legal Mobilization and Conceptions of Justice
6. Litigation and the Legal Profession" <<more>>

STEM (SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS)

National Science Foundation Critical Techniques, Technologies and Methodologies for Advancing Foundations and Applications of Big Data Sciences and Engineering (BIGDATA)

Deadline: May 14, 2018

"The BIGDATA program seeks novel approaches in computer science, statistics, computational science, and mathematics leading towards the further development of the interdisciplinary field of data science. The program also seeks innovative applications in domain science, including social and behavioral sciences, education, physical sciences, and engineering, where data science and the availability of big data are creating new opportunities for research and insights not previously possible. The solicitation invites two

categories of proposals: Foundations (BIGDATA: F): those developing or studying fundamental theories, techniques, methodologies, and technologies of broad applicability to big data problems, motivated by specific data challenges and requirements; and Innovative Applications (BIGDATA: IA): those engaged in translational activities that employ new big data techniques, methodologies, and technologies to address and solve problems in specific application domains. Projects in this category must be collaborative, involving researchers from domain disciplines and one or more methodological disciplines, e.g., computer science, statistics, mathematics, simulation and modeling, etc." <<more>>

American Association for the Advancement of Science Early Career Award for Public Engagement with Science

Deadline: August 1, 2018

"The AAAS Early Career Award for Public Engagement with Science, established in 2010, recognizes early-career scientists and engineers who demonstrate excellence in their contribution to public engagement with science activities."

National Science Foundation Science, Technology, and Society Grants

Deadline: August 3, 2018, and February 2, 2019

"The Science, Technology, and Society (STS) program supports research that uses historical, philosophical, and social scientific methods to investigate the intellectual, material, and social facets of the scientific, technological, engineering and mathematical (STEM) disciplines. It encompasses a broad spectrum of STS topics including interdisciplinary studies of ethics, equity, governance, and policy issues that are closely related to STEM disciplines, including medical science." <<more>>

National Science Foundation Perception, Action & Cognition Grants

Deadline: July 15, 2018 and January 15, 2019
Workshop and conference proposal deadline is May 15, 2018

"The PAC program funds theoretically motivated research on a wide-range of topic areas related to typical human behavior with particular focus on perceptual, motor, and cognitive processes and their interactions. Central research topics for consideration by the program include (but are not limited to) vision, audition, haptics, attention, memory, written and spoken language, spatial cognition, motor control, categorization, reasoning, and concept formation. Of particular interest are emerging areas, such as the interaction of sleep or emotion with cognitive or perceptual processes, epigenetics of cognition, computational models of cognition, and cross-modal and multimodal processing. The program welcomes a wide range of perspectives, such as individual differences, symbolic and neural-inspired computation, ecological approaches, genetics and epigenetics, nonlinear dynamics and complex systems, and a variety of methodologies spanning the range of experimentation and modeling." <<more>>

Simons Foundation Autism Research Initiative SFARI Explorer Award

Deadline: rolling

"Application type for proposals requesting support of exploratory experiments that will strengthen hypotheses and lead to the formulation of competitive applications for subsequent larger-scale funding by SFARI or other organizations. Innovative, high-risk/high-impact proposals are encouraged. We especially encourage applications from investigators who are new to the field of autism, but who have expertise that could be brought to bear on this complex disorder."

National Science Foundation Conferences and Workshops in the Mathematical Sciences

Deadline: rolling

"Conferences, workshops, and related events (including seasonal schools and international travel by groups) support research and training activities of the mathematical sciences community. Proposals for conferences, workshops, or conference-like activities may request funding of any amount and for durations of up to three years. Proposals under this solicitation must be submitted to the appropriate DMS programs in accordance with the lead-time requirements specified on the program web page." <<more>>

Peede joined NEH in April 2017 as the agency's Senior Deputy Chairman. Under his leadership NEH has created a new category of grants to support [infrastructure and capacity-building](#) at humanities institutions, [issued emergency grants](#) for cultural organizations affected by Hurricanes Harvey, Irma, and Maria, expanded its [grant offerings for museum exhibitions](#), and formed new partnerships with [Blue Star Families](#) and the [First Nations Development Institute](#) for reading and discussion initiatives for military families and the revitalization of Native American languages.

"Federal Agencies release a new NPRM to further delay Common Rule

On April 19, HHS and 16 other federal agencies released a new [Notice of Proposed Rulemaking \(NPRM\)](#) proposing to delay the general compliance date for the revised Federal Policy for the Protection of Human Subjects, or "Common Rule," six more months to January 21, 2019. The NPRM also proposes to allow institutions to implement three "burden-reducing provisions" during the delay period, specifically:

- use of the revised definition of "research," which deems four categories of activities as not research
- allowance for no annual continuing review for certain categories of research
- elimination of the requirement for IRB review of grant applications for research

The agencies are seeking public comment on these proposals. The comment period for this NPRM is short, just 30 days (ending May 20)." The article continues; read it [here](#).
