Featured Funder

William T. Grant Foundation

“Supporting research to improve the lives of young people”

Faculty of all disciplines whose research “is relevant to policies and practices that affect the lives of young people” should know about the William T. Grant Foundation. By young people, the Grant Foundation means “people ages 5 to 25 in the United States.”

RESEARCH FUNDING

Since we’re in the business of seeking funding sources for your research, our first concern is the grants the Foundation offers researchers. They focus primarily on two areas:

- **Reducing Inequality**—“To reduce inequality by identifying responses to this fundamental challenge in its many forms...we welcome descriptive studies meant to clarify the mechanisms for reducing inequality. We also seek intervention studies that improve the measurement of inequality in ways that will enhance the works of researchers, practitioners, or policy makers.” [<<more>>](#)
- **Improving the Use of Research Evidence**—“to identify, create, and test strategies to ensure that research reaches the hands of decision makers, answers their most pressing questions, and is used in ways that benefit youth.” [<<more>>](#)

In 2018, the Foundation accepted grants three times during the year. The next deadline is **August 1, 2018**. Grants range from \$100,000—\$600,000 for research into reducing inequality and \$100,000—\$1,000,000 for grants about improving the use of research. [<<more>>](#)

“For smaller projects, we have a separate funding mechanism, Officers’ Research grants. These awards cover budgets up to \$50,000. Some are stand-alone projects that fit our research focus areas; others build off of larger projects. Junior scholars of color are encouraged to apply for these grants as a way to build their research programs.”

SCHOLAR PROGRAM

The Foundation supports faculty career development specifically for early career researchers through their Scholar Program that “funds five-year research and mentoring plans that significantly expand junior researchers’ expertise in new disciplines, methods, and content areas.... [T]his award includes a mentoring component, as well as an emphasis on community and collaboration.” [<<more>>](#)

OTHER FUNDING

Separately, the Grant Foundation also offers two other grant programs:

- **Institutional Challenge Grants** “encourage university-based research institutes, schools, and centers to build sustained research-practice partnerships with public agencies or nonprofit organizations in order to reduce inequality in youth outcomes.” Deadline is September 7, 2018. [<<more>>](#)
- **Youth Services Improvement Grants** “help strengthen existing youth services by addressing issues or problems at the point of service, where staff and youth interact.” Deadline was March 8, 2018. [<<more>>](#)

In addition to providing grants, the Foundation began publishing a Digest in Summer 2016. Each issue explores one or two main themes through multiple articles. For example, the most recent [Digest, Issue 3](#), examines research on ability tracking of English Language Learners and on fostering the use of research outside the university.

Sage Advice for Competitive Proposals

This newsletter writer spent three days this month at a conference focused on Corporate and Foundation funding. It was, to be honest, a deluge of tips and pointers, but a few trends seemed to come up repeatedly.

1. Increasingly foundations have committed themselves to advancing one or more explicitly defined missions, which has resulted in a trend away from supporting institutions and toward supporting projects. To this end, they want applicants who align closely with their stated missions. It doesn't mean, they were quick to say, faculty should tailor their choice of research topic to suit funders. It does mean faculty should understand the foundation's priorities before applying.
2. With this new emphasis on mission, it makes sense that foundations now perceive the grantmaking enterprise as a partnership with the faculty and programs they fund. The idea of a partnership, several funding officers pointed out, alleviates the sense of "begging for money." Faculty and college staff can remember we are the ones doing the work that helps funders advance their mission.
3. Speaking of partnerships, "collaboration" was the buzz-word of the conference, both inside and outside one's institution. In his key note address on diversity, Scott Page of the University of Michigan discussed studies that found scholarly articles were four times more likely to receive more than 100 citations when five or more authors collaborated. The likelihood increased even more when those authors came from different institutions or different ethnic groups. It was just one of several examples he gave for ways in which collaboration among diverse people produced beneficial results.
4. Along the same lines, community-engaged work seems to be enjoying a surge in popularity. Foundations are showing heightened interest in projects or research that reaches "beyond the ivy" of higher education and into the community.
5. This "word" of wisdom came up only once, but it's too good to omit.

The Writing for Justice Fellowship is open-genre, and proposed projects may include—but are not limited to—fictional stories; works of literary or long-form journalism; theatrical, television or film scripts; memoirs; poetry collections; or multimedia projects. The most competitive applications will demonstrate how the proposed project will engage issues of reform, fuel public debate, crystallize concepts of reform, and facilitate the possibility of societal change." Deadline: rolling

This new foundation has not given enough grants to establish a record of what kinds of projects, programs, or research they fund. ARTS AND HUMANITIES

College Art Association Millard Meiss Publication Fund

Deadline: September 15, 2018, and March 15, 2019

Non-fellowship applications accepted on a rolling basis.

Grants to "support book-length scholarly manuscripts in the history of art, visual studies, and related subjects that have been accepted by a publisher on their merits, but cannot be published in the most desirable form without a subsidy.

Thanks to the generous bequest of the late Prof. Millard Meiss, CAA began awarding these publishing grants in 1975. Books eligible for a Meiss grant must currently be under contract with a publisher and be on a subject in the arts or art history." [<<more>>](#)

College Art Association Wyeth Foundation for American Art Publication Grant

Deadline: September 15, 2018

"For this grant program, "American art" is defined as art created in the United States, Canada, and Mexico. Eligible for the grant are book-length scholarly manuscripts in the history of American art, visual studies, and related subjects that have been accepted by a publisher on their merits but cannot be published in the most desirable form without a subsidy." <<more>>

SOCIAL SCIENCE

Sociological Initiatives Foundation

Deadline: August 15, 2018

"The Sociological Initiatives Foundation supports social change by linking research to social action. It funds research projects that investigate laws, policies, institutions, regulations, and normative practices that may limit equality in the United States. It gives priority to projects that seek to address racism, xenophobia, classism, gender bias, exploitation, or the violation of human rights and freedoms. It also supports research that furthers language learning and behavior and its intersection with social and policy questions."

National Science Foundation Decision, Risk, and Management Sciences grants

Deadline: August 18, 2018, and January 18, 2019

"The Decision, Risk and Management Sciences program supports scientific research directed at increasing the understanding and effectiveness of decision making by individuals, groups, organizations, and society. Disciplinary and interdisciplinary research, doctoral dissertation research improvement grants (DDRIGs), and workshops are funded in the areas of judgment and decision making; decision analysis and decision aids; risk analysis, perception, and communication; societal and public policy decision making; management science and organizational design." <<more>>

National Science Foundation Economics grants

Deadline: August 18, 2018, and January 18, 2019

"The Economics program supports research designed to improve the understanding of the processes and institutions of the U.S. economy and of the world system of which it is a part. This program also strengthens both empirical and theoretical economic analysis as well as the methods for rigorous research on economic behavior. It supports research in almost every area of economics, including econometrics, economic history, environmental economics, finance, industrial organization, international economics, labor economics, macroeconomics, mathematical economics, and public finance. The Economics program welcomes proposals for individual or multi-investigator research projects, doctoral dissertation improvement awards, conferences, symposia, experimental research, data collection and dissemination, computer equipment and other instrumentation, and research experience for undergraduates. The program places a high priority on interdisciplinary research." <<more>>

Russell Sage Foundation Social, Economic, and Political Effects of the Affordable Care Act

Deadline: August 20, 2018

"This Russell Sage Foundation initiative will support innovative social science research on the social, economic and political effects of the Affordable Care Act. We are especially interested in funding analyses that address important questions about the effects of the reform on outcomes such as financial security and family economic well-being, labor supply and demand, participation in other public programs, family and children's outcomes, and differential effects by age, race, ethnicity, nativity, or disability status. We are also interested in research that examines the political effects of the implementation of the new law, including changes in views about government, support for future government policy changes, or the impact on policy development outside of health care. Funding is available for secondary analysis of data or for original data

collection. We welcome projects that propose novel uses of existing data, as well as projects that propose to analyze newly available or underutilized data." [<<more>>](#)

Russell Sage Foundation Future of Work

Deadline: August 20, 2018

"The Future of Work program examines the causes and consequences of the deteriorating quality of low-wage jobs in the United States. Projects sponsored by the program have examined a wide range of causal factors, from foreign outsourcing and immigration to the decline of unions and technological change, that may have depressed wages of low-education workers. Current research under this program includes a new investigation to re-assess how minimum wage increases affect employment and the broader labor market; a new study of the extent of offshoring of production by U.S. firms and its impact on the economy; and a project that examines the role of job search behaviors on the employment and wage outcomes of women and minorities in the post-recessionary U.S. labor market, among others." Russell Sage Foundation Social Inequality

Deadline: August 20, 2018

"The Russell Sage Foundation's program on Social Inequality supports innovative research on whether rising economic inequality has affected social, political, and economic institutions, and the extent to which increased inequality has affected equality of opportunity, social mobility, and the intergenerational transmission of advantage. We seek investigator-initiated research projects that will broaden our understanding of the causes and consequences of rising economic inequalities in the United States.... Funding is available for secondary analysis of data or for original data collection. We are especially interested in novel uses of existing data, as well as analyses of new or under-utilized data. Proposals to conduct laboratory or field experiments, in-depth qualitative interviews, and ethnographies are also encouraged. Smaller projects might consist of

exploratory fieldwork, a pilot study, or the analysis of existing data." [<<more>>](#)

"The Russell Sage Foundation's program on Behavioral Economics supports innovative research that uses behavioral insights from psychology and other social sciences to examine and improve social and living conditions in the United States. We seek investigator-initiated research proposals that will broaden our understanding of the social, economic and political consequences of real-life behaviors and decisions that deviate from the neoclassical economic standards of rationality. RSF is especially interested in behavioral economics research that contributes to our understanding of topics of interest under its other programs—Future of Work; Race, Ethnicity and Immigration; Social Inequality." Wilson Center Kennan Institute George F. Kennan Fellowship

Deadline: September 1, 2018, and March 1, 2019

"The Kennan Institute seeks fellowship applicants from diverse, policy-oriented sectors such as media, business, local government, law, civil society, and academia to examine important political, social, economic, cultural, and historical issues in Russia, Ukraine, and the region. Among the aims of the new fellowships are to build bridges between traditional academia and the policy world, as well as to maintain and increase collaboration among researchers from Russia, Ukraine, the U.S., and around the globe." Organic Farming Research Foundation Grants for Researchers

Deadline: July 10, 2018

Research and Education: "Northeast SARE's Research and Education Grant program funds projects (with or without an applied research component) that result in gains in farmer knowledge and skills applied to make changes that lead to greater sustainability throughout the Northeast region."

Research for Novel Approaches: "Northeast SARE's Research for Novel Approaches in Sustainable Agriculture grant program funds projects that conduct applied research leading to the feasibility of new practices and approaches that have high potential for adoption by farmers." <<more>>

"Environment and species conservation and blindness-related services and research. National Science Foundation Mathematical Biology

Deadline: September 5, 2018

"The Mathematical Biology Program supports research in areas of applied and computational mathematics with relevance to the biological sciences. Successful proposals are mathematically innovative and address challenging problems of interest to members of the biological community. Some projects of interest to the Mathematical Biology Program may include development of mathematical concepts and tools traditionally seen in other disciplinary programs within the Division of Mathematical Sciences, e.g., topology,

probability, statistics, computational mathematics, etc. To receive appropriate and timely review, such proposals should be submitted directly to the relevant disciplinary program that has the earliest deadline, with other program(s) selected as secondary. Note that proposals that use established mathematical and computational tools to address problems in the biological sciences are typically not appropriate for submission to DMS." <<more>>

National Science Foundation Probability

Deadline: September 5, 2018

"The Probability Program supports research on the theory and applications of probability. Subfields include discrete probability, stochastic processes, limit theory, interacting particle systems, stochastic differential and partial differential equations, and Markov processes. Research in probability which involves applications to other areas of science and engineering is especially encouraged." <<more>>

National Institutes of Health National Institute for Environmental Health Science Individual Fellowships for Senior Fellows (F33)

Deadline: August 8 and December 8, 2018, and April 8, 2019

"The Ruth L. Kirschstein National Research Service Awards for Senior Fellows (F33) provides up to two years of support for experienced scientists who wish to make major changes in the direction of their research careers or who wish to broaden their scientific background by acquiring new research capabilities. These awards are targeted to individuals with at least seven years of research experience beyond the doctorate, and who have progressed to the stage of independent investigator. In most cases, this award is used to support sabbatical experiences." <<more>>

Nature Conservancy NatureNet Science Fellow Program

Deadline: September 7, 2018

"The Conservancy has established the NatureNet

Science Fellows Program in partnership with a rotating set of the world's leading universities to create a reservoir of new interdisciplinary science talent that will carry out the new work of conservation. Fellows and grantees will work with a Nature Conservancy mentor and a hosting senior scholar (or scholars) to develop a research program. This joint mentorship model allows for fellows and grantees to take fundamental research questions and the traditional support provided by universities and embed themselves in the practice of applied conservation through TNC networks. Within this framework, the NatureNet program goals are to: Support innovative and impact-oriented research that help deliver TNC outcomes;

- Invest in the talent potential of a new generation of climate change leaders;
- Recruit scientists who bring a diversity of culture, experience, and ideas into conservation; and
- Provide partner universities and fellows with access to real-world conservation issues." [<<more>>](#)

National Science Foundation Research Training Groups in the Mathematical Sciences

Deadline: September 12, 2018

"The purpose of the Focused Research Group activity is to support collaborative groups employing innovative methods to solve specific, major research challenges in the mathematical sciences. A major challenge is an outstanding problem of significant importance that requires the focused and synergistic efforts of a collaborative group to solve, and whose solution will have wide impacts in the mathematical sciences and potentially in other areas. Groups may include, in addition to statisticians and mathematicians, researchers from other science and engineering disciplines appropriate for the proposed research. Risky projects are welcome. Interdisciplinary projects are welcome. Projects should be timely, limited in duration to up to three years, and substantial in their scope and impact for the mathematical sciences. Funded projects that show substantial progress in their first two years may be recommended for a creativity extension for up to an additional two years." [<<more>>](#)

Institute of Museum and Library Services

"National Leadership Grants for Libraries (NLG-L) support projects that address significant challenges and opportunities facing the library and archives fields and that have the potential to advance theory and practice. Successful proposals will generate results such as new tools, research findings, models, services, practices, or alliances that will be widely used, adapted, scaled, or replicated to extend the benefits of federal investment." Basic scientists still feel pinch of new NIH clinical trial policy

"Basic researchers who study the brain and human behavior thought lawmakers had come to their rescue in March by blocking the National Institutes of Health (NIH) in Bethesda, Maryland, from redefining their studies as clinical trials. But NIH officials are still pushing ahead with new requirements that scientists say make no sense and will cripple their research.

What some see as NIH's narrow interpretation of a directive from lawmakers has researchers up in arms as they navigate confusing new rules and paperwork. The clinical trial policies "are not appropriate for fundamental research," a group of societies wrote in an email to NIH this week.

The issue goes back almost a year, when researchers [became aware that a new NIH definition of clinical trials would encompass many basic studies involving human subjects.](#)

Since January 2018, these projects must now go through a new submission and review process and will need to be registered and have results reported on [clinicaltrials.gov](#), a public database, among other requirements aimed at improving rigor and transparency in clinical research."

Panel calls for a postdoc tax and other measures to help biomedical scientists find jobs

“The U.S. Congress, federal funding agencies, universities, and other research institutions must take significant steps, such as a postdoc “tax” and a hard cap on how long postdocs can be funded by a lab head, to better usher young biomedical scientists into viable careers, a committee from the National Academies of Sciences, Engineering, and Medicine (NASEM) concluded in a [report released...](#)”

“Motivating the new report is the growing mismatch between many biomedical scientists’ aspirations and the career prospects available to them. Despite efforts to promote research careers in industry, government, and the nonprofit sector, an independent academic research career remains the top goal for many budding biologists. Yet only about 18% of people trained in the United States with a Ph.D. in biomedical sciences is employed in a tenured or tenure-track position 6 to 10 years after completing their degree...”
