Featured Funder

Community Engagement Initiatives

Today's Featured Funder is really a group of funders with a shared interest in community engagement initiatives. If you've ever wanted to develop a public-facing project, this profile is for you.

I'm sure you've all heard the good news about our first one: Barnard! Barnard was recently awarded a major grant by the Mellon Foundation to start **Barnard Engages New York: Collaborative Partnerships to Promote Sustainable Change**. Barnard Engages recently sent out a [Request for Proposals](#) (RFP) to full-time faculty developing courses based in the humanities that involve "three- to five-year partnerships with New York non-profit institutions, whose missions connect to the following topics: Immigration and immigrant rights and safety; poverty and associated issues of healthy, food insecurity, and criminal justice; the human rights of laborers." For help thinking about course design, see Jennifer Rosales at the [Center for Engaged Pedagogy](#). For more information see the [Request for Proposals](#). **Pre-proposals are due October 30, 2019 to barnardengages@barnard.edu.**

For start-up grants, try [Humanities New York](#). "The mission of Humanities New York is to strengthen civil society and the bonds of community, using the humanities to foster engaged inquiry and dialogue around social and cultural concerns." Humanities New York has a few different grants.

"[Vision Grants](#)" are planning grants for \$500-\$1,500 for "expenses such as travel, consultant fees, and participant stipends." Organizations must provide a 1:1 match. **Deadline: Rolling**

"[Action Grants](#)" offer \$1500-\$5000 for the implementation of public-facing projects, "including workshops, roundtables, panel discussions, humanities-infused performances, exhibits, podcasts, and interactive digital platforms." Organizations must provide 1:1 matching.

Deadline: April 1, 2020 for projects starting July 1st, 2020 or later.

On a larger scale, the [National Endowment for the Humanities](#) offers a range of grants.

[Public Humanities Projects](#): "support projects in three categories: **Exhibitions** (permanent, temporary, or traveling); interpretive programs at **Historic Places**; and **Humanities Discussions** related to the 250th anniversary of the nation's founding." Planning Grants: Up to \$75K. Implementation: up to \$400k. **Deadline: January 15, 2020.**

[Public Scholar Program](#): up to \$5k/month in support of "the creation of well-researched books in the humanities intended to reach a broad readership." **Deadline: February 5, 2020.**

[The Whiting Foundation's Public Engagement Programs](#) fund "ambitious, often collaborative projects to infuse into public life the richness, profundity, and nuance that give the humanities their lasting value."

Public Engagement Seed Fellowship: up to \$10k. "Nominees should also have articulated specific short-term next steps required to advance the project and understand the resources required to complete them." **Deadline: TBA.**

Public Engagement Fellowship: \$50k is for public-facing projects far enough along in development or execution that the nominee can present compelling, specific evidence that they will successfully engage the intended public. **Deadline: TBA.**

[The J.M Kaplan Fund](#) supports "civil liberties, human rights, the arts, and the conservation and enhancement of the built and natural worlds." They have two main grants.

[Furthermore Grants](#): \$5k in support publication of nonfiction books that concern the arts, history, and the natural and built environment. **Deadline: March 1**

[Innovation Prize](#) provides \$150k over three years in "catalytic funding for projects in their early stages of development" in the field of social innovation. **Deadline: TBA.**

Sage Advice for Competitive Proposals

What Makes a Good Community Partnership Proposal?

The news about Barnard Engages is all very exciting and exactly the sort of opportunity that we like to flag for you, here at Institutional Funding and Sponsored Research. As you've probably noticed, though, it's only one opportunity to partner with community organizations among a growing number. Grants for community partnerships are taking over increasingly posh addresses in funding real estate.

Given that, I thought that today would be a good time to talk about how to craft a persuasive proposal for working with the public. **So what makes a good community partnership proposal?**

Luckily, this is one of the few questions that can be answered nearly entirely by reference to first principles: **Your project has to answer genuine needs for your partner organization and for you own.** Let's unpack this.

You have to know what the needs of your partner organization are, which means you have to have an ongoing relationship with them. Almost no one wants to fund a community engagement project where the proposal writer clearly doesn't have a strong relationship with the organization. What if that organization says 'no' to your great idea?

Your project has to fit with the priorities and capacities of your partner organization. Non-profits can often be understaffed, underfunded, and overburdened with projects. The single worst thing you can do is parachute in with a project, drop it on an organization, and leave.

Your partner organization should be better off after the project than before you started. This doesn't have to mean financially. You can leave your partner organizations with new skills, volunteers, resources, or connections. Don't ask for them to commit time and resources to your project without giving them anything in return.

You should be sensitive to power differentials and biases vis-à-vis your collaborators. Be especially sensitive if you are the one controlling funding.

You and your partner have to define your public audience. Who are you trying to reach? Students? The elderly? The arts community? The prison population? Decide and tailor your project accordingly.

You and your partner have to understand what your funder means by "community" and "public." There are funders who have absolutely no interest in giving money to Barnard College to reach its own students, but might well give to a Barnard program if it were working with, say, prisons.

Community engagement has to make sense for you or your organization's mission. It might be a fine, morally upstanding thing to have your students volunteer at a soup kitchen, but if it isn't meaningfully enhancing their experience of your class on Milton it's not a good project.

You should have a strong answer for how your project creates social change, if applicable. This point depends on the detail of your funder, but funders are often *extremely* fond of metrics when assessing impact. So have a plan to count attendance, track page views, gather feedback, and otherwise assess the impact of what you propose.

Your partnership should be sustained and optimally scalable. This isn't always the case, but funders often like seeing that partnerships are ongoing and can be replicated. Check the details of your grant.

The key point is that the best community partnerships are bottom-up, not top-down.

Alert: FastLane and Research.gov will be unavailable from Friday, November 8 at 8:00 PM EST until Tuesday, November 12 at 6:00 AM EST

“The National Science Foundation (NSF) is migrating its business applications to a modern and flexible platform from November 8 at 8:00 PM EST through November 12 at 6:00 AM EST. As part of this effort, NSF will also upgrade the alpha-numeric character set used by the FastLane and Research.gov systems to correct text errors, such as special characters displaying as question marks (“?”) in proposals and project reports. This migration has been scheduled over the Veteran's Day holiday weekend to minimize the impact of the systems downtime on the research community and NSF staff.

“During this outage, there will be no access to these websites, proposals cannot be submitted in FastLane or Research.gov, and project reports and cash requests cannot be submitted in Research.gov. However, previously saved information and uploaded documents in FastLane and Research.gov, including in-progress proposals and project reports, will be accessible after the migration is completed.”

“Experts from the USDA, the FDA, and the NIH undertook much collaborative, thoughtful, and rigorous deliberation to get us to this point. ...Their final report reflects, incorporates, and analyzes diverse perspectives of more than 1,300 researchers, animal welfare advocacy organizations, scientific professional societies, members of the public, and others who commented on an earlier draft version. Investigators, generally speaking, supported the report's recommendations to reduce various administrative hurdles. But, importantly, they were also balanced with concerns raised by animal welfare organizations and the public to not lessen requirements in such a way that adversely effects the humane care and use of laboratory animals.” [<<more>>](#)

“Research Topic Contributes to Persistent Gap In NIH Research Grants to Black Scientists”

“The study identified disparate outcomes between black and white scientists at three decision points: selection for discussion, impact score assigned by the review panel and research topic choice, a previously unstudied factor. Reviewers in study sections, which are composed of subject matter experts recruited from the scientific community, showed a preference for research topics that tend to have methodologies that are highly controlled with very precise outcomes.

Black applicants were more likely than white applicants to propose research topics that receive awards at a lower rate, such as community or population-level research. Research topics with the lowest success rates included health disparities research and patient-focused interventions. Importantly, white researchers also experienced lower award rates in these topic areas, although less so than black researchers.

Despite significant efforts by NIH to close this [funding gap first identified in 2011](#), it continues to persist. This new research identifies opportunities for interventions that could bolster NIH’s [scientific workforce diversity efforts underway](#), such as the [Diversity Program Consortium](#) and the [MOSAIC program](#).”

“**NIH Marquee Awards for ‘High Risk, High Reward’ Projects Skew Male—Again**” from *Science Magazine*. Posted October 9, 2019 by Meredith Wadman.

“The U.S. National Institutes of Health (NIH) on 1 October announced the [winners](#) of an annual crop of prestigious “high risk, high reward” (HRHR) awards. The plum awards provide generous, multiyear funding to a select group of scientists—101 this year—doing outside-the-box research that might not survive standard peer review. But in past years, the awards have been scrutinized because of the [paucity of women among awardees](#).

For women, this year’s harvest was a mixed bag. For three of the four types of HRHR awards, women won in numbers that met or exceeded their representation in the applicant pool. However, that representation was meager: Eighteen percent to 38% of the applicants for these four awards were women, although women have earned [more than 50%](#) of U.S. Ph.D.s in biological sciences in every year since 2008. What’s more, in the award that is arguably best positioned to help women at a critical time in their career—the Early Independence Award (EIA), which allows awardees to skip a postdoc and start an independent lab immediately after a Ph.D.—women constitute 38% of applicants but only 25% of awardees. “I don’t see why consistently fewer women should make it through than apply,” says Monica Mugnier, a molecular parasitologist at Johns Hopkins University in Baltimore, Maryland, who won an EIA in 2016.” [<<more>>](#)

“Three percent of NIH Grants Involved a Direct Financial Conflict of Interest, Watchdog Report Finds” from *Science Magazine*. Posted September 30, 2019 by Jocelyn Kaiser.

“The 25 September [report](#) by the Office of Inspector General (OIG) of the Department of Health and Human Services (HHS), NIH’s parent agency, follows a 2008 OIG analysis that found NIH was not collecting adequate data on financial conflicts, such as payments from drug companies for consulting or royalties from patents. The report helped prompt HHS to tighten its reporting rules, which now require investigators to tell their institution about all conflicts related to their institutional duties. The institutions then tell NIH about those that could bias an NIH-funded research project and explain how the conflict will be managed.

A decade on, NIH’s improved tracking system allows a count for the first time. OIG found that in 2018, 202 of 2064 grantee institutions reported any financial conflicts of interests. A total of 1668 unique grants had at least one conflict. In total, 3978 separate “significant financial interests” were reported, because grants can have more than one investigator, and each investigator can have several types of conflicts.” [<<more>>](#)
