Featured Funder

The Smithsonian

It's still a mystery why the British chemist, mineralogist, and man of means James Smithson (1765-1829) decided to leave his money to the United States to found an "Establishment for the increase & diffusion of knowledge among men," given that he didn't have any strong ties with the country. Whatever the reason, though, that choice made possible today's Featured Funder, **The Smithsonian**.

James Smithson was the illegitimate son of Hugh Smithson, Duke of Northumberland, and Elizabeth Keate Macie Hungerford, a wealthy widow. While his father never acknowledged him as his son, James Smithson inherited a small fortune from his mother. He trained as a scientist and spent his life traveling Europe while publishing papers on topics ranging from the "[chemical content of a lady's teardrop](#)" to "[improved methods for making coffee](#)." When he died, he left his fortune to his nephew, Henry James Hungerford, with the caveat that if Hungerford died childless the remaining estate should go to the United States to establish an institute called "the Smithsonian." In due time, his nephew died without children and a very bemused representative of the U.S. government was sent to Britain to collect Smithson's bequest, returning with eleven crates of gold sovereigns. After much debate about what, exactly, an institution for the "increase and diffusion of knowledge" was, Congress passed in 1846 a law creating the Smithsonian.

Today the Smithsonian describes itself as "the world's largest museum, education, and research complex." It is also a generous funder of research on the doctoral and postdoctoral level.

"The [J.S. Lee Memorial Fellowship](#) facilitates the international exchange of curatorial expertise and contributes to the professional development of Chinese art curators and academics. Fellows may choose to be based at the Freer and Sackler or at a number of other museums worldwide." The fellowship duration is 4-12 months. **Deadline: January 22, 2020.**

The National Air and Space Museum offers [the Postdoctoral Earth and Planetary Sciences Fellowship](#). "Research areas of interest include planetary landscape evolution, planetary volcanism and cryovolcanism, tectonics of rocky and icy bodies, radar remote sensing and radar sounder studies, and analysis of terrestrial analog landforms." **Deadline: January 12, 2020.**

"The [Smithsonian's Fellowships in Museum Practice](#) (FMP) program is an opportunity for mid- and senior-level museum personnel, researchers and training providers to spend time at the Smithsonian researching a particular topic of interest that is relevant to their work at the intersection of digital education and the museum profession." The fellowship comes with a stipend of \$3,500/month for up to six months. **Deadline: rolling.**

"[The Neville-Pribram Mid-Career Educators Awards](#) allow mid-career educators to be in residence and utilize the Smithsonian Libraries distinctive collections, focusing on science, history, culture and arts. The awards are open to middle & high school teachers, college teachers, and museum educators working on curriculum development or publications in print or electronic form." **Deadline: January 10, 2020.**

[The Margaret Henry Dabney Penick Resident Scholar Program](#): "Supports scholarly research into the legacy of Patrick Henry and his political circle, the early political history of Virginia, the history of the American Revolution, founding era ideas and policy-making, as well as science, technology, and culture in colonial America and the Early National Period ... Senior scholars are particularly encouraged to apply." **Deadline: January 15, 2020.**

Sage Advice for Competitive Proposals

What is the Difference Between a Reference Letter and a Letter of Support?

The last few columns of Sage Advice have been pretty general, dealing as they have with big questions of [fit](#), [writing style](#), and [how to build community partnerships](#). This week, though, we're going to take a great running leap into a tangle of grant-writing weeds and we won't thrash our way out until we've answered a properly tiny technical question.

What is the difference between a reference letter and a letter of support?

The answer comes from a helpful NIH post from September 11, 2019.

Put simply, **a reference letter is written by someone who is familiar with your work but is not directly involved in the project you are proposing.** A co-sponsor or Co-PI for the project you are proposing generally can't write a reference letter, but a mentor, former collaborator, or colleague can. A good reference letter speaks to the significance of your work in the context of your field and your project's intellectual merits. (But please be tactful if you're writing one. I once knew someone who would write reference letters ranking his students, which would be fine ... if he didn't rank them against the members of the hiring committee.)

When soliciting letters, be careful not to bombard the funder with reference letters. In an article the NIH links to titled "Hit the Sweet Spot for Letters of Support," the National Institute of Allergy and Infectious Diseases notes, "Unnecessary letters can also limit the pool of expert peer reviewers. Due to potential conflicts of interest, anyone who writes a letter may not review your application. You could unintentionally eliminate the scientists who would have been your best supporters."

A letter of support, by contrast, is written by a person or representative of an institution directly involved in your project and is a statement of commitment. If you are the PI of a big collaborative grant, you might need a letter of support from one of your partner organizations or from your own institution, declaring what type of resources they are willing to commit and summarizing any agreements you might have in place. Those resources might be time, space, money, students, personnel, laboratory equipment, or something else altogether. Typically, the NIH notes, "Applicant organization submits the letters of support as part of the application."

There is, of course, a third type of letter—the nomination letter. Nomination letters are halfway between applications and reference letters. They are usually produced by the Provost's office in support of a faculty or staff member for an award or membership in an honorary society or department chairs in support of faculty awards, particularly for internal competitions. The details vary depending on the award guidelines, so be sure to read carefully. If you would like to nominate a faculty member for an award, IFSR would be happy to collaborate on drafting such letters.

“ Revised Policies and Procedures Guide (PAPPG) for use in 2020”

Emailed via newsletter on December 13, 2019 by NSF Staff

“We wanted to highlight some important information to assist the community in preparing for this new PAPPG as it relates to the preparation and submission of the Biographical Sketch and Current and Pending Support sections of NSF proposals that fall under this revised PAPPG.

- NSF is partnering with the National Institutes of Health (NIH) to use SciENcv: Science Experts Network Curriculum Vitae as an NSF-approved format for use in preparation of both the Biographical Sketch and Current and Pending Support sections of an NSF proposal.
- Use of an NSF-approved format for the Biographical Sketch and Current and Pending Support documents will be required upon implementation of the PAPPG. NSF is encouraging proposers to begin using SciENcv for preparation of the Biographical Sketch now.
- SciENcv allows proposers to integrate their

ORCID to enable pre-population for the Biographical Sketch. Additional information is available on the ORCID website.

- SciENcv will produce NSF-compliant PDF versions of these documents. Proposers must save these documents and submit them as part of their proposals via FastLane, Research.gov or Grants.gov.
- Additional resources including video tutorials are available on the SciENcv website.

NSF will continue to communicate with the community regarding the 2020 PAPPG and will provide further notice to the community as soon as the revised PAPPG is released. [<<more>>](#)

“NSTC Seeks Insights on the American Research Environment”

“Women are less likely to get papers accepted for publication in chemistry journals than their male colleagues are, an analysis of more than 700,000 manuscripts submitted to the Royal Society of Chemistry (RSC) has found. The society analysed the given names of authors who submitted papers to RSC journals between January 2014 and July 2018, to determine their gender. Almost 36% of the authors were women, but only around 23% of papers that were accepted for publication had female corresponding authors. The report, *Is Publishing in the Chemical Sciences Gender Biased?*, was published on 5 November.”

“When the federal government interferes with its scientists and manipulates their research and reports, science advocates often clamor for clear scientific integrity policies. Ideally, advocates say, government scientists should follow their research where it leads, talk about it honestly and freely with the press and the public, and release unaltered information about their findings.

A bill introduced earlier this year seeks to move toward that ideal. On March 13, Democratic Representative Paul Tonko of New York, introduced the Scientific Integrity Act in Congress. It passed the House Science Committee on

Then there’s the universe of private universities that aren’t subject to public records laws and don’t disclose professors’ potential conflicts at all. After these many months of close collaboration, on December 2, we decided not to recommend the grant. Our decision was prompted by the university's announcement that it would give \$2.5 million to the Sons of the Confederate Veterans to protect and display the confederate statue known as Silent Sam." <<more>>

Each fellow is expected to be in residence at Houghton for at least four weeks ... (these do not have to be consecutive weeks), and each fellow

- The article may be nominated by a member of the society, by its author, or by an editor of the publishing journal. Self-nominations are limited to one article per year. Normally, submissions for the Clifford prize are in English. Works written in languages other than English are permitted, but it may not be possible for the prize committee to assess these works.
- The author must be a member of the ASECS at the time of submission."

- The Gita Chaudhuri Prize is an annual prize that recognizes the best monograph about the history of women in rural environments, from any era and any place in the world, published by a WAWH member... The book must have been published in one of the three years prior to the prize.

- The Frances Richardson Keller-Sierra Prize is an annual \$400 prize that recognizes the best monograph in the field of history published by a WAWH member."

The program also supports research investigating factors that affect developmental change including family, peers, school, community, culture, media, physical, genetic, and epigenetic influences. Additional priorities include research that: incorporates multidisciplinary, multi-method, microgenetic, and longitudinal approaches; develops new methods, models, and theories for studying development; includes participants from a range of ethnicities, socioeconomic backgrounds, and cultures; and integrates different processes (e.g., memory, emotion, perception, cognition), levels of analysis (e.g., behavioral, social, neural), and time scales." <<more>>
