Featured Funder

American Philosophical Society

Founded in 1743 by Benjamin Franklin to promote “useful research,” the American Philosophical Society in Philadelphia is the oldest learned society in the United States. The society briefly lapsed in 1767, then re-formed in 1769, merging with the American Society for Promoting Useful Knowledge. In 1780, the state of Pennsylvania deeded a plot of land on present-day Independence Square to the Society and between 1785-1789 members erected Philosophy Hall, where the society still sits.

In its early years, the APS gained a measure of fame as a scientific center. David Rittenhouse (1732-1796) plotted the trajectory of Venus using a telescope owned by the American Philosophical Society. As the eighteenth century turned into the nineteenth, its scope expanded and it became an unofficial national library, academy of science, museum, and patent office. The society’s membership rolls reflect its enduring interest in the natural sciences. In addition to early members like Benjamin Franklin, Thomas Jefferson, George Washington and Thomas Paine, the society also invited Charles Darwin, Louis Pasteur, Elizabeth Cabot, Margaret Mead, Robert Frost and Thomas Edison.

Today the APS serves as an archive, scholarly society and—most importantly for this newsletter—a grantmaker in the humanities and sciences. In 2018–2019 the Society awarded over \$1.5 million to nearly 250 scholars. Its grants take two main forms.

First, [residential library and curatorial grants](#). Some of the grants include:

[Short-term research grants](#) to scholars whose work “will contribute a deeper understanding of America’s founding principles and history and the wider traditions that influenced its development.” **Deadline: TBA (Previously March 1, 2019)**

[Digital humanities Fellowships](#) fund scholars working to interpret archival materials through emerging technologies. **Deadline: TBA (Previously March 1, 2019)**

[Long-term residential fellowships in the History of Science](#) “for predoctoral and sabbatical scholars.” **Deadline: TBA (Previously, February 1, 2019)**

[Indigenous Communities Research Fellowships](#) for indigenous community members researching their heritage or scholars working in collaboration with Native communities. **Deadline: October 15, 2019.**

Second, [research grants](#).

[Franklin Research Grants](#) are small grants meant to defray the cost of research, such as travel to archives, the purchase of research material or laboratory supplies. It cannot be used for conference travel. **Deadline: October 1 and December 2, 2019.**

[Lewis and Clark Fund for Exploration and Field Research in Astrobiology](#) funds field studies in astronomy, chemistry, evolutionary biology, field and population biology, geology, microbiology, molecular biology, oceanography, paleontology, and planetary science. Applicants must be pre-doctoral students or no more than five years past graduation. **Deadline: February 17, 2020**

[Phillips Fund for Native American Research](#) funds research in “Native American linguistics, ethnohistory, and the history of studies of Native Americans, in the continental United States and Canada.” **Deadline: March 2, 2020**

The APS also offers selected pre-doctoral and post-doctoral fellowship, so don’t forget your graduate students when checking out these grant opportunities.

Sage Advice for Competitive Proposals

How to Tell if a Grant or Fellowship is a Good Fit

Has this happened to you?

You're looking for funding to travel to an archive or for a year abroad or support during sabbatical and you find the perfect opportunity. The Request for Proposals asks for research projects about postcolonial literature in the Global South; you write about postcolonial literature in the Global South! Feeling uncharacteristically optimistic, you spend days putting together and polishing a proposal. You find exactly the right story to tell about how your research addresses some of the biggest problems we face. At the same time, you craft your proposal so tightly that a lay reader could understand the exact question your research seeks to answer. Your methodology is clear. Your timeline is convincing. You minimize your jargon and make sure to echo the language of the RFP without obviously copying it. Your proposed budget is a thing of beauty.

And then you get the rejection. What happened?

Well, realistically any number of things could have gone wrong. Maybe you didn't pay attention to [guidelines about how to use hyperlinks](#) and the funder threw out your application without reading it. But maybe your project just wasn't a good fit, even though it sounded perfect on paper. **So how do you tell if a grant or fellowship is worth your all-too-limited time?**

Ask your friends and colleagues. Realistically, you are already doing this if you have made it this far in your career. If a foundation has funded a colleague doing similar work, chances are they might fund you.

Look at the Website. With any luck, the funding organization has descriptions of the projects they have funded posted on its website. Read it with some of the following questions in mind.

What type of projects has this grant funded? The RFP might say it funds India, but if you are an anthropologist and the grants have only gone to philologists it might be a long shot.

What types of institutions has this grant gone to? If that NSF grant that sounds perfect on paper has only ever gone to R-1 universities, you should take that into consideration.

Does the funder prefer to support research into particular regions? Some foundations like to focus their portfolios on particular areas of expertise. If all of the previous grants have gone to scholars working on Africa and you work in Latin America, your work might not be a good fit.

Are there any US travel advisories that might affect the availability of international grants?

Search [The Foundation Directory](#) in [Clio](#). The Foundation Directory is a database with information on foundations and non-profits. It allows you to search for funders, and view an organization's grants by location, subject, and amount. It is particularly helpful for getting a sense of how large typical grants are for an organization. **There's no point in applying for 20k if an organization only ever gives \$200.**

Ask the Program Officer. If you are trying to decide between two similar programs, ask the program officer which would be a better fit. It's in their best interest to send you to the right place.

News

FROM THE NSF

The NSF recently released A Dear Colleague Letter we wanted to highlight for our faculty members.

Research Protection

July 11, 2019

“Our science and engineering enterprise, however, is put at risk when another government endeavors to benefit from the global research ecosystem without upholding the values of openness, transparency, and reciprocal collaboration. Faced with such a risk, we must respond.

Our values have not changed. What has changed is the scope and sophistication of the activities threatening our research community, such as certain foreign-government-sponsored talent recruitment programs. These activities create new risks to the integrity of NSF's mission and operation. NSF is therefore taking multiple steps to mitigate these risks in concert with other agencies and stakeholders, as outlined below.

To ensure that NSF is applying consistent standards to all staff members, each of whom has access to sensitive merit review and other information, we issued a requirement in April 2018 that rotators working onsite at NSF must be U.S. citizens or have applied for U.S. citizenship.

Earlier this year, we sent a note to NSF staff reminding everyone that government ethics regulations require accurate and timely financial disclosure reports and that Federal ethics rules, which apply to both our career and rotator personnel, cover emoluments issues and gifts from foreign governments.

Since 1978, NSF has required senior project personnel on proposals to disclose all sources of

support, both foreign and domestic. A renewed effort is now underway to ensure that existing requirements to disclose current and pending support information are known, understood, and followed. For example, in May, we published in the Federal Register a proposed clarification of our proposal disclosure requirements (open for public comment through July 29). Our draft NSF Proposal and Award Policies and Procedures Guide includes clarifications regarding reporting requirements for both current and pending support and professional appointments. To streamline the process for providing these disclosures to NSF, we are proposing use of an electronic format for submission of biographical sketches, including disclosure of all appointments. As currently envisioned, this will become effective in January 2020. We are also working to develop an electronic format for disclosure of current and pending support information.” [<<more>>](#)

Linking ORCID iD to eRA Commons Profile

“We encourage everybody from graduate students to senior scientists to [register for an ORCID account](#) and [link it to their eRA Commons personal profile](#). Starting October 1, 2019, ORCID identifiers will be **required** for individuals supported by institutional research training, career development, and other research education awards. ORCID iDs will also be required for PD/PIs on individual fellowship and career development applications submitted for due dates on or after January 25, 2020. [<<more>>](#)

Reminder of NIH's Natural Disaster Policy

“When delays occur because the applicant organization is officially closed due to a natural disaster or other emergency, the NIH will consider accepting applications late, on a case-by-case basis, under the following circumstances and in accordance with the NIH Grants Policy Statement, [Section 2.3.9](#).

- Institutions must submit applications as soon as possible after reopening, not to exceed the number of days the institution was officially closed
- Institutions must submit a cover letter with the application, with enough detail about the delay so that NIH staff can make a determination whether circumstances justify accepting the application late.

Institutions need not request advance permission to submit late due to a disaster-related delay.”

“Senate bill would give NIH \$3 billion in 2020, or 7.7% boost” from *Science Magazine*, September 18, 2019

“A Senate spending panel today released a draft 2020 spending bill containing a hefty \$3 billion increase for the National Institutes of Health (NIH) that would bring the agency’s total budget to \$42.1 billion. That 7.7% boost is \$1 billion more than a House of Representatives committee approved in its version of the bill in April, and would complete a 40% increase in NIH’s budget over the past 5 years.

“The Senate Committee on Appropriations measure includes a \$350 million increase for Alzheimer’s disease research at NIH, bringing the total to \$2.82 billion, as well as \$50 million for a new Childhood Cancer Data Initiative as part of President Donald Trump’s proposed 10-year, \$500

million pediatric cancer research effort. The bill also includes \$492 million for the 21st Century Cures Act, which supports the Cancer Moonshot, the Brain Research through Advancing Innovative Neurotechnologies brain-mapping initiative (which would receive \$500 million overall, a \$71 million increase), and the All of Us precision medicine study (funded at \$500 million, an increase of \$161 million).” [<<more>>](#)

"All proposed projects should be bold, innovative, and potentially transformative and have a primary focus in conservation, education, research, storytelling, or technology. Projects should also align to one of our three focus areas: Wildlife, Human Journey, Changing Planet. We do not usually consider applications that support strictly laboratory or collections work. Grants are awarded on the basis of merit and exist independent of the Society's other divisions." [<<more>>](#)

"The Foundation's programs encompass five regions: the Domestic Region, the American Region, the European Region, the Asia-Pacific Region, and Developing Regions. "Proposals submitted for IRIS Researcher Awards must emphasize the use of IRIS data in projects that address open issues in the study of science and technology and in science policy. Topics of particular interest include but will not be limited to: (1) new methods to estimate social and economic return on investment for funding from various sources (federal, philanthropic, industrial,

and institutional); (2) studies about the relationship between research training, career outcomes and the downstream productivity of employers; (3) research on the relationship between different funding sources and mechanisms and the structure and outcomes of collaboration within and across campuses; (4) analyses of the distinctive contribution university research makes to regional economic development and resilience; and (5) examinations of the effects different funding sources and mechanisms have on research teams and the productivity and efficiency of the academic research enterprise as a whole." "DAAD grants provide foreign academics and scientists with an opportunity to carry out research and continue their education in Germany. The aim of this particular programme is to support short-term research stays and thus promote the exchange of experience and networking amongst

colleagues. Research stays can be funded at state or state-recognized institutions of higher education or non-university research institutes in Germany and last one to three months, providing monthly payments as well as travel allowances." [<<more>>](#)

Society for the Humanities at Cornell University Society Fellowships

Deadline: October 1, 2019

"The Society for the Humanities at Cornell University invites applications for residential fellowships from scholars whose research projects reflect on the 2020-21 theme of FABRICATION. Six to eight Fellows will be appointed. The fellowships are held for one academic year. Each Society Fellow will receive \$52,000. Fellows include scholars and practitioners from other universities and members of the Cornell faculty released from regular duties. Fellows at the Society for the Humanities are "residential," and will collaborate with one another and the Taylor Family Director of the Society for the Humanities, Paul Fleming, Professor of Comparative Literature and German Studies. Fellows spend their time in research and writing during the residential fellowship, and are required to participate in a weekly Fellows Seminar workshopping each other's projects and participating in lively discussions on readings based on the yearly theme." Harvard University Divinity School Women's Studies in Religion Research Associates

Deadline: October 1, 2019

"Each year, the Women's Studies in Religion Program at the Harvard Divinity School hosts five full-time research associate/visiting faculty positions. Proposals for book-length research projects utilizing both religion and gender as central categories of analysis are welcomed. Priority will go to book projects for which most

research has been completed. The projects may address women and religion in any time, place or religious tradition, and may utilize disciplinary and interdisciplinary approaches from across the fields of theology, the humanities, and the social sciences. Associates meet together regularly for collective discussion of research in progress; each Associate teaches a one-semester course related to the research project; and the Associates present their research in a public lecture series and an annual conference. "The Humanities Center offers approximately twenty-five residential fellowships for the academic year to Stanford and non-Stanford scholars at different career stages, giving them the opportunity to pursue their work in a supportive intellectual community.... External fellowships are intended primarily for individuals currently teaching in or affiliated with an academic institution, but independent scholars may apply. Faculty fellowships are awarded across the spectrum of academic ranks (assistant, associate, and full professor) and a goal of the selection process is to create a diverse community of scholars." Solidify community partnerships and diversify audiences. Creatively employ the tools of the humanities to respond to issues and ideas capturing the imagination and passion of New Yorkers today." "The Clark offers between ten and sixteen Clark Fellowships each year, ranging in duration from one to ten months. Stipends are dependent on salary and sabbatical replacement needs. Housing in the Clark's Scholars' Residence, located across the street from the campus, is provided. National Gallery of Art Senior Fellowships

"The Paul Mellon and Ailsa Mellon Bruce Senior Fellowships are intended to support research in the history, theory, and criticism of the visual arts (painting, sculpture, architecture, landscape architecture, urbanism, prints and drawings, film, photography, decorative arts, industrial design, and other arts) of any geographical area and of any period. The Samuel H. Kress Senior Fellowships are intended to support research on European art before the early nineteenth century. The William C. Seitz Senior Fellowship is primarily intended to support research on modern and contemporary art. Senior fellowship applications are also solicited from scholars in other disciplines whose work examines artifacts or has implications for the analysis and criticism of form." [<<more>>](#)

Institute for Advanced Studies (IAS) School of Historical Studies Membership

Deadline: October 15, 2019

(PREFERRED DEADLINE: October 1)

"The School of Historical Studies supports scholarship in all fields of historical research, but is concerned principally with the history of western, near eastern and Asian civilizations, with particular emphasis upon Greek and Roman civilization, the history of Europe (medieval, early modern, and modern), the Islamic world, East Asian studies, art history, the history of science and philosophy and modern international relations. The School also offers the Edward T. Cone Membership in Music Studies. Each year the School welcomes approximately forty Members selected on the basis of both external and internal review. Most are working on topics in the above mentioned fields, but each year the School also selects some scholars working in other areas of historical research." [<<more>>](#)

National Endowment for the Humanities Dialogues on the Experience of War

Deadline: October 15, 2019

"The program supports the study and discussion of important humanities sources about war, in the belief that these sources can help U.S. military veterans and others think more deeply about the issues raised by war and military service. Although the program is primarily designed to reach military veterans, men and women in active service, military families, and interested members of the public may also participate. The program awards grants of up to \$100,000 that will support the convening of at least two discussion programs for no fewer than fifteen participants; and the creation of a preparatory program to recruit and train program discussion leaders (NEH Discussion Leaders). Discussion programs may take place on college and university campuses, in veterans' centers, at public libraries and museums, and at other community venues." [<<more>>](#)

"With funding generously provided by The Recording Academy, the GRAMMY Museum Grants Program awards grants each year to

organizations and individuals to support efforts that advance the archiving and preservation of the music and recorded sound heritage of North America, and research projects related to the impact of music on the human condition. Grant funds have been utilized to preserve private collections as well as materials at the Library of Congress, the Smithsonian and numerous colleges and universities. Research projects have studied the links between music and early childhood education, treatments for illnesses and injuries common to musicians, and the impact of music therapy on populations from infants to the elderly. Emerging Artists Residency Fellowship at the Santa Fe Art Institute

"provide an annual opportunity to an emerging visual artist 25 years and older who needs time and space to explore ideas and start new projects. Artist Fellows will receive a one-month residency at the Santa Fe Art Institute, which includes a private room and bath, a private studio space, and a \$500 travel stipend. Founded in 1985, the Santa Fe Art Institute (SFAI) provides a unique opportunity for emerging artists to pursue creative projects without interruption. SFAI supports over 50 residents per year and offers a cohesive, arts-focused environment that creates the ideal working conditions for resident artists.
