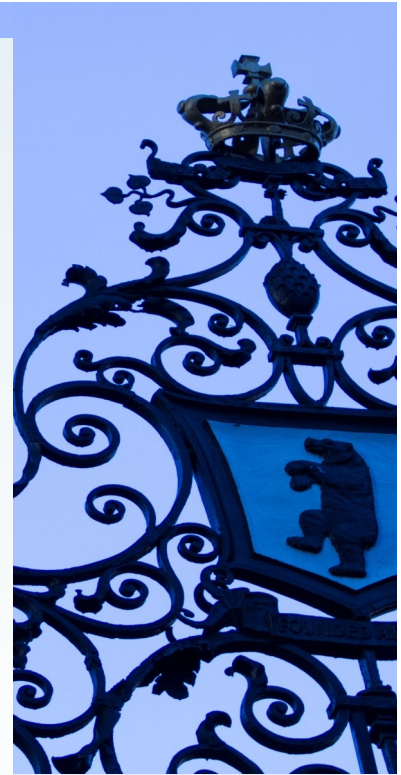

The Wenner-Gren Foundation for Anthropological Research

Why would a Swedish industrialist become the founding benefactor of a US-based anthropological research foundation? The answer can be found in Axel Wenner-Gren's book *Call to Reason: An Appeal for Common Sense*, in which he pushes for societal improvement and details the need for modern scientific technology to create "prosperity for everyone."

Axel Wenner-Gren was born in 1881 in Uddevala, Sweden. During his schooling years, he grew increasingly interested in the fields of science and applied research. His professional life started with a career in agricultural machinery, where Wenner-Gren became attracted to the role of the industrialist. Wenner-Gren created world-famous companies as an industrialist, including the appliance manufacturing company Electrolux. The founding of Electrolux emerged from Wenner-Gren's need for a vacuum that was lighter and more compact than those currently on the market. He worked on this initiative with two Swedish companies: Elektromekansia and Lux to produce lighter vacuum cleaners. In 1919, Electrolux was officially established with Wenner-Gren at the helm.

Before the creation of the foundation bearing his name, Wenner-Gren's philanthropic efforts included the establishment of both a scientific society and an institute for experimental biology in Stockholm. However, the creation of a foundation for anthropological research, a fairly distant field to what he was involved in, was based on his increased desire to look at society at large, as well as his chance encounter with Hungarian photographer Paul Fejos in Malaysia, which led to the two deciding to collaborate on an initiative. Wenner-Gren and Fejos, who became the scientific director, built up the Foundation, leading to the availability of multiple grants for anthropology researchers today.

[Post Ph.D. Research Grants](#) "are awarded to individuals holding a Ph.D. or equivalent degree to support individual research projects. The Foundation supports research that demonstrates a clear link to anthropological theory and debates, and promises to make a solid contribution to advancing these ideas." **Deadline: May 1 and November 1**

[The Engaged Anthropology Grant](#) "is designed to enable grantees to return to their research locale to share their research results with (1) The community in which the research was conducted or (2) The academic/anthropological community in the region or country of research." Only previous grantees of a Dissertation Fieldwork Grant or a Post-Ph.D. Research Grant are eligible to apply. Only "virtual engagement projects" will be accepted this year. **Deadline: August 1, 2020**

[The Fejos Postdoctoral Fellowship](#) in Ethnographic Film supports "the completion of ethnographic film(s) based on anthropological research already accomplished by the applicant. Scholars who have received a Ph.D. or equivalent within ten years of the application deadline are eligible to apply." **Deadline: May 1 annually**

[The Hunt Postdoctoral Fellowship](#) supports "the writing-up of already completed research. Scholars with a Ph.D. in hand for no more than ten years (from the application deadline) are eligible to apply." **Deadline: TBA.**

Timelines and Indirect Costs

One of the things that was most confusing to me when I started here was the difference between cost share and indirect costs. I had applied to scads of fellowships, but, as a humanist, I never really had to worry about expenses like a lab. I knew that colleges would sometimes take a percentage off the top of grants, but I didn't really understand why or how that was calculated.

Nearly a year later, I have a much better grasp on why the system works the way it does. So for this column, I want to share some of that insider knowledge with you—what the difference is between cost share and indirect costs, why they exist at all, and how they affect your application timeline.

Cost share is exactly what it sounds like—costs for the project that the college shares with the funder. This can take all sorts of forms. A foundation, for example, might pay for students' summer research stipends, but expect the college to pay for a faculty mentor's stipend. The money the college pays is its cost share. Essentially, it is a way of showing the funder that the college has some skin in the game.

Indirect costs, sometimes called Facilities and Administrative (F&A) costs, are actually the opposite. Indirect costs are expenses the college charges to the funder in order to defray expenses that, well, indirectly support the project. Think of things like space, electricity, and your friendly local grant administrators, as opposed to beakers, microscopes, and research staff. Indirect costs exist because it is expensive for a college to support research, especially research that requires a dedicated lab or specialized equipment. A college needs bigger buildings with than it would otherwise, which means more spent on rent, utilities, and electricity. It also needs specialized equipment and more computing clusters, along with IT people to maintain those computing clusters, janitors to clean the labs, and administrators to help with reporting. And all of *those* people need health insurance, retirement accounts, and paid sick leave.

Indirect costs and cost share expectations vary by organization. The NSF, for example, prohibits any mention of cost share, but negotiates indirect cost rates with colleges. Private foundations have their own rates. Some prohibit indirect costs outright or cap it at 10% or 15%, while occasionally broadly hinting that they will look more favorably on applications that minimize or forego indirect costs.

Cost share and indirect cost rates are important elements of a budget that need to be carefully considered and vetted before any grant is submitted. My colleagues in Sponsored Research are happy to help you build a budget, but must follow college policies, which stipulate that applicants should recover the full amount of indirect costs available. The Provost is responsible for deciding how much the College can contribute to cost share.

The College wants to support your research, but also needs to protect the institution as a whole. Imagine a scenario where a faculty member applies for a \$100,000 grant, blithely promises that the college will provide matching funds, and then gets the grant. Now the college is responsible for \$100,000 it might not have. Or imagine that someone submits a grant promising the college will offer a course release as cost share, but never cleared it by the college. Now his or her department is unexpectedly down a faculty member. In both cases, the college is now responsible for obligations it might not have agreed to and, equally importantly, has found itself in a position where it is distributing advantages of time and resources unfairly among faculty. These are the sorts of scenarios the college wants to avoid.

So please give us three days to a week when submitting a grant application. It helps all of us.

If an [institution requests a change of recipient institution](#), and there are concerns about safety and/or work environment involving the PD/PI, NIH expects to be informed.” <<more>>

“Many of you are well aware that COVID-19 mitigation measures have adversely affected the ability of many researchers to generate preliminary data. Now that all 50 states have begun to reopen, and investigators may be better positioned to develop preliminary data, we want to give them the opportunity to have that data considered for this application submission round. The Guide Notice we issued today announces that for applications submitted for due dates beginning May 25, 2020 for the Fall 2020 review meetings/ January 2021 Council round, NIH will accept a one-page update with preliminary data as post-submission materials for single component applications, or one page for each component of a multi-component application.” <<more>>

Scientists rush to defend Venezuelan colleagues threatened over coronavirus study

“Scientific and human rights groups in Venezuela and abroad have rushed to defend the Venezuelan Academy of Physical, Mathematical and Natural Sciences (ACFIMAN) after a high-level government official suggested raids or arrests to punish the academy for “causing alarm” in a report that suggested the country’s coronavirus epidemic is far worse than official numbers show.

In the unsigned 18-page report, released on 8 May, scientists at ACFIMAN used mathematical models to estimate the current and future size of the epidemic in the country. As of 30 March, up to

883 people in Venezuela had been infected with SARS-CoV-2, the virus that causes COVID-19, they concluded—well above the 135 reported confirmed infections at the time. The report also said the government’s reassurances that it had “flattened the curve” of exponentially increasing infections were wrong. Without additional control measures, Venezuela could see between 1000 and to 4000 cases daily during the pandemic’s expected peak between June and September, according to the study.” [<<more>>](#)

Are women publishing less during the pandemic? Here’s what the data say

“Quarantined with a six-year-old child underfoot, Megan Frederickson wondered how academics were managing to write papers during the COVID-19 pandemic. Lockdowns implemented to stem coronavirus spread meant that, overnight, many households worldwide had become an intersection of work, school and home life. Conversations on Twitter seemed to confirm Frederickson’s suspicions about the consequences: female academics, taking up increased childcare responsibilities, were falling behind their male peers at work.

“But Frederickson, an ecologist at the University of Toronto, Canada, wanted to see what the data said. So, she looked at preprint servers to investigate whether women were posting fewer studies than they were before lockdowns began. The analysis — and several others — suggests that, across disciplines, women’s publishing rate has fallen relative to men’s amid the pandemic.” [<<more>>](#)

“The purpose of this FOA is to support clinical trial planning for studies that will evaluate a therapeutic/indication pair for drug repurposing. The repurposing hypothesis should be generated using a developed method that is publicly available. Examples include independent crowdsourcing strategies [e.g., <https://ncats.nih.gov/ntu/assets/current>, <https://openinnovation.astrazeneca.com/>, or any website that lists experimental therapies (drugs or biologics)], or use of computational algorithms. The clinical trial planning phase is to allow time and support for the complete planning, design, and preparation of all the documents and development of other essential elements necessary to enhance the probability of being able to achieve enrollment goals and determine a definitive outcome for Phase I and Phase II clinical trials for a new therapeutic use. It is intended that results

obtained from this FOA could lead to subsequent implementation of clinical trials. It is expected that all assets investigated will have completed a Phase I trial by the time an award is made under this FOA. This initiative will support a planning period for a new hypothesis-driven and milestone-defined Phase I (if necessary) and/or planning for a Phase II clinical trial for a new therapeutic use. Funds provided by NCATS may only be used to support planning of phase III clinical trial activities, but not the phase III trial itself except in the case of a rare disease or condition that meets certain criteria.”
