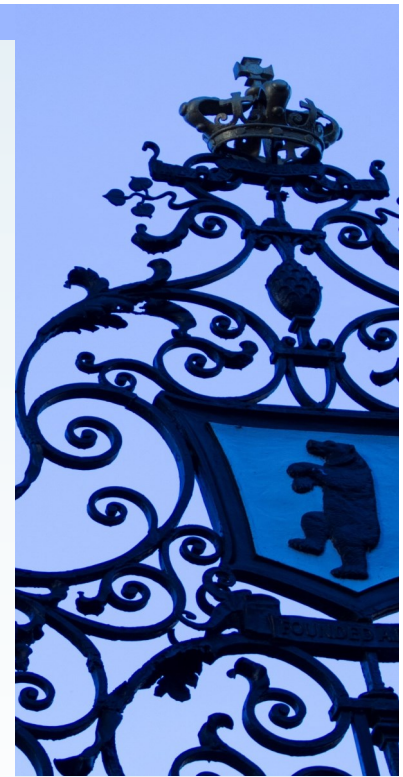

Meet the Institutional Funding and Sponsored Research Team!

We're taking a bit of a break from our usual format to introduce you to our team.

Kayla McCaffrey, Executive Director of Institutional Funding and Sponsored Research

Tell us a little about your background.

I grew up on Long Island as the eldest of three girls. I just returned (unexpectedly!) after living in NYC for nearly 15 years. I live with my spouse, Scott, our gregarious kindergartener, Poppy, and our dog, Chico.

How did you get into this line of work?

I began my career as a middle school teacher. Knowing that it was not a fit, I discovered grants work through networking and informational interviews. I took my favorite parts of teaching (organization, writing, creativity) and translated them into a new profession. My first fundraising role was at a nonprofit that supports high school students, so I like to think that I've gone from middle school to high school to college.

What is your role on the team?

I started in April 2020 as the Executive Director, Institutional Giving and Sponsored Research. Mark Godwin, Director of Sponsored Research

Tell us a little about your background.

I grew up in a small town in North Carolina (and I joke that I now live in a small town in Brooklyn). In college, I studied English, then went on to earn a master's in public administration, with a focus on arts policy. My immediate family consists of my husband Joe and our two cats.

How did you get into this line of work?

Like so many others, I got into this line of work by happy accident. The summer after my first year of grad school, I took an internship at a museum. On the first day, the Director asked me if I wanted to try working in the Development Department. I said, "Sure, but what's 'Development?'" That summer, I had my first experience with grant writing, and I've been at it ever since.

What is your current role on the team? I help faculty members apply for and manage sponsored

Feeling uncharacteristically optimistic, you spend days putting together and polishing a proposal. You find exactly the right story to tell about how your research addresses some of the biggest problems we face...And then you get the rejection. What happened?"

"Funding agencies and foundations often solicit preliminary proposals (or letters of inquiry) to reduce the work that goes into grant-making, for both themselves and applicants. New NSF engineering research centers focus on health, transportation, quantum tech and agriculture

These new centers will focus on extending the viability of cells, tissues, organs and organisms; designing sustainable infrastructure for electrified vehicles; creating building blocks of the quantum internet; and realizing precision agriculture.

“For the last 35 years, engineering research centers have helped shape science and technology in the United States by fostering innovation and collaboration among industry, universities and government agencies,” said NSF Director Dr. Sethuraman Panchanathan. “As we kick off a new generation of centers, NSF will continue to work with its partners to ensure the success of these collaborative enterprises and the transformative, convergent research impact they produce.”

Institute and Center Award Rates and Funding Disparities

“In 2011, Ginther et al. first demonstrated that African American and Black applicants to the National Institutes of Health received grant awards at a lower rate than their white counterparts ([Ginther 2011](#)). Since then, multiple studies have reproduced and extended this finding ([Ginther 2011](#); [Ginther 2016](#); [Hoppe 2019](#); [Erosheva 2020](#)). Recently we reported that African American and Black (AAB) PIs are more likely to propose research on topics that are less likely to be funded ([Hoppe 2019](#)). We found that topic choice has little or no effect on whether an application is chosen for discussion, but after considering a number of confounders, it accounts for over 20% of the gap in funding success for applications that are discussed ([Hoppe 2019](#)).” [<<more>>](#)

Research security bill advances in U.S. Senate despite opposition from research groups

“A U.S. Senate panel yesterday unanimously endorsed legislation to tighten oversight of federally funded researchers with ties to foreign governments. The move came despite objections from universities whose faculty would come under increased scrutiny if the bill becomes law.

“The bipartisan support from the Committee on Homeland Security and Government Affairs for the

Safeguarding American Innovation Act (S. 3997) reflects an apparent growing consensus that Congress should respond to Chinese-backed research collaborations seen as threatening national security. The bill includes expanded authority for the State Department to limit immigration, stiffer penalties for scientists who fail to disclose their foreign ties on grant applications, a lower threshold for individuals and institutions to report foreign gifts, and a new research oversight body led by the White House Office of Management and Budget.

However, a bevy of higher education organizations are worried that taking such actions would actually undermine innovation by making U.S. institutions less attractive to foreign scholars and increase paperwork requirements without making the country safer.” <<more>>

Senior U.S. lawmaker wants National Academies to scrutinize racism in science

“In response to a request from the chairwoman of the science committee in the U.S. House of Representatives, the National Academies of Sciences, Engineering, and Medicine (NASEM) is gearing up for an in-depth study of racism in academic research.

“Previous NASEM studies have documented the value of diversity to the practice of science, and recommended ways to broaden participation by groups historically underrepresented in science. But the study proposed by Representative Eddie Bernice Johnson (D-TX) would break new ground, say researchers who study the topic, by asking the community to examine long-standing beliefs and practices that have marginalized many individuals and skewed decisions on what topics are worthy of support.” <<more>>

Clinical Trial Planning: Therapeutic/Indication Pairing Strategies

Deadline: October 16, 2020

“The purpose of this FOA is to support clinical trial planning for studies that will evaluate a therapeutic/indication pair for drug repurposing. The repurposing hypothesis should be generated using a developed method that is publicly available. Examples include independent crowdsourcing strategies, or use of computational algorithms. The clinical trial planning phase is to allow time and support for the complete planning, design, and preparation of all the documents and development of other essential elements necessary to enhance the probability of being able to achieve enrollment goals and determine a definitive outcome for Phase I and Phase II clinical trials for a new therapeutic use. It is intended that results obtained from this FOA could lead to subsequent implementation of clinical trials. It is expected that all assets investigated will have completed a Phase I trial by the time an award is made under this FOA. This initiative will support a planning period for a new hypothesis-driven and milestone-defined Phase I (if necessary) and/or planning for a Phase II clinical trial for a new therapeutic use. Funds provided by NCATS may

only be used to support planning of phase III clinical trial activities, but not the phase III trial itself except in the case of a rare disease or condition that meets certain criteria.” [<<more>>](#)

Bill and Melinda Gates Foundation COVID-19 Therapeutics Accelerator

“The Bill & Melinda Gates Foundation, Wellcome, and Mastercard today committed up to \$125 million in seed funding to speed-up the response to the COVID-19 epidemic by identifying, assessing, developing, and scaling-up treatments. The partners are committed to equitable access, including making products available and affordable in low-resource settings. The COVID-19 Therapeutics Accelerator will play a catalytic role by accelerating and evaluating new and repurposed drugs and biologics to treat patients with COVID-19 in the immediate term, and other viral pathogens in the longer-term. Currently there are no broad-spectrum antivirals or immunotherapies available for the fight against emerging pathogens, and none approved for use on COVID-19.” <<more>>
