NSF RAPID Response Grants

Think of a major disaster from the last fifteen years. The Gulf Coast oil spill. The 8.8 magnitude earthquake in Chile in 2010. Ebola. Our increasingly violent hurricane season. Chances are whatever you just thought of was followed by a call from the NSF for a RAPID Response Grant.

Our current disaster, COVID-19, is no different. On March 4, 2020, NSF released a [Dear Colleague Letter](#) that began as follows:

In light of the emergence and spread of the coronavirus disease 2019 (COVID-19) in the United States and abroad, the National Science Foundation (NSF) is accepting proposals to conduct non-medical, non-clinical-care research that can be used immediately to explore how to model and understand the spread of COVID-19, to inform and educate about the science of virus transmission and prevention, and to encourage the development of processes and actions to address this global challenge.

We've profiled the NSF before, but this seems like a good time to highlight its RAPID Response Grants—what they are and how they're different from regular NSF grants.

[According to the NSF](#), "RAPID is a type of proposal used when there is a severe urgency with regard to availability of, or access to, data, facilities or specialized equipment, including quick-response research on natural or anthropogenic disasters and similar unanticipated events. PI(s) must contact the NSF Program Officer(s) whose expertise is most germane to the proposal topic before submitting a RAPID proposal. This will facilitate determining whether the proposed work is appropriate for RAPID funding."

RAPID Grants differ from regular NSF grants in a few key ways.

- 1) They're shorter.** NSF proposals normally tend to be 15 pages, but, as the NSF's website notes, "The Project Description is expected to be brief and must be no more than five pages. It must include clear statements as to why the proposed research is of an urgent nature and why RAPID is the most appropriate type of proposal for supporting the proposed work. Note this proposal preparation instruction deviates from the standard proposal preparation instructions contained in this Guide; RAPID proposals must otherwise be compliant with the proposal preparation requirements specified in Part I of the PAPPG."
- 2) They aren't sent out for external review.** "Only internal merit review is required for RAPID proposals. Under rare circumstances, Program Officers may elect to obtain external reviews to inform their decision. If external review is to be obtained, then the PI will be informed in the interest of maintaining the transparency of the review and recommendation process. The two standard National Science Board-approved merit review criteria will apply."
- 3) They only last a year (though they can be renewed).** "Requests may be for up to \$200K and up to one year in duration. The award size, however, will be consistent with the project scope and of a size comparable to grants in similar areas."
- 4) If declined, they cannot be resubmitted.**
- 5) Renewals must be subject to external review.** "Renewed funding of RAPID awards may be requested only through submission of a proposal that will be subject to full external merit review. Such proposals would be designated as "RAPID renewals."

Sage Advice for Competitive Proposals

COVID-19 Frequently Asked Questions for Researchers

There's not much point in talking about anything else right now, so today's Sage Advice column is going to pull together the information we have about how COVID-19 will affect your grants—both the ones you are applying for and the ones you currently have.

On our home ground, [Columbia has put together a very thorough FAQ page](#) that addresses concerns of scholars who want to work on COVID-19, either by applying for related grants or sharing biological samples (such as plasma or virus) with other organizations, and scholars whose work is interrupted by the outbreak. Among other topics, the website answers the following questions:

- “How will the pause in my research impact my grant expenditures?”
- “My study may be impacted by the pause, which could lead to delays in completing my study by the end of the project period. What should I do?”
- “What is the contingency plan for research animal care?”

The NSF recently released a [Dear Colleague Letter](#), inviting proposals “to conduct non-medical, non-clinical-care research that can be used immediately to explore how to model and understand the spread of COVID-19, to inform and educate about the science of virus transmission and prevention, and to encourage the development of processes and actions to address this global challenge.” They also have a [FAQ page](#) devoted to all questions related to the Coronavirus. Here are some key points:

“Will NSF provide for an extension to my award if the planned activities are disrupted by the COVID-19 public health threat?”

“All NSF awards are eligible for one-year grantee-approved no-cost extensions and then further extensions as approved by NSF. If you foresee a need for NSF-approved extensions, you should include that information in your annual report and discuss the need ahead of time with the cognizant NSF program officer for your award. See the [Proposal & Award Policies & Procedures Guide \(PAPPG\)](#), Chapter VI.D.3, for additional information.”

“My university has asked staff to stay home for an undetermined period of time. How would I petition for an extension of a proposal deadline?”

“Researchers or sponsored projects office staff from organizations that have been affected and are unable to meet stated NSF deadlines should contact the cognizant NSF program office to discuss the issue. NSF will consider extensions to the submission deadline on a case-by-case basis (and, in a few cases, on a program-by-program basis), understanding that it may be particularly difficult for individuals impacted to contact NSF.”

The NIH has a similarly helpful [FAQ page](#).

“My NIH grant involves an exchange of researchers (including students) and/or other foreign travel. Should I continue with plans?”

Travel logistics, accessibility, and health and safety considerations of the participants in an active research project should always be a foremost consideration. NIH recommends consulting with your organization about its policies and procedures. You may consider approaching the planned researcher exchanges and/or other foreign travel with flexibility, and/or devising alternate plans including virtual participation as appropriate. As noted above, NIH understands that plans for active research projects may be disrupted, to the point of needing extensions on the original award durations. For foreign travel, you should consult the [State Department Travel Advisories website](#).”

“FAQs About the Coronavirus Disease 2019 for NSF Proposers and Awardees”

“This document addresses questions associated with proposal submission and award management that may arise in relation to COVID-19. NSF is providing this information as a service to our proposer and awardee communities in the hope it will address most of the questions that may arise in this regard. Given that COVID-19 and the associated impacts continue to evolve, proposers and awardees are strongly encouraged to monitor this website for updates.” <<more>>

“The National Science Foundation is working closely with the research community to bolster our national response to coronavirus disease 2019 (COVID-19) and has issued [a letter to researchers](#) inviting additional proposals for rapid response grants related to the virus.” <<more>>

“NSF creates new research security chief position”

“The National Science Foundation has appointed Rebecca Spyke Keiser to the newly created position of chief of research security strategy and policy as part of its continuing effort to ensure the security of federally funded research while maintaining an open international collaboration.

In this role, Keiser will be tasked with providing the NSF director with policy advice on all aspects of research security strategy. She will also lead NSF’s efforts to develop and implement strategies to improve research security and the agency’s coordination with other federal agencies and the White House.

NSF created the position as part of its response to the recommendations the independent science

advisory group JASON presented to NSF in the study “Fundamental Research Security,” published in December.

“The JASON report was clear that the U.S. science community faces threats to its longstanding position of openness and transparency of research and its results. Navigating this situation will require substantive engagement with the research community, intelligence agencies, oversight committees and law enforcement. Dr. Keiser will lead our engagement efforts,” said NSF Director France Córdoba. “All of us at NSF are taking this issue very seriously.” <<more>>

FROM THE NIH

“NIH Late Application Policy Due to Public Health Emergency for United States for 2019 Novel Coronavirus.” March 9, 2020

“It is likely that the emergency declaration related to novel coronavirus (COVID-19) will adversely affect some NIH applicants' and recipients' ability to submit applications in a timely manner.

Late applications

When delays occur because the applicant or recipient organization is officially closed or unable to submit grant applications due to the effects of COVID-19, the NIH will consider accepting applications late, on a case-by-case basis, in accordance with the NIH Grants Policy Statement, [Section 2.3.9](#), under the following circumstances:

- Institutions must submit applications or reports as soon as possible after reopening or resuming operations so that grant applications can be submitted, not to exceed the number of days the institution was officially closed or unable to submit grant applications.
- Institutions must submit a cover letter with the applications with enough detail about the

delay so that NIH staff can make a determination whether circumstances justify accepting the application late.

- Institutions need not request advance permission to submit late due to this declared emergency.

NIH will be issuing additional guidance related to this public health emergency in the near future.”

“Trump Administration Expands Reach of EPA Secret Science Proposal.”

“The U.S. Environmental Protection Agency (EPA) yesterday evening released a controversial proposal to limit the scientific research used in the federal rulemaking process.

Greens have already vowed to sue the agency.

The draft “Strengthening Transparency in Regulatory Science” is part of the agency’s persistent effort to rework the foundation on which public health and environmental rules are crafted.

The draft released yesterday builds on a 2018 proposal issued by then-EPA Administrator Scott Pruitt, who at the time declared that “the era of secret science at EPA is coming to an end.” Now his successor, Andrew Wheeler, has sought to shore up shortcomings in the initial proposal while expanding the scope to cover all the agency’s scientific information—not just what’s used in rulemaking.” [<<more>>](#)

“China bans cash bonuses for publishing papers.”

“Chinese institutions have been told to stop paying researchers bonuses for publishing in journals, as part of a new national policy to cut perverse incentives that encourage scientists to publish lots of papers rather than focus on high-impact work.

In an order released last week, China’s science and education ministries also say that institutions must not promote or recruit researchers solely on the basis of the number of papers they publish, or their citations. Researchers are welcoming the policy, but say that it could reduce the country’s

competitiveness in science. Despite their size, researchers say studies of one person can uncover results that would be lost in a large-scale trial and can have all of the statistical power and scientific rigor of studies involving hundreds or thousands of people." <<more>>

Fahs-Beck Fund of the New York Community Trust Research and Experimentation Grant Program

Deadline: April 1, 2020

"Areas of interest to the Fund are: studies to develop, refine, evaluate, or disseminate innovative interventions designed to prevent or ameliorate major social, psychological, behavioral or public health problems affecting children, adults, couples, families, or communities, or studies that have the potential for adding significantly to knowledge about such problems."

Columbia Brown Institute Magic Grant

Deadline: April 10, 2020

"Magic Grants provide year-long funding awards of up to \$150,000 (\$300,000 for teams with members of both the Columbia and Stanford communities). In addition to funding, grantees have access to a distinguished advisory and mentoring group, an extensive and inspiring alumni network. We are looking for hardware, software, and story proposals. We are interested in projects that advance storytelling and journalism through new applications of technology. We also are interested in new tools and technologies that extend media broadly. Since its founding six years ago, the Brown Institute has funded over 140 people across over 40 projects. Example include... An open repository for data on the Panamanian government. A

hotspot detector for social media feeds, highlighting important stories in a city. A tool to auto-generate rough cuts for documentary videos. A 360-video documentary on the famine in South Sudan. An augmented reality application for enhancing tours through art museums. Experiments with natural and gestural (i.e., not a joystick) interfaces to drones. A platform for helping science journalists better contextualize new research reports." <<more>>

Library of Congress John W. Kluge Center Philip Lee Phillips Society Fellowship

Deadline: April 15, 2020

"The John W. Kluge Center and the Philip Lee Phillips Map Society at the Library of Congress invite qualified scholars to apply for a grant to conduct research for two months at the Kluge Center using the Geography and Map Division's collections and resources. The Philip Lee Phillips Society Fellowship will award \$11,500 to selected scholars with the possibility of an additional \$2,000 as an honorarium for a later lecture and publication. The Geography and Map Division has custody of collections numbering over 5 million maps, 100,000 atlases, 8,000 reference works, over 5,000 globes and globe gores, 3,000 raised relief models and several terabytes of born digital geospatial data." <<more>>

Yale LGBT Studies

Yale University LGBT Studies Research Fellowship

Deadline: April 17, 2020

"The Lesbian, Gay, Bisexual, and Transgender Fellowship is offered annually, and is designed to provide access to Yale resources in LGBT Studies for scholars who live outside the greater New Haven area. Scholars from across the country and around the world are invited to apply for the Yale LGBT Studies Research Fellowship. This fellowship supports scholars from any field pursuing research in lesbian, gay, bisexual, transgender, and/or queer studies at Yale University, utilizing the vast faculty resources, manuscript archives, and library collections available at Yale. Graduate

students conducting dissertation research, independent scholars, and all faculty are invited to apply. **Scholars residing within 100 miles of New Haven are ineligible.** <<more>>

National Geographic Society Grants Programs

Deadline: April 22, 2020

"As part of supporting a planet in balance, National Geographic offers Exploration grants that concentrate on certain key issues. Applicants may propose projects focused in conservation, education, research, storytelling, or technology. We do not usually consider applications that support strictly laboratory or collections work. Grants are awarded on the basis of merit and exist independent of the Society's other divisions."

National Library of Australia National Library of Australia Fellowships

Deadline: April 24, 2020

"The National Library of Australia, in partnership with its generous sponsors and donors, offers researchers an opportunity to undertake a 12-week residency at the Library. Applicants may work in any field or discipline where the Library's collections have appropriate depth and breadth to support the desired outcomes. Fellowships are available to researchers who require onsite access to the Library's uniquely held or extensive collections to advance their research towards publication or other public outcomes. Fellowships will:

- contribute to a greater public understanding or knowledge of the Library's collections
- promote discussion through research which informs and engages contemporary discourse.
- enhance the national and international reputation of the National Library as an institution of major research significance.
- actively promote the research experience and outcomes

Fellowships are open to individuals with research at any stage of development, as well as those

undertaking research which forms part of a larger project. When an individual is contributing to a collaborative project, they must demonstrate their own research component." <<more>>

Project Management Institute Sponsored Research Project

Deadline: April 25, 2020

"Each year, PMI solicits proposals for research funding on any topic related to project, program or portfolio management. Awards up to US\$50,000 are granted to selected recipients. Proposed research must have direct application to some aspect of the project management body of knowledge or its practice." <<more>>

Lawrence Foundation Grants in Environment and Human Services

Deadline: April 30, 2020

"The Lawrence Foundation is a private family foundation focused on making grants to support environmental, education, human services and other causes.... The foundation is focused on making grants to support environmental, human services and other causes although our interests are fairly diverse and may lead us into other areas on an occasional basis. We make both program and operating grants." <<more>>

Textbook and Academic Authors Association Academic & Textbook Writing Grants

Deadline: April 30, 2020

"TAA offers two forms of grants to assist members and non-members with some of the expenses related to publishing their academic works and textbooks.

- Publication Grants provide reimbursement for eligible expenses directly related to bringing an academic book, textbook, or journal article to publication.
- Contract Review Grants reimburse eligible expenses for legal review when you have a contract offer for a textbook or academic monograph or other scholarly work that includes royalty arrangements." <<more>>

History of Art Grants Program

Deadline: April 1, 2020

"The History of Art program supports scholarly projects that will enhance the appreciation and understanding of European art and architecture. Grants are awarded to projects that create and disseminate specialized knowledge, including archival projects, development and dissemination of scholarly databases, documentation projects, museum exhibitions and publications, photographic campaigns, scholarly catalogues and publications, and technical and scientific studies. Grants are also awarded for activities that permit art historians to share their expertise through international exchanges, professional meetings, conferences, symposia, consultations, the presentation of research, and other professional events." <<more>>

"The J. Franklin Jameson Fellowship in American History is offered annually by the John W. Action Grants

Deadline: April 1, 2020

"Up to \$5,000 to implement humanities projects that encourage public audiences to reflect on their values, explore new ideas, and engage with others in their community. These grants require organizations to demonstrate a match of at least one-to-one. Requests related to the U.S. Women's Suffrage Centennial in 2020, the Erie Canal Bicentennial, and the prison ecosystem are welcome. They aim to:

- Connect audiences more deeply to the communities where they live and work.
- Solidify community partnerships and diversify

audiences.

- Creatively employ the tools of the humanities to respond to issues and ideas capturing the imagination and passion of New Yorkers today." <<more>>

Digital Art History Grants Program

Deadline: April 1, 2020

"The Digital Resources program is intended to foster new forms of research and collaboration as well as new approaches to teaching and learning. Support will also be offered for the digitization of important visual resources (especially art history photographic archives) in the area of pre-modern European art history; of primary textual sources (especially the literary and documentary sources of European art history); for promising initiatives in online publishing; and for innovative experiments in the field of digital art history." <<more>>

Fellowship in Aerospace History

Deadline: April 1, 2020

"The Fellowships in Aerospace History are offered annually by the National Aeronautics Space Administration (NASA) to support significant scholarly research projects in aerospace history. These fellowships grant the opportunity to engage

in significant and sustained advanced research in all aspects of the history of aerospace from the earliest human interest in flight to the present, including cultural and intellectual history, economic history, history of law and public policy, and the history of science, engineering, and management. NASA provides funds to the American Historical Association, the History of Science Society, and the Society for the History of Technology to allow each association to award a fellowship. Applications will be entered into consideration for all three fellowships.... The fellow will be expected to devote the term entirely to the proposed research project. Residency is not required." The Center for Ethnomusicology

The Nadia and Nicholas Nahumck Fellowship

Deadline: April 1, 2020

"Purpose: To help support research on a dance-related subject and its subsequent publication. Eligibility: Established scholars, recent Ph.D.s or Ph.D. candidates who have completed all degree program requirements except dissertation research. Preference will be given to applicants planning to enhance their research findings with movement notations such as Labanotation and/or with digital media such as photographs, video, or web-based formats. Prize: \$4,000 research fellowship and \$1,000 award for publication. Regularity: Awarded biennially (even years), or as frequently as allowed by investment returns." [<<more>>](#)

National Endowment for the Humanities Fellowship

Deadline: April 1 2020

"NEH Fellowships are competitive awards granted to individual scholars pursuing projects that embody exceptional research, rigorous analysis, and clear writing. Applications must clearly articulate a project's value to humanities scholars, general audiences, or both. Fellowships provide recipients time to conduct research or to produce books, monographs, peer-reviewed articles, e-books, digital materials, translations with annotations or a

critical apparatus, or critical editions resulting from previous research. Projects may be at any stage of development." [<<more>>](#)

National Endowment for the Humanities Mellon Fellowships for Digital Publication

Deadline: April 8, 2020

"Through NEH-Mellon Fellowships for Digital Publication, the National Endowment for the Humanities and The Andrew W. Mellon Foundation jointly support individual scholars pursuing interpretive research projects that require digital expression and digital publication. To be eligible for this special opportunity, an applicant's plans for digital publication must be essential to the project's research goals. That is, the project must be conceived as digital because the nature of the research and the topics being addressed demand presentation beyond traditional print publication. Successful projects will likely incorporate visual, audio, and/or other multimedia materials or flexible reading pathways that could not be included in traditionally published books, as well as an active distribution plan." Columbia University Heyman Center Edward Said Fellowship

"Named in his honor, the Edward W. Said Fellowship supports promising scholars early in their careers to produce scholarship that speaks across disciplinary boundaries, promotes humanistic inquiry in the service of intercultural communication and understanding, and engages the public. The fellowship is intended to help support a short-term residency (one month to one semester) at Columbia University so as to allow scholars to consult the Edward W. **National Endowment for the Arts
Challenge America Grants**

Deadline: April 9, 2020

The Challenge America category offers support primarily to small and mid-sized organizations for projects that extend the reach of the arts to underserved populations -- those whose opportunities to experience the arts are limited by geography, ethnicity, economics, or disability. Age alone (e.g., youth, seniors) does not qualify a group as underserved; at least one of the underserved characteristics noted above also must be present. Provide details about the underserved audience you select in your application using relevant statistics and anecdotal information. Proposals should detail the efforts made to reach the identified underserved population. Grants are available for professional arts programming and for projects that emphasize the potential of the arts in community development."
