The Coronavirus Aid, Relief, and Economic Security (CARES) Act

There's really only one story right now in the higher education funding world: the Coronavirus Aid, Relief, and Economic Security Act (CARES) Act. Some of its funding is available to individual researchers, some of it only goes to college administration to be disbursed to students, but all of it is relevant to you as someone working in a university, so this column will give you an overview of the act's provisions as a whole as they relate to higher education.

The first thing to know is that the [CARES Act earmarks \\$14 billion for direct payment to colleges](#). Roughly half of that money has to go directly to students for emergency aid immediately. In addition to money allocating money directly to colleges, the CARES Act also gives each of the major agencies—the NSF, NIH, NEH, NEA, and IMLS—a lump sum of money to distribute as they see fit. Each has chosen a different way to disperse their funds.

As mentioned in our last newsletter, the **National Science Foundation received \$75 million that it is currently dispersing through RAPID Response Grants**, a special type of grant that allows the NSF to respond quickly to natural disasters and unexpected events. As the NSF notes on its website, “Requests for RAPID proposals may be for up to \$200K and up to one year in duration. Well-justified proposals that exceed these limits may be entertained.” For more details, see [here](#).

The National Institute of Health has chosen to distribute funding by issuing “Urgent Competitive Revisions” and “Emergency Competitive Revision” Funding Opportunity Announcements to modify existing awards. As the agency explains in a recent newsletter, “This approach allows us to leverage resident expertise, getting additional funding to those researchers who are already working with other organisms, models, or tools so that they can quickly shift focus to the novel coronavirus.” Emergency Competitive Revision Funding can only be used by NIH Institutes and Centers, so for our purposes can be ignored. Urgent Competitive Revisions, however, do apply to individual researchers and “can be used to meet immediate needs to help address a specific public health crisis in a timely manner.” Researchers must respond to a specific Notice of Special Interest (NOSI) when applying for funding. Once a researcher applies for additional funding, the NIH will do its best to expedite the review process by foregoing external peer review in favor of internal review by NIH experts. [The National Endowment for the Arts](#) limits its emergency funding to organizations that have received an NEA award in the last four years. Eligible organizations can only apply for one grant, with a maximum of \$50,000. The funding can only be used to support at-risk positions or facility costs.

We don't yet know the details of [the National Endowment for the Humanities](#), though its website promised an update by **April 30**. It looks, though, that agency will receive \$75 million. “Approximately 40 percent of the appropriation, or \$30 million, will go directly to the 56 state and jurisdictional humanities councils, based on the standard population formula used for their annual appropriation. The remaining 60 percent, or \$45 million, will support at-risk humanities positions and projects at museums, libraries and archives, historic sites, colleges and universities, and other cultural nonprofits that have been financially impacted by the coronavirus.” The NEH is also looking into giving emergency funding to national humanities organizations to support members, including “independent scholars, cultural heritage professionals, contingent faculty, schoolteachers, college and university professors, and other humanists economically impacted by the coronavirus.”

All of this is subject to change. We will do our best to update you as new opportunities emerge.

Sage Advice for Competitive Proposals

How to Stay Sane During COVID-19

I am not going to give advice on how to stay productive during quarantine or tell you now is a great time to look for funding opportunities for the next year. Some of you work with human subjects and had to close your labs or cut short your ethnographic research. Others of you have children at home. Nearly everyone is living in a small NYC apartment right now with too many people and not enough privacy. Worst of all, some of you are nursing sick family members or have lost those you love. Our thoughts are with all of you right now. You know what your reality is right now and what is possible for you. Instead, I want to round up the best articles I have read recently on staying sane during the pandemic and managing your new responsibilities in unprecedented times.

The first is an [op-ed](#) by Aisha Ahmed, who is an Assistant Professor at the University of Toronto. Drawing on her own experience living in high-stress situations, Ahmad gives the following advice.

Know that you are not failing. Let go of all of the profoundly daft ideas you have about what you *should* be doing right now. Instead, focus intensely on your physical and psychological security. Your first priority during this early period should be securing your home. Get sensible essentials for your pantry, clean your house, and make a coordinated family plan. Have reasonable conversations with your loved ones about emergency preparedness. If you have a loved one who is an emergency worker or essential worker, redirect your energies and support that person as your top priority. Identify their needs, and then meet those needs.

Only once you have met your basic needs, Ahmad offers, will it be possible to start reclaiming time to start thinking about research.

Closer to home, Barnard's Assistant Professor of Psychology, Michael Wheaton, recommends focusing on the altruistic motives behind social distancing to lessen the negative psychological effects of isolation, and creating both space and routine for work. [In an interview on Barnard's website](#), he notes:

People who have studied working from home recommend trying to keep the workspace you will work from separate from the rest of your house or apartment to the extent possible. This physical separation of space will help you mentally [differentiate] between when you are at work and when you are not, so that work does not become something you are doing all of the time. They also recommend trying to keep the same routine as if you were heading into the office. Wake up, shower, and get dressed, as if you were going to the office, and it will feel more normal to you.

And if you manage to juggle kids, online courses, and research, don't forget your graduate students, [an article by Leonard Cassuto](#), Professor of English at Fordham University, advises. It can be tempting, he acknowledges, to focus your attention on your undergraduates, but don't forget that your graduate students also need help, moral support, and advice at a moment when very many colleges are placing hiring freezes and the economy is sliding into a recession that is on track to be as devastating as the Great Depression. How should you help them? "Ask them. Then, after an appropriate time, ask them again.... When I asked my current Ph.D. students an open question on how I could best advise them at this strange moment, they mostly talked about working plans and deadlines. Their answers showed me that they wanted structure. That's understandable, considering that the quotidian rhythm of their lives has fallen apart." It's good advice, whether dealing with graduate students or suddenly unmoored undergraduate researchers.

Most of all, though, stay safe and stay well.

Approved formats for creating current & pending support are:

[SciENCv](#) - **(AVAILABLE NOW!)** NSF has partnered with the National Institutes of Health (NIH) to use [SciENCv: Science Experts Network Curriculum Vitae](#) as an NSF-approved format for use in preparation of the current and pending support section of an NSF proposal. Adoption of a single, common researcher profile system for Federal grants reduces administrative burden for researchers. [SciENCv](#) will produce NSF-compliant PDF versions of the current & pending support format. Proposers must save these documents and submit them as part of their proposals via FastLane, Research.gov or Grants.gov.

[NSF Fillable PDF](#) - **(AVAILABLE NOW!)** NSF is providing a fillable PDF of the current & pending support format. Proposers will be able to download it from this page, complete the form, and upload as part of their proposal via FastLane, Research.gov or Grants.gov. This document addresses questions associated with proposal submission and award management that may arise in relation to COVID-19. NSF is providing this information as a service to our proposer and awardee communities in the hope it will address most of the questions that may arise in this regard. “CAN ESI STATUS BE EXTENDED DUE TO DISRUPTIONS FROM COVID-19?” April 9, 2020 by NIH Staff

“Yes. Be sure to describe the nature of the disruption to your research in your ESI extension request. We suggest you submit the request once you know how much research time was lost, unless your upcoming application deadline is imminent and an ESI extension is urgently needed. ERA MOVING TO THE CLOUD APRIL 17 TO APRIL 20; SYSTEMS UNAVAILABLE DURING THIS TIME

“Just a reminder that eRA is planning a major undertaking this month, to migrate its modules and data to the Amazon Web Services (AWS) cloud April 17-20 (Fri-Mon).

During this cloud migration, from 8 a.m. ET on Friday, April 17 to 8 p.m. ET on Monday, April 20, all eRA modules (eRA Commons, ASSIST, IAR, iEdison, etc.) and all informational websites (era.nih.gov, etc.) will be unavailable.

Any affected due dates will be covered under [NIH’s late application policy due to COVID-19](#), which allows all applications submitted late for due dates between March 9, 2020, and May 1, 2020, to be accepted through May 1, 2020.” [<<more>>](#)

EPA Can’t Bar Grantees from Sitting on Science Advisory Panels, Judge Rules

participating on its science advisory boards, a federal judge said yesterday. The ruling from Senior Judge Denise Cote of the U.S. District Court for the Southern District of New York follows her decision earlier this year that said EPA needed to provide a "reasoned explanation" for the 2017 ban, which resulted in the ouster of scientists from advisory panels (Greenwire, 11 February). The judge requested recommendations for next steps in the case and was ultimately persuaded by the Natural Resources Defense Council's arguments that scrapping the policy would not require the agency to immediately restructure its advisory committees." <<more>>

What the Coronavirus Stimulus Means for Higher Education Funding.

From the National Association of College and University Business Officers. Posted on March 27, 2020.

"One of the most notable items for higher education is the creation of a nearly \$31 billion Education Stabilization Fund. These funds primarily will be split into three buckets:

- \$13.2 billion for Department of Education grants to K-12
- \$13.95 billion for Department of Education grants to colleges and universities
- \$2.95 billion for grant aid given to states to award to K-12 and higher education institutions, mostly at the governor's discretion

Separate allotments are made within the Education Stabilization Fund to provide additional funds to tribal colleges and designated minority-serving institutions. Additionally, about \$349 million is reserved expressly for schools hit particularly hard by the virus, with priority going to small schools that receive less than \$500,000 in the larger pool of ED grants, as well as to minority-serving institutions that have remaining unmet need." <<more>>

Research Center Visiting Fellowships**

“In 2020, the Humanities Research Centre is inviting scholars from all over the world to explore the history and philosophy, politics and prospects of liberalism. We will begin by asking what exactly is liberalism – or should we be talking about ‘liberalisms’ in the plural? Is there a set of internally consistent ideas that adds up to what we can call ‘liberalism’ and, if there is, how did liberalism develop in the lead up to the early nineteenth century, when select people and parties first began characterising themselves as ‘liberal’? Scholars are invited to explore fictional and non-fictional texts, along with other historical and contemporary socio-cultural phenomena, which can be identified as sites in and through which the liberal subject has been projected and cultivated. How does liberalism balance the desire for individual freedom with the need for collective authority? Is freedom of expression in the humanities and the creative arts only possible within a liberal culture – or is liberalism, at some level, antipathetic to the arts? Can liberalism explain and engage the emotions? Can it accommodate illiberalism? Have extreme forms of liberalism, like neo-liberalism, with its stress on self-interest and its reduction of all values to those of the market place, disrupted or destroyed the development of a liberal future?” <<more>>
