Featured Funders

Stanford University's Center for Advanced Study in the Behavioral Sciences

In late April of 1970, residents spotted several men on motorcycles circling the area near Stanford's [Center for Advanced Study in the Behavioral Sciences](#) (CASBS). They were firefighters in training, they explained later to the police, patrolling the area in case any malcontents got any ideas. It wasn't a very satisfying story but there wasn't much the police could do but release them. With them went the last lead to the arson case that broke out on April 24, 1970, destroying books, building, and irreplaceable scholarly notes housed in Stanford's CASBS. No one would ever discover who set the fire or why they targeted CABS. The event was eventually written off as one more act of protest against the university during the Vietnam War.

At the time of the arson attack, CASBS was only sixteen years old. It had been founded in 1954 with a grant from the Ford Foundation, with Ralph Winfred Tyler selected to lead the Center. Tyler was in some ways an obvious choice to lead the center in its early years. He was born in Chicago in 1902, the sixth of eight children. At the time, his father was working as a doctor, but, a deeply religious man, he began to worry that his profession was too lucrative. With his equally religious wife's support, Tyler's father abandoned medicine, became instead a minister, and moved to Nebraska. (As a religion PhD, the math checks out.) As a result, when it came time to attend college, Tyler worked his way through, attending classes during the day and working as a telegraph operator on a railroad at night. This doesn't seem like the best job to perform sleep-deprived, but apparently it all ended happily enough with Tyler getting a degree and going on to teach high school in South Dakota.

During his time in South Dakota, Tyler became interested in the inadequacy of an educational system that only tested memorization. How to assess curricula and educational strategies became the center of his work, first in a M.A. at the University of Nebraska (1923), then during his PhD at the University of Chicago (1927). Tyler then joined the faculty at Ohio State University. While in Ohio, he helped the University assess its curriculum and reform it to boost retention. His most high-profile project, however, came in 1933, when he was tapped to lead the "Eight-year Study," a large national experiment to see if high school students would be competitive in college applications if their schools had full control over the curriculum, rather than adhering to a traditional curriculum that focused rigidly on the classics. The students were competitive, and even showed signs of greater artistic and political engagement. It was a win for progressive education, a win for the students (who maybe didn't need the win that badly, since they largely came from wealthy backgrounds), and a win for Tyler, whose work on evaluating education gained national prominence, leading directly to his selection as the director of CASBS until his retirement in 1967.

So Tyler wasn't there to see the arson attack on CASBS that destroyed more than one scholar's work or to see the CASBS rebuild itself and expand into the research oasis it is today. Today the CASBS offers [residential fellowships](#) for outstanding scholars at least three or four years past their PhDs. All scholars will be judged in comparison to those at similar career stages. "In addition to scholars working in fields of the behavioral and social sciences, those in other areas will also be considered for fellowships if their work has human behavioral and social dimensions." CASBS offers a stipend to first-time awardees that will match 50% of their base salary, up to \$77,000. **Deadline: TBA. Previously November 5, 2021.**

In addition, there are other fellowships that faculty may be considered for, including the following:

Sage Advice

The Best Preparation for Grant Writing is Teaching

The best teacher I had wasn't particularly flashy. He didn't make a big deal about experimental pedagogy or multimedia displays. In fact, all he ever used in class was chalk, heavily annotated books, and a carefully prepared set of questions. One of the things that made him such a great teacher was that sometimes he would pause in the midst of writing his careful list of points (which we always scrambled to copy verbatim, because they sounded so precisely formulated) and translate what the thinker was saying into human terms. "Hegel wants to know whether the world can be a home," he said once and I've thought about it ever since.

I'm thinking about it again right now because for a long time I've held a theory that good grant writing has a lot in common with good teaching, at least when it comes to research grants. Sometimes you hear that a background in journalism is helpful in grant writing and I'll admit a snappy anecdote is always welcome, but if you want to get in the head space for grant writing, I think the best thing you can do is think about teaching.

Here's what happens when I'm preparing to teach. I read through a text, make notes on all the interesting passages and themes that I see tying it together. Then I settle back and ask myself a few different questions.

- How can I succinctly summarize the main argument?
- What type of biases and blind spots do I need to make sure my students can see in the argument?
- What is the method the author is using to make this point? Is it the right method for the subject?
- Are there any missing steps in the argument?
- Are there any unsupported assumptions?
- Are there any surprising connections to be found in the themes and topics the author broaches?
- Are there any ways that a point made in one part of the text undercuts, supports, or expands a different point made later?
- What can contradictions tell us?
- Why, as a human with limited hours on the planet, is the author writing about *this particular topic*? *Why does she care? What is he afraid of?*

I'm probably forgetting some of the questions I ask myself and you probably have different questions or styles. But I think it's fair to say that most of you spend some amount of time trying to balance specificity with your ability to convey broader stakes of the subject at hand. You assume that you have an interested and smart audience that's willing to go with you in this conversation (why else would they be there?) but might need a little hand holding to see how everything you're discussing hangs together. You probably assume that they have varying degrees of background on the subject and that you'll have to find a way to speak simultaneously to the completely uninitiated without losing them and to the deeply invested without boring them. To do that, you'll keep your specialist language to a minimum and carefully define it when you find that impossible.

That's the same balance you need to write a grant.

Sure, you might have to pitch things a little higher, especially if you're applying to something like the ACLS, where your application will be reviewed by generalists and experts in your field, but next time you're stuck on writing a grant, seriously consider how you would teach your project to very smart undergraduates. (Graduate students are too invested in being seen as "in-the-know" to be a useful imaginary audience.) You spend nearly every day practicing how to balance impact and precision. Use those skills to win some money.

The History of American Philanthropy

[In our last column](#), it seemed like we had finally reached something approaching clarity about how the United States would treat charitable bequests. It's hard to get much clearer than John Marshall's statement in *Trustees of Dartmouth College v. Woodward (1819)* that governments "must be disposed to encourage rather than discountenance" philanthropic gifts, particularly for educational purposes. The courts would do their best to honor donor intentions in order to encourage philanthropy. Well, today, we're going to watch the Supreme Court undermine that sentiment and hand over a small pile of money to disgruntled next-of-kin based on some very important technicalities.

I'm talking about the case [Trustees of Philadelphia Baptist Association vs. Hart's Executors \(1819\)](#). Hart was Silas Hart, who—near as I can tell from internet amateur sleuthing—was born May 5, 1718 in Bucks, Pennsylvania, just north of Philadelphia. He was the son of John Hart Jr. and Eleanor Hart (née Crispin), both of whom were born, raised, and died in Pennsylvania, although both sets of *their* parents had immigrated from England. There are vague hints that Hart's grandmother was related to a rear admiral of the British navy, which suggests some sort of social status, but aside from that, there's not much information on the Hart family aside from the note that Silas Hart was one of eleven children.

At some point Hart moved to Virginia, where he bought his first piece of property in 1748. The year after that he married Jean (or Jane?) Robinson, who died in 1801. It doesn't appear that the pair had children, but the record shows at least three orphan children bound to Silas as servants in 1751 and 1752. Only two of those orphans stayed with Hart, however; the courts ruled the third child's indentured servitude void because he came from the lower parts of Virginia and not, presumably, from England. From there, the records indicate a scattering of inheritances, land acquisition, and increasing social stature as he was elected judge and sheriff. (My favorite little detail comes from the will of one Alexander Matheson, who left "his rifle gun and flowered plush jacket" to someone named William Robertson and the rather less sentimental gift of £6 to Hart. But then, Hart didn't seem like a sentimental man.) The will that really mattered, though, was Hart's own, [which read](#):

"Item, what shall remain of my military certificates at the time of my decease, both principal and interest, I give and bequeath to The Baptist Association, that for ordinary meets at Philadelphia annually, which I allow to be a perpetual fund for the education of youths of the Baptist denomination who shall appear promising for the ministry"

The will was drafted in 1790. On October 29, 1795, Silas Hart died.

The executors of Hart's estate didn't want to give up the money, so naturally enough the Baptist Association sued. Hart's executors countered the lawsuit by claiming that because the Philadelphia Baptist association was not legally incorporated at the time of Hart's death—it was only incorporated in 1797—it couldn't receive the money under Virginia state law. And Virginia law, they concluded, was the only law that mattered because Hart had been a citizen of Virginia at death.

The Baptists, in turn, objected that Virginia state law hadn't actually prohibited citizens from leaving inheritances to unincorporated organizations at the time Hart drafted the will. Up until 1792, Virginia had been operating under the 1601 English law of Charitable Uses, which had no requirements about incorporation. Furthermore, this wasn't simply a Virginia issue; it was an interstate issue, because the Baptist Association was located in Pennsylvania. Therefore, the Supreme Court had the jurisdiction to decide the case and Virginia's laws were irrelevant.

Unfortunately for the Baptists, the Supreme Court ruled in favor of Hart's next-of-kin. They decided that Hart could not leave his money to an unincorporated organization and that the members of the organization couldn't receive it either. From now on, charitable donations could only be left to a legally recognized organization and anything too vague or badly phrased could be thrown out.

Dear Colleague Letter: Request for Information on Future Topics for the NSF Convergence Accelerator

The Convergence Accelerator builds upon NSF investments in fundamental research and discovery to accelerate solutions toward societal impact using a three-tiered approach: topic ideation, followed by convergence research phases 1 and 2. Topics aligned to a specific research focus are called “tracks” and funded teams constitute a cohort. The teams include multiple disciplines, expertise and cross-sector partnerships to stimulate innovative ideas and to develop long-lasting, sustainable solutions to support a variety of societal challenges.

The purpose of this RFI is to seek input from industry, institutions of higher education (IHEs), non-profits, state and local governments, and other interested parties on potential NSF Convergence Accelerator tracks for the next round of funding, anticipated in fiscal year (FY) 2023.

U.S. science no longer leads the world. Here's how top advisers say the nation should respond

"That loss of hegemony raises an important question for U.S. policymakers and the country's research community, according to NSF's oversight body, the National Science Board (NSB). "Since across-the-board leadership in [science and engineering] is no longer a possibility, what then should our goals be?" NSB asks in a policy brief that accompanies this year's Science and Engineering Indicators, NSF's biennial assessment of global research, which was released this week.
