Featured Funders

Columbia University

Let's talk about our neighbor across the street! Columbia is remarkably decentralized and hard to navigate unless you're in the know. The best place to find internal Columbia opportunities is <https://research.columbia.edu/internal-seed-funding>, but even that won't capture everything. Still, it's a very generous funder of faculty projects, so it's worth looking. For today's column I want to offer a roundup of some of the opportunities available. I've tried to pick the opportunities that Barnard faculty have received before, but it's always worth your time to check that you're eligible.

[“The Tamer Fund for Social Ventures](#) provides seed grants of **up to \$25,000** to nonprofit, for-profit, and hybrid early-stage social and environmental ventures...working to solve a social or environmental problem. In general, social and environmental for-profit ventures produce products and/or services that either focus on addressing the needs of low-income communities or customers with an explicit purpose of increasing the welfare of these groups, alleviate a market failure and create significant public goods or benefits that are not wholly captured in the price charged by the business, or have attracted funding for the business by investors or grant makers who are seeking measurable social or environmental impacts.” **Deadline: March 1 or August 15.**

[“The DSI Seed Funds Program](#) supports new collaborations that will lead to longer term and deeper relationships among faculty in different disciplines across campus...We are interested in the application of data science to all domains and bringing ideas from other domains to bear on data science. Aligned with these efforts, we are particularly interested in proposals that address one or more of DSI's focus areas: Business and Finance, Climate, Foundations of Data Science, Health, and Social Justice.” **Deadline: TBA. Funding: Up to \$75k for two years.**

[Data Science and Health Initiative \(DASHI\)](#): “DASHI invites applications for pilot projects in the intersection of Artificial Intelligence (AI) and Health Sciences. A Letter of Intent (LOI) by a single contact -PI without a complete project team is required.” **Deadline: TBA. Funding: up to \$75k.**

“The [Collaboratory Fellows Fund](#) will award grants to pairs of instructors (teams can be larger), one with disciplinary/area expertise and one with data-science/computational expertise, to collaborate on the development and teaching of new material that embeds data or computational science into a more traditional domain. We are also encouraging proposals that suggest the reverse: courses that embed business, policy, cultural, and ethical topics into the context of a data or computer science curriculum.” **Deadline: April 13, 2022.**

[“The Institute for Social and Economic Research and Policy](#) announces an opportunity for one-year research Seed Grant Awards of up to \$35,000. The main goal of this project is to offer social science researchers the chance to undertake major research programs that may require initial results or proof of concept to attract external funding. The ISERP seed grant program places a priority on high-risk, high-return research, including work that develops new theories, identifies new areas of methodological innovation, or that bridges different substantive domains.” **Deadline: TBA.**

[“The Institute for Religion, Culture, and Public Life](#) seeks proposals from Columbia University faculty for Joint Projects that aim to understand the role of religion and secularism, both historically and in the contemporary world. Joint Project funding may be applied to **research projects, seminars, conferences, working groups, and other programs that bring together an interdisciplinary group of scholars.**” **Deadline: March 21, 2022. Funding: Up to \$15,000.**

Sage Advice

Secrets to writing a winning grant

For today's column, I wanted to share a column I ran across from *Nature* called ["Secrets to writing a winning grant,"](#) profiling a few different senior scientists. The article is a few years old but has some helpful advice. Here are some highlights.

On formatting

"Formatting is an important consideration, says Aerin Jacob, a conservation scientist at the Yellowstone to Yukon Conservation Initiative in Canmore, Canada. White space and bold headings can make proposals easier to read, as can illustrations. "Students are tempted and sometimes encouraged to squeeze in as much information as possible, so there are all kinds of tricks to fiddle with the margin size, or to make the font a little bit smaller so that you can squeeze in that one last sentence," Jacob says. 'For a reviewer, that's exhausting to read.'"

Picking your key words

"Ball advises avoiding basic deal-breakers, such as spelling errors, grammatical slips and lengthy proposals that exceed word limits. Those kinds of mistake can cast doubt on how rigorous applicants will be in their research, she says. A list of key words, crucial for indexes and search engines, should be more than an afterthought, Ball adds. On a proposal for a project on promoting physical activity among women, she tagged her proposal with the word 'women'. The descriptor was too broad, and her application ended up with a reviewer whose expertise appeared to be in sociology and gender studies instead of in exercise or nutrition. The grant didn't score well in that round of review."

On science communication training

"Science communication training can be a worthwhile strategy for strengthening grant-writing skills, Stanley says. When she was reviewing pitch letters for a private foundation, she recalls that lots of scientists couldn't fully explain why their work mattered. But when she received pitches that were clear and compelling, she was more willing to help those scientists brainstorm other possible funding agencies if her foundation wasn't the right fit. Scientists who sent strong — albeit unsuccessful — applications were also more likely to get funding from the foundation for later projects.

"To refine project pitches and proposals, Stanley recommends that scientists use a free communication tool from COMPASS called the Message Box Workbook, which can help to identify key points and answer the crucial question for every audience: 'So what?' Scientific conferences often provide symposia or sessions that include funders and offer helpful tips for writing grants. And development officers at institutions can help scientists to connect with funders. 'A good development officer is worth their weight in gold,' Stanley says. 'Make friends with them.'"

Have a clear goal

"A clear focus can help to boost a grant to the top of a reviewer's pile, Ball adds. In one of the first large grants that she applied for, she proposed collecting information on the key factors that prevent weight gain as well as designing and implementing an obesity-intervention programme. In retrospect, it was too much within the grant's two-year time frame. She didn't get the funding, and the feedback she received was that it would have worked better as two separate proposals. 'While it's tempting to want to claim that you can solve these enormous, challenging and complex problems in a single project,' Ball says, 'realistically, that's usually not the case.'"

The History of American Philanthropy

[In our last column](#), we discussed *Trustees of Philadelphia Baptist Association vs. Hart's Executors*, an 1819 decision by the U.S. Supreme Court that a bequest by Silas Hart to the Philadelphia Baptist Association could not stand, because at the time Hart wrote his will, the Philadelphia Baptist Association was not legally incorporated. Since it wasn't legally incorporated, the argument ran, there was no way to tell who, specifically, should receive the money. Should it be the people who belonged to the Baptist Association at the time that Hart wrote his will? At the time he died? At the time that his executors dispersed his money? And what if the group split? It was in essence a ship of Theseus problem—if you replace all the components of the ship one by one (or in this case, members of the association), at what point does the ship become something different altogether? It was all too complicated and too vague, the Supreme Court ruled. Therefore, the bequest defaulted back to the estate's heirs.

This ruling was a big moment in establishing philanthropic law as we know it, where foundations have charters and rules binding their giving, but it's not the only moment that matters. There was also another relevant debate in the courts at the time, in this case regarding the principle of *cy-près*.

Cy-près, or *si près* in modern French, literally means “as close as possible” and is an old legal doctrine that states that when circumstances have rendered a charitable bequest obsolete or impracticable, the court may amend the document or will in question in order to enforce a version of it that is “as close as possible” to the original intention. Imagine someone leaves in her will a fortune to the local church but the church burns down, or someone else leaves a sum in the early twentieth-century for the express purpose of advancing women's suffrage. After a little while, the church is gone and women can vote, so the gift no longer has a purpose, based on a strict reading of the will. What, then, do you do with the remaining money?

One option is to give what remains back to the closest heirs to the estate. That can work but can also prove complicated, especially if the gift was given a long, long time ago and no one is clear who is the proper heir. *Cy-près* is an alternative solution. In that case, you might keep the money, but redirect the funds from the since-destroyed church to another in the parish.

The doctrine was another inheritance from English law and just like [the more famous inheritance of the 1601 Law of Charitable Uses](#), certain parties hated it. Some of the objections stemmed from [the old chauvinistic sense](#) that there was no point in having fought a revolution against the British if Americans were just going to import their laws. More often, though, judges objected to relying on *cy-près* because it was messy and confusing. How *do* you decide what the closest cause is to a donor's original intention?

Take the hypothetical example of the donor who leaves a bequest to support women's suffrage in her will. Is the next closest cause supporting women's suffrage globally or supporting some other equal rights law for women in the U.S. or helping women find time and transportation to reach the polls? They're all plausible and if that's the case, then it's hard to see how charitable funds can ever be gotten out of the system. What is to stop courts from endlessly redirecting funds from defunct gifts and replicating the old problem of pre-Reformation England, where vast tracts of land and wealth were permanently out of reach of private use and public taxes?

I don't mean to overstate the problems with *cy-près*. It still exists as a doctrine today. But the complexities around its application are part of the reason that both federal and state courts leaned in favor of insisting that charitable associations had to be legally recognized entities with charters that spelled out their missions. At least then you didn't have to guess if the donor supported the organization's activities. Charters would have their own complications, as we'll see far down the line when it's time to establish the Rockefeller Foundation.
