## Featured Funders

### Big Changes for the ACLS

For today's Featured Funder column, I want to revisit an organization that we last profiled in [January 2018](#)—the American Council of Learned Societies or the ACLS. Our office recently had the opportunity to hear from [John Paul Christy, the Senior Director of U.S. Programs](#), as part of a meeting put together by CLASP, a professional organization of research administrators at liberal arts colleges. There's a lot to cover, since the ACLS has been undergoing some very interesting changes, so for this issue I am going to skip the usual background information. See Kari's 2018 column for a broader overview.

You may or may not have noticed that when the pandemic struck, the ACLS temporarily changed the eligibility criteria of its [main fellowship program](#), making it so that only early career, untenured scholars who had received their PhD after 2013 could apply. (The 2013 graduation date is, unfortunately, firm; there are no exceptions for people who had to interrupt their careers for family, medical, or other reasons, though Christy assured us that the ACLS was examining that policy.) That policy will remain in place for this year's competition, but is scheduled to expire at the end of the year.

The emphasis on supporting untenured scholars is part of a broader shift in the ACLS's priorities, reflected in its recently-released [strategic plan](#). It's the first strategic plan that the ACLS has ever released, so I would recommend reading it carefully. There aren't a lot of details in there regarding new programs, but you can get a sense of where things are going from this passage:

**Fostering humanistic scholarship of the highest quality means expanding the topics, methods, and forms of writing we humanists value as scholars; increasing the number and types of people we reach; and supporting those most in need. We are especially concerned about PhDs lacking full-time employment; students and faculty at resource-constrained institutions; and scholars of color and first-generation scholars, still too few in every discipline. We will put our energies into working in collaboration with the learned societies, the Research University Consortium, ACLS Associate Universities, and other partners to coordinate the reform and redesign of humanistic studies.**

Naturally, we wanted to know what that meant. Here are some of the key things we learned.

- The ACLS is currently limited to “US citizens, permanent residents, Indigenous individuals residing in the United States through rights associated with the Jay Treaty of 1794, DACA recipients, asylees, refugees, or individuals granted Temporary Protected Status in the United States.” However, the ACLS is reviewing that criteria to consider the possibility of opening up the competition to scholars working in the U.S. on J-1 visas or who maintain foreign citizenship.
- The ACLS is trying to expand its pool of reviewers to increase its diversity. You can now volunteer to review [here](#). I'll devote a future column to why you should consider reviewing, but, suffice to say, it's a great way to get insight into the evaluation process before you apply.
- The ACLS is piloting fellowships that don't require faculty to take a full year or semester off. Currently, that flexibility applies to their program for faculty at community colleges, but there are more general discussion about increasing the flexibility around award time.
- While reluctant to interfere too much with faculty self-governance, the ACLS hopes that by supporting projects where the outcome is something other than a monograph that they can lend legitimacy to non-traditional scholarly projects.

There's more to say, so keep reading to hear what makes a competitive proposal at the ACLS.

## Sage Advice

### Tips on Proposal Writing from the ACLS

In our conversation about the new priorities of the ACLS, Senior Director of U.S. Programs John Paul Christy didn't limit himself to the big picture changes in the ACLS; he also had tips for proposal writing. Here are the key details and suggestions that he covered.

**The review process.** The first thing to understand about the ACLS is that its review process is split into two stages. During the first round, proposals are vetted by experts within an applicant's field. In the second, proposals are reviewed by a panel of interdisciplinary scholars. What does that mean?

- Your proposal has to be formulated in such a way that people outside of your field can understand the broader relevance of what you do to the humanities.
- No jargon.

**The social sciences.** Christy noted that while the ACLS, like the National Endowment for the Humanities, is open to those working in the humanities and "humanistic social sciences," there were a few things for social scientists to keep in mind to increase their chances of success.

- If you decide to list a secondary field in the humanities on your application, be aware that it will be reviewed by someone within that field. So don't say you're conversant in a field if you're not!
- It's not enough to say, "this proposal will contribute to conversations in literature/religious studies/etc." Your bibliography needs to demonstrate that you are reading texts from the humanistic discipline that you mentioned and are actively engaging in conversation with specific issues and thinkers.
- Be sure to look at the abstracts of previous winners in your discipline to get a sense for how they positioned their work.

**Letters of recommendation.** Only one letter is required now. If you are mid-career, it is better for your letter of recommendation to come from someone outside of your institution to show the breadth of your scholarly influence. Though Christy didn't say so explicitly, I imagine there is more leeway on that front for early career scholars.

That said, pick the person who can give the most persuasive accounting of the significance of your work. Reviewers are trained to spot prestige bias, so a thoughtful letter by someone less famous is more helpful than a formulaic letter from a superstar.

**Idea vs. project.** Be sure you are proposing a project, not an idea. An idea is an observation or a conundrum. A project is an idea with a beginning, middle, and end. The ACLS wants to see that you have a specific question, some sense of how you would answer it, and a plan for the form your output will take. **Working around Covid.** This is obviously a dicey moment to be proposing anything. It can feel incredibly hard to write a proposal if you need to travel abroad to archives, conduct ethnographic research, visit an archaeological site, or do anything else that entails traveling. Christy recommended making it clear that you have other activities that you can do during a fellowship year that will further your project, in the event that you can't travel. Are there parts of your project that you could be writing? Archival materials that you can access online? Interviews that you could conduct over Zoom?

These suggestions are specific to the ACLS. I will talk about more general tips in next month's issue.

## The History of American Philanthropy

This issue we're (finally!) on the boat to America, alongside a band of Puritans fleeing the religious crackdown instituted by Charles I, who had started trying to impose religious uniformity on England and Scotland, with predictably disastrous results. His stubborn insistence on trying to dictate the religious rituals of his kingdom ultimately led to a humiliating war with Scotland, which forced him to call back the Parliament he'd been pointedly ignoring for eleven years in order to raise revenue. That, in turn, would set off a cascade of events that eventually ended in Civil War and his execution.

That was all in the future, though. For now it was 1630 and the Puritans were sailing off to an unknown (to them) land. Like every other English colony, they were still subject to [the Charitable Uses Act](#), established under Elizabeth I in 1601. And while none of the colonies had the right to scrap that law and start over, the way each colony interpreted it varied from region to region. Sometimes the interests at play were primarily economic, as in Virginia. For the Puritans of Massachusetts Bay Colony and, later, the Quakers of Pennsylvania, the driving attitude toward charity was primarily religious.

The cleanest distillation of the religious ideology driving the Puritans came in a sermon preached by John Winthrop (1587-1649) to his fellow passengers, called "[A Model of Christian Charity.](#)" You probably already know it, at least by reputation. It's famous for describing the new colony as "a city upon a hill," but it's also a programmatic discussion of what charity should look like in the new settlement. It begins with a bald defense of inequality: "God Almighty in His most holy and wise providence, hath so disposed of the condition of mankind, as in all times some must be rich, some poor, some high and eminent in power and dignity; others mean and in submission." The whole sermon is a justification of God's plan. God creates hierarchies, Winthrop argues, so that each part of society can come together and work for the good of the whole—a type of free market of virtue. Differing social stations give the wealthy person opportunity to practice benevolence and the poor humility. The exchange of charity binds together the wealthy and the poor with ties of brotherly love.

It's that last point that is key to Winthrop's vision; he thinks the ties of charity that bind rich and poor are necessary and inescapable. "Ye are the body of Christ and members of their part. All the parts of this body being thus united are made so contiguous in a special relation as they must needs partake of each other's strength and infirmity; joy and sorrow, weal and woe. If one member suffers, all suffer with it, if one be in honor, all rejoice with it." The natural consequence of this vision for Winthrop is that wealthy people have a duty to care for the poor—at least up to a point. The rich were obligated in fat times to set aside a portion of their excess wealth for the poor. In more desperate times, they are called upon to share all their goods, only stopping short of impoverishing their own family.

If this all sounds a bit defensive, that's because there had been utopian cities built by Christians in recent memory. The most famous case was the Anabaptist migration to the German city of Münster. Persecuted for their belief in adult baptism, among other things, several thousand Anabaptists descended on the city when their leader heard word that it was undergoing a reform movement welcoming to their creed. Münster was the holy city where everyone would be saved when the Apocalypse arrived in Easter of 1534. The Apocalypse never came, of course, but for more than a year the Anabaptists lived under theocratic rule. They banned private property and instituted polygamy. They were under siege for most of that time by a combination of Catholic and Lutheran forces. When they succumbed, their leaders were gruesomely executed and their bodies hung in cages.

Winthrop wanted none of that, which is why I suspect he was so protective of private property. But he did voice a sense that the common good has claims on private property for reasons of survival. In that, he was leagues away from the squabbling of his English forebears about whether a dying man can dispose of his property as he sees fit or if the money belongs to his heirs.

### **Emergency Award: RADx-UP - Social, Ethical, and Behavioral Implications (SEBI) Research on Disparities in COVID-19 Testing among Underserved and Vulnerable Populations**

Deadline: July 8, 2021

“Research proposed in response to this FOA should address social, ethical, behavioral, structural, environmental, historical and policy factors, including structural racism within public health and health care delivery systems, that lead to disparities in access to and uptake of COVID-19 testing in underserved and/or vulnerable populations. Even with the availability of vaccines, testing for the SARS CoV-2 virus will remain a critical aspect of pandemic control. It is also important to understand whether and how the availability of COVID-19 vaccines affects the need for, and propensity to seek testing in both symptomatic and asymptomatic testing programs.
