The Camille and Henry Dreyfus Foundation

There was a moment late in WWI when it seemed like the family fortune behind the Camille and Henry Dreyfus Foundation might buckle. It was 1918 and the brothers had promised the British government an enormous order of acetate lacquer or "aircraft dope," a plastic film they had invented that rendered planes weatherproof. Manufacture had slowed because there was a shortage of raw materials, but anti-Semites in the press didn't care. They began to mutter darkly that the Swiss-born Jewish Dreyfus brothers were secretly pro-German and deliberately sabotaging the war effort. When the war finally ended, military business dried up and the slandered business almost collapsed.

The story has a happy ending, of course. How could the brothers have afforded a foundation, if not?

Camille and Henri Dreyfus were born into a Swiss-Jewish family during a period that was not particularly kind to Jews, especially not Jews <u>named Dreyfus</u>. Camille, the eldest child, was born in 1878. Henri followed four years later. Both brothers pursued PhDs in chemistry; both graduated with high honors. Their earliest work took place in a garden shed in their family's back yard. When they started out, their interests ranged from inventing new indigo dyes, to developing a superior alternative to celluloid for films, seeing as celluloid had an unnerving habit of <u>bursting into flames</u> when a projectionist's lamp grew overheated. Aircraft dope was their most lucrative invention, though. At the time, airplanes still had thick canvas wings that tore and flapped in the wind. The best protective substance of the time was also highly flammable—a distinct disadvantage when being shot at during war. That's how they wound up in Britain, being slandered by an anti-Semitic press.

Camille was in the United States at the time, setting up a factory that would become one of the two main branches of the business. The brothers weathered the slander and the slump in business by transitioning to making more household goods after the war, including paint, lacquer, and a fabric named "Celanese, " an early version of rayon. The switch to textiles brought new challenges, <u>as new dyes needed to be invented for the new fabric</u>, but it also brought new profits. The pair was rich.

Henri Dreyfus died in 1944 and the grieving Camille established the Henri Dreyfus Foundation to honor him. When Camille died in 1956, the foundation was renamed to <u>The Camille and Henry Dreyfus</u> <u>Foundation</u>. Today the foundation supports teaching and research in chemistry through a number of prizes and awards, many of which require nomination from a department or mentor.

"<u>The Dreyfus program for Machine Learning in the Chemical Sciences and Engineering</u>, initiated in 2020, provides funding for innovative projects in any area of Machine Learning (ML) consistent with the Foundation's broad objective to advance the chemical sciences and engineering. The Foundation anticipates that these projects will contribute new fundamental chemical insight and innovation in the field." **Deadline: April 07, 2022. Funding: varies by project.**

"<u>The Henry Dreyfus Teacher-Scholar Awards Program</u> supports the research and teaching careers of talented young faculty in the chemical sciences at undergraduate institutions. Based on institutional nominations, the program provides discretionary funding to faculty at an early stage in their careers. The award is based on accomplishment in scholarly research with undergraduates, as well as a compelling commitment to teaching." **Deadline: TBA. Funding: \$75,000.**

"<u>The Camille and Henry Dreyfus Foundation established the Award for Encouraging Women into</u> <u>Careers in the Chemical Sciences</u> in 1993 to recognize significant accomplishments by individuals who have stimulated or fostered the interest of women in chemistry, promoting their professional development as chemists or chemical engineers." **Deadline: TBA. Award: \$5,000.**

Sage Advice

Write About What Annoys You

A funny thing tends to happen when I'm going back and forth with a faculty member over a draft of a proposal, especially for a new project. He or she will almost always be able to explain the broad strokes of the project—what the subject matter is, why this particular time period or method, why this object or group of people, what interesting themes have emerged from preliminary research—and I'll be nodding along, but hesitantly, feeling like something not quite clicking. We'll keep talking and something will prompt the faculty member to say, "But everyone in my field always talks about x and it really annoys me." Without fail, that is the moment the project snaps into place.

People like to ask academics "what's your intervention?" and in my experience it's almost never helpful. For one, it tends to depress junior scholars and graduate students, who often end up feeling after tunneling through mountains of secondary literature that their interventions are minuscule, but that they don't have the authority in their fields to strike out and do something big and bold that might turn out to be wrong in big and bold ways. For another, it's such a joyless way to approach scholarship—as if you had to approach a senior scholar with hushed voices, place your hand over his, and gently explain that everyone respects and cares for him so very much, but his interpretation of the *Phenomenology of Spirit* by way of philosophy of language is getting out of hand.

The truth is that you need strong feelings to motivate you to write a book or embark on a long scholarly project. Finding something interesting is almost never quite enough. There are loads of things that I find interesting that I will never write about—hysteria, witch hunts, the Second Great Awakening, the Black Death—because I don't have the grumbling voice in the back of my head when reading about them that *someone is getting something wrong*. I don't mean a little wrong about some piddling, pedantic point that you don't really care about in the depths of your night. I mean genuinely annoyed that everyone in your field simply will not stop trying to wedge this particular topic into some preconceived conversation about religion or hegemony or transnationalism or G.W.F. Hegel. Annoyed in that way that makes you want to do ridiculous voices when explaining the different scholarly positions to your best friend from grad school over a beer until you both howl with laughter. Annoyed that you are all gathered around talking about this wonderful, surprising, delightful, deeply weird phenomenon and *they're all missing the best part*.

Of course, I wouldn't recommend barreling in and saying, "I am writing this monograph to correct the staggering fatuities of renowned senior scholar Herr Doktor Steve." I also wouldn't recommend spending your time coming to blows with someone you genuinely hate or think is a dunce. Reading smart people makes you smarter, even when you think that they're wrong, so the more fair and nuanced you can be when representing their position, the sharper your own work will be.

In general, though, you do have emotions about your work other than exhaustion and anxiety, (or at least I hope so). I picked annoyance because it has come up lately, but you could just as easily ask yourself what you love or fear or hope for when you write. Asking yourself what you feel when you think about your work is a good way to hone in on what your project is and why you're doing it. It's also a good way to decide what you don't want to talk about. If a particular side conversation fills you with dread and ennui, why not see if you can footnote it and move on?

The more clearly you can hone in on what moves you to get up and work on a project, the more easily you'll be able to explain it to a funder. And the more you can make a funder care, the more likely they are to fund you. So the next time you find yourself rolling your eyes at a particular scholarly debate, take a note. That sense of irritation might help you write a winning fellowship.

The History of American Philanthropy

From Edward Longshank's thirteenth-century mortmain laws attempting to clamp down on deathbed bequests to the Catholic Church, to Henry VIII's plundering of the monasteries after his break with Catholicism, to that sneaky Prologue to the 1601 Elizabethan Poor Laws that gave a very narrow list of legally recognized charitable causes, the thrust of nearly every English law we've covered in this column has been to prune back charitable donations so they only went where the government wanted. And for a long time the government wanted that money to go anywhere except the Church. It was too powerful, with too much land, and paid far too little in taxes. The situation grew a little more complicated after the Elizabethan Poor Laws officially shuffled responsibility for the poor onto reputable men appointed by local parishes. Still, the threat was always there that an English court might deem a will too vague and therefore invalid. That's what we're talking about today, using the case of the Pennsylvanian Quakers.

Things were altogether different in England's North American colonies. For one, there was no single church to consolidate land and wealth, just a patchwork of different sects. And, to be frank, there simply weren't enough social services in place to be fussy about who was in charge of charity and why. There were no hospitals, no firemen, and no provisions for orphans or widows. Why *would* the government get in the way of charitable bequests, when there was so much need for charity?

So the fact that the Quakers provided most of the philanthropic services in Pennsylvania during its early years suited the colonial government just fine. According to Howard Miller's *The Legal Foundations of American Philanthropy*, Quakers provided all the charitable relief in Philadelphia until 1705 and were so generous that there was little need for governmental aid until the mid 1700s.

The Pennsylvania assembly was understandably eager to keep this state of affairs running and so passed in 1712 a broad act that guaranteed the right of Quakers and unincorporated societies to receive gifts for churches, cemeteries, hospitals, schools and charitable houses. There was a catch, though. The law guaranteed the legality of all prior gifts. Arguing that the law was an act of ex post facto legislation, the Solicitor General in London urged the Queen to strike it down. So she did in 1713.

That didn't stop the Pennsylvania state assembly. In 1715, they did a classic revise and resubmit, lightly altering the text to explain their motivation. "The true reason of this act was to encourage in an infant colony, where there were no endowments, the building of hospitals, churches, and other place for religious worship and charity schools for the education of youth." They insisted the law was non-sectarian and written solely with an eye for the public good. No dice. The Queen struck it down again.

By now, the story is starting to feel a little like that Monty Python sketch in *The Holy Grail*. ("Everyone said I was daft to build a castle on a swamp, but I built in all the same, just to show them. It sank into the swamp. So I built a second one. That sank into the swamp. So I built a third. That burned down, fell over, then sank into the swamp. But the fourth one stayed up.") In this case the third castle did stay up, so to speak. In 1731, the Pennsylvania assembly finally, finally convinced the Crown to pass the law confirming the legality of charitable bequests to the Quakers and unincorporated societies. That really started a trend in Pennsylvania. For the rest of the eighteenth century, the Pennsylvania state legislature continued to make it easier and easier to donate to philanthropy.

Why does this matter? Well, the story of American philanthropy is a regional one, with different attitudes toward preexisting charitable laws. Pennsylvania had a particularly contentious experience with the Crown. Other states, like Virginia, found the Crown's limitations to be helpful in navigating their internal politics. All of these attitudes would have to be reconciled when America finally united.

FROM THE NSF

"NSF PAPPG 22 Updates."

Summary by Mark Godwin.

The 2022 PAPPG becomes effective **October 4**, **2021**. Here are the major changes: 1) Fastlane is being removed as a submission option by December 31, 2022.

2) Biosketch:

•Expanded from 2 to 3 pages. New fillable pdf template available here: <u>https://www.nsf.gov/bfa/dias/policy/</u> <u>biosketch.jsp</u>.

•May use "et al." in the Products section. (This does not apply to the References section of your proposal. You must still list all authors there.)

3) Current and Pending Support

For each entry, you will now be required to complete a section on: 1) Objectives and 2)
Overlap with proposed work.
New template available here: https://www.nsf.gov/bfa/dias/policy/cps.jsp

4) Active Other Support Requirement in RPPR: Must now report the percentage of expenditures spent in foreign countries. This only applies to two budget categories: consulting arrangements with foreign individuals and firsttier subawards – nothing else.

5) Added new type of proposal: Planning. Up to \$100,000 per year for up to two years. Only available in research.gov.

6) Travel proposal certification: For Travel Proposals, AOR must certify that the meeting organizer has a written policy or code-of-conduct addressing harassment.

7) New Career-Life Balance Supplement. May be used:

•"To support additional personnel (e.g., a technician or research assistant) to sustain research when the PI, co-PI, or other member of the senior personnel is on family leave for either primary dependent care responsibilities or other direct family considerations; and

• "To support additional personnel (e.g., a technician or research assistant) to sustain research while a postdoctoral researcher or graduate student being supported by NSF on the award is on family leave for either primary dependent care responsibilities or other direct family considerations."

The US is unfairly targeting Chinese scientists over industrial spying, says report

Innovation, entrepreneurship, promotion, and tenure

"Academic promotion and tenure (P&T) processes that typically prioritize faculty grants and publications can fail to fully assess and value entrepreneurial, innovative endeavors (1) that can produce the kind of societal impacts that universities are increasingly being called on to

provide and that many faculty and students increasingly prioritize (2, 3). A more inclusive assessment of scholarship and creative activity to better recognize and reward innovation and entrepreneurship (I&E) will require "broadening the bar" (4) to reflect evolving forms of faculty impact without diluting or increasing the requirements for advancement. Expanding what we value as scholarship can also help augment who we value as scholars and thus support a more innovative and diverse professoriate. We highlight work by the Promotion and Tenure-Innovation and Entrepreneurship (PTIE) coalition to promote policies and practices to recognize the impact of faculty I&E. We posit that this strategy can be broadly applicable (beyond I&E) to recognize the many and evolving dimensions along which faculty create societal impacts. " <<more>>

Study: Female Scientists Don't Get the Mentions They Deserve

"A new study in Proceedings of the National Academy of Sciences says that science research published by women doesn't get the same traction online as that published by male scientists. Across 13 broad research areas, researchers found that women account for just 29 percent of scholars whose work is mentioned on social media and that female scientists are less likely to be among the top 25 percent of the most successful scholars in terms of social media mentions. Top-line findings concern online data from 2012. The gender gap closed somewhat five years later, but not by much." <<more>

"National Endowment for the Humanities Post-Doctoral Fellowships support research in residence at the Library Company on any subject relevant to its collections, which are capable of supporting research in a variety of fields and disciplines relating to the history of America and the Atlantic world form the 17th through the 19th centuries.... NEH fellowships are tenable for four to nine months. The stipend is \$5,000 per month."

The Jefferson Monticello Short Term Fellowships

Deadline: November 1, 2021

"Short-term fellowships are awarded for one or more months, and open to academics from any country, subject to selection by committee. Successful applicants will be working on Jeffersonrelated projects. Priority is given to Jeffersonrelated projects using the Digital Archeological Archive of Comparative Slavery or Getting Word. Fellows are expected to be in residence at the Robert H. Smith International Center for Jefferson Studies (ICJS), where they will have access to Monticello's expert staff and research holdings at the Jefferson Library as well as those of the University of Virginia. During their residencies, fellows hold a 45 minute forum on their research projects." <<more>

School for Advanced Research Resident Scholar Fellowship

<u>Deadline:</u> November 1, 2021 (or Apr 1, 2021) "Resident scholar fellowships are awarded annually by the School for Advanced Research (SAR) to up to six scholars who have completed their research and who need time to prepare manuscripts or dissertations on topics important to the understanding of humankind. Resident scholars may approach their research from the perspective of anthropology or from related fields such as history and sociology. Scholars from the humanities and social sciences are encouraged to apply." <<more>

Society for Classical Studies Thesaurus Linguae Latinae Fellowship

Deadline: November 12, 2021

"The Society for Classical Studies invites applications for a one-year Fellowship, tenable from July 2021 through June 2022, will allow an American scholar to conduct lexicographical research at the Thesaurus Linguae Latinae (TLL) Institute in Munich. Fellows at the TLL develop a broadened perspective of the range and complexity of the Latin language and culture from the classical period through the early Middle Ages, contribute signed articles to the Thesaurus, have the opportunity to participate in a collaborative international research project in a collegial environment, and work with senior scholars in the field of Latin lexicography." <<more>

American Institute of Indian Studies Research & Senior Scholarly/Professional Development Fellowships

Deadline: November 15, 2021

"Senior Research Fellowships are available to scholars with a PhD or its equivalent. These grants are designed to enable scholars who specialize in South Asia to pursue further research in India and to establish formal affiliation with an Indian institution. Short-term awards are available for up to four months. Long-term awards are available for six to nine months. A limited number of humanists will be granted fellowships paid in dollars funded by the National Endowment for the Humanities." <<more>>

The Huntington Library Fellowships

Deadline: November 15, 2021

"The Huntington Library awards over 150 research fellowships annually. Recipients of all fellowships are expected to be in continuous residence at The Huntington and to participate in, and make a contribution to, its intellectual life." <<more>>

NYU Institute for the Study of the Ancient World Visiting Scholar Research Program

Deadline: November 20, 2021

"Institute for the Study of the Ancient World (ISAW) is a center for advanced scholarly research and graduate education, which aims to encourage particularly the study of the economic, religious, political and cultural connections between ancient civilizations. In an effort to embrace a truly inclusive geographical scope while maintaining continuity and coherence, the Institute focuses on the shared and overlapping periods in the development of cultures and civilizations around the Mediterranean basin, and across central Asia to the Pacific Ocean. The approaches of anthropology, archaeology, geography, geology, history, economics, sociology, art history, digital humanities, and the history of science and technology are as integral to the enterprise as the study of texts, philosophy, and the analysis of artifacts." <<more>>

The Gerda Henkel Foundation General Research Grants
