Featured Funders

Institute for Citizens and Scholars (Formerly the Woodrow Wilson Foundation)

[The last time](#) we talked about the [Institute for Citizens and Scholars](#), it was called the Woodrow Wilson Foundation. It has been a year since it announced its new name in the wake of a racial reckoning, so it seemed like a good time to revisit the organization and see how its priorities have changed.

The Institute began once upon a time, in a faraway land called New Jersey, where there were not enough professors. (I'm sorry, I can't explain this origin story in any other way.) It was 1945, the G.I. Bill had just been passed when a Classics professor named Dr. Whitney "Mike" Oakes at Princeton realized there was about to be a drastic shortage of professors. So he started a batch of fellowships named after Woodrow Wilson, Princeton's most (in)famous president, to encourage G.I.s to enter college teaching. Other organizations quickly recognized the need for the program and with some help from the Ford Foundation, the Woodrow Wilson Fellowships quickly became an independent organization. From the 1970s-1990s, the Woodrow Wilson Institute focused its attention on building bridges between colleges and K-12, as well as promoting humanities in the public sphere. When the early 2000s arrived, the Foundation redoubled its interest in improving K-12 education. [And in 2020](#), when the organization confronted Wilson's racist legacy, it changed its name and "expanded its mission to include broadening civic engagement, supporting civil discourse, and reemphasizing excellence, opportunity, and diversity in higher education."

Today, the Institute for Citizens and Scholars offers several different faculty awards, in addition to Dissertation Fellowships.

"The Junior Faculty [Career Enhancement Fellowship](#) seeks to increase the presence of minority junior faculty members and other faculty members committed to eradicating racial disparities in core fields in the arts and humanities." **Funding:** \$30,000 with \$1,500 for travel. **Deadline:** TBA, previously October 22, 2021.

"[The Adjunct Faculty Fellowship](#) provides each Fellow with a six-month period during which to focus on the research and scholarship necessary to secure a tenure-track position. Two fellowships are awarded each year." **Funding:** \$10,000. **Deadline:** TBA, Previously November 5, 2021.

"[The Mellon Emerging Faculty Leaders Award](#) supports tenure-track faculty who have passed their midpoint review. The award is structured to free the time of junior faculty who have passed their midpoint tenure review—including those from underrepresented groups and others committed to eradicating disparities in their fields—so that they can both engage in and build support systems, networks, and affinity groups that make their fields and campuses more inclusive. Eligible applicants must have passed their third-year review or their institution's equivalent." **Funding:** \$17,500 stipend—\$10,000 to be used for summer research support and \$7,500 for research assistance during the academic year. **Deadline:** TBA. Previously December 1, 2021.

This last opportunity isn't strictly for funding, but might be of interest to any readers out there who has benefited from Mellon Mays Undergraduate Fellows. The Institute advertises a program for [The Mellon Mays Gap Assistance Program \(Mellon Mays GAP\)](#), which "helps Mellon Mays Fellows who have recently graduated maintain their graduate school ambitions and progress towards an academic career."

Sage Advice

How to Structure Your Budget Justification

The budget justification can be one of the more mysterious documents if you're new to grant writing. After all, presumably you've explained in the proposal what you're doing and why, while your budget gives the details of how much you're spending on any given category, so what, exactly, does a written description of your budget lines accomplish? And how do you write a good one?

The short answer to the first question is that a budget justification is all part of your campaign [to make your budget look credible](#). You want to prove to your funder that you've thought about your project, have a good sense of what the components are, roughly how much they will cost, and—crucially—where you are getting that number from. It's a way of showing that you're a sensible, trustworthy person who won't blow their money on top-shelf bourbon for your conferences or come back six months later because you forgot to include health insurance when budgeting for a postdoc.

As for the question of what makes a good budget justification, we recently ran across an article on exactly that topic on the [Blog of the Division of Integrative Organismal Systems \(IOS\) at the National Science Foundation](#). The article, titled "How to structure your budget justification to assure the project budget is well justified," is written with NSF applications in mind, but a lot of their tips apply to any grant. Check out some of the highlight below!

"1) It is helpful to use the exact terminology that appears on the budget form and to discuss the items in the order they appear on the form. For instance, you can allocate expenditures in categories A. Senior Personnel, B. Other Personnel, C. Fringe Benefits, D. Equipment, E. Travel, F. Participant Support Costs, and G. Other Direct Costs. In your budget justification, you would then use these categories **exactly as designated** in the budget form as headers to describe each expenditure. If no funds are requested within a category, you would leave that category/header out of the budget justification. Please note that it is important to always use headers as designated in the budget form for maximum clarity. This is even more important when you begin to detail the subcategories within each larger category, for example, when describing G. Other Direct Costs, which includes 1. Materials and supplies, 2. Publication costs, etc.

"2) Provide enough information about the roles of the personnel that are being supported on the project to justify their time commitment, and therefore the salary support, being requested."

"3) Provide enough details to justify larger budget numbers so that a reader can understand what those funds will cover and how you arrived at the total. Take this approach throughout the budget, especially when justifying requests for funds in categories such as E. Travel or G. 1. Materials and Supplies where allocations often sum to a large dollar amount. Here is where it is important to provide enough detail so that the reader and NSF understand the rationale for the expenditures.

"As an example, suppose you are requesting funds for lab supplies and the justification for G.1. Materials and Supplies reads, 'Lab Supplies: \$10,000'. A more informative budget justification would read 'Total Lab Supplies \$10,000, including Animal husbandry supplies (food, tank cleaning, environmental enrichment): \$3,000, Experimental aquaria (10 x \$500 each): \$5,000, Reagents and disposables for hormone assays: \$2,000'."

The History of American Philanthropy

[When we last left off](#), the United States had finally won independence from Britain and was faced with a conundrum: What laws should the new country use? The colonies had been operating under British common law, but wasn't it a bit counterproductive to go through all of the effort of a war, just to keep the same old legal system from the aristocratic Old World? Wasn't the whole point to break from that ossified culture and embrace what made the country distinctively new? But on the other hand, what should the new laws be? And what legal system should you use while you were sorting that out?

For the most part, the states sorted out the issue of inheritance and charity in the early years of the country, but occasionally the states conflicted or residents objected to state law. Now, you might find yourself thinking, "This sounds like the sort of problem the Supreme Court is supposed to sort out." And I agree! It *does* sound like the sort of thing the Supreme Court should settle. Only, a lot of their early cases only made the status of inheritance law even less clear.

Take the 1819 case, [Dartmouth College vs. Woodward](#). Dartmouth College was founded in 1769 by [Eleazar Wheelock](#) (1711-1779). Wheelock was part of that long, American tradition of colonialism mixed with proselytizing that [we saw in the early years of Harvard](#). Before moving to New Hampshire to found Dartmouth, he had launched and ran Moors Charity School in Connecticut to educate Native Americans. The school was inspired by his early experience teaching [Samson Occom](#), a Mohegan boy who had converted to Christianity. Occom became a missionary after studying for four years with Wheelock and Wheelock hoped to train other Native American boys to do the same. Few of his students fulfilled his hopes. Some grew homesick, some sickened, and some died.

Undaunted, Wheelock decided to raise money for the school and soon received a number of donations from wealthy English philanthropists, as well as a charter from King George III. Money in hand, he decided to start a second branch of the school, this time with classes for American colonists, and settled on a new location in Hanover, New Hampshire. The wealthy donors back in England howled. Wheelock coolly kept the money and named the college after the head of the Board of Trustees placed in charge of the school—Lord Dartmouth.

Eleazar Wheelock was succeeded by his son, [John Wheelock \(1754-1817\)](#), and that's who ultimately triggered the chain of events that ended in a Supreme Court case. Wheelock was neither an academic, nor a minister, but he steered Dartmouth through its early years capably enough. He oversaw the construction of Dartmouth Hall and founded the medical school. He even kept the college solvent throughout the Revolutionary War. In his later years, though, he began to squabble with the Dartmouth's Board of Trustees. Eventually the fighting grew heated enough that Wheelock convinced the governor of New Hampshire to turn Dartmouth College into a secular state school, Dartmouth University, and replace the previous board with supporters of Wheelock. The new board promptly elected Wheelock president. The old board sued—not Wheelock, but William Woodward, the treasurer of the college who had taken the college's charter, records, and seal to the new established university.

That's the lawsuit that made it to the Supreme Court, which ultimately ruled in favor of the original board. Dartmouth's original charter had been a contract. By replacing the board and changing the mission, New Hampshire had violated that contract. Just as importantly, the Court ruled, generations of donors had given to the college in hopes that the institution would exist in perpetuity. If the state had the power to seize a philanthropic entity and change its stated purpose, individuals wouldn't have much incentive to donate to good causes. It was an important moment in the creation of U.S. charity law because it definitively established certain protections for philanthropic organizations—or at least the formally incorporated ones.

Tool protects users' private data while they browse

“Computer scientists funded by the [U.S. National Science Foundation](#) and affiliated with the [University of California San Diego](#) and Brave Software have developed a tool that will increase protections for users' private data while they browse the web.

“The tool, named SugarCoat, targets scripts that harm users' privacy -- for example, by tracking their browsing history around the web -- yet are essential for the websites that embed them to function. SugarCoat replaces these scripts with others that have the same properties, minus the privacy-harming features. SugarCoat is designed to be integrated into existing privacy-focused browsers like Brave, Firefox and Tor as well as browser extensions like uBlock Origin. SugarCoat is open source and is currently being integrated into the Brave browser.” [<<more>>](#)

Long-Term Trends in the Age of Principal Investigators Supported for the First Time on NIH R01-Equivalent Awards

The [R01](#) (or [R01-equivalent](#)) grant has traditionally been a critical component to the launch of one's research career. A number of academic leaders have described and expressed concerns about the age at which scientists are first supported on an R01 award ("age at first R01"). The biomedical [research workforce is aging over the past several decades](#) due to demographic trends and the end of mandatory retirement in academia. [Difficulties faced by early-career investigators](#) may include prolonged training, advantages of incumbency, and cost-shifting to universities.

Few foundations give groups they support decision-making power on funding priorities

"Eighty-three percent of large U.S. [foundations seek input](#) from some of the nonprofits they fund – along with other people, organizations or communities directly affected by [their funding](#). But foundations, which aim to serve the public interest through the money they give away, rarely give [these stakeholders](#) decision-making authority – by either letting them help set priorities or giving them a say about where grant money flows. That is what philanthropy scholars [Kelly Husted, David Suarez](#) and I found in [a study that assessed the practices](#) of the 500 largest U.S. foundations. Our findings suggest that foundations, which face mounting pressure to direct more [grants to underserved communities](#) as part of the widespread [reckoning on race](#) underway in America, have incorporated some stakeholder outreach into their work."
