## Featured Funders

### The Burroughs Wellcome Fund

The origin of today's Featured Funder, the [Burroughs Wellcome Fund](#), is the story of two American men who struck it big in London peddling pharmaceuticals. The first, [Silas Mainville Burroughs](#), was born in 1846 to a New York State Congressman. Both of his parents died when he was young, leaving him in the care of his aunt and uncle. Burroughs began his career working drugstores, then moved on to working as a pharmaceutical salesman. He eventually went to pharmaceutical school, moved to London as a representative of a pharmaceutical firm. In 1878, he founded Burroughs & Co, which would be renamed Burroughs Wellcome after his friend Henry Wellcome came on board as a partner.

[Henry Wellcome](#) was slightly younger than Burroughs, having been born to a missionary couple who traveled the American Midwest in a covered wagon, preaching the good news of the Second Adventist Church. (I say "Second" Adventist Church, because the First ran into trouble when the prophesied end of days failed to come in 1844 in "[The Great Disappointment](#).") Wellcome went to pharmaceutical school in 1877 and soon had a successful career marketing pharmaceuticals. By all accounts he was a brilliant salesman, knowledgeable and gifted with a knack for marketing (and in possession of a [glorious mustache](#)). In 1880 he joined forces with Burroughs to start Burroughs Wellcome & LTD.

The company came along at exactly the right moment, when drugs were becoming scientifically formulated and standardized into doses. The pair soon brought innovations to the industry, such as forming medicine into pills, rather than powders, and directly marketing to doctors. Burroughs worked phenomenally hard in sales, spending three years of his life touring the globe to promote their wares. He was also a Christian Socialist and a generous employer, supporting eight-hour work days, profit sharing, along with other radical causes, such as Irish Home Rule and world peace.

Silas Burroughs died young at 48 and Henry Wellcome bought out the company. Wellcome went on to live until 1936. His business exploded, expanding to multiple continents and becoming a financial behemoth. Unfortunately, his life also exploded, in much less pleasant ways. In 1901, the 48-year-old Wellcome met and married 22-year-old Gwendoline Maud Syrie Barnardo. The marriage was an unhappy one. Eventually they separated and Syrie Wellcome became pregnant by the wealthy novelist Somerset Maugham. Wellcome sued for a divorce, and Syrie Maugham went on to become a successful interior designer known for her all-white rooms.

Wellcome died of pneumonia in 1936 and left his entire estate to trustees charged with spending it "to improve human and animal health." His bequest eventually became the Burroughs Wellcome Fund, which is today one of the largest funders of biomedical research. Grants include:

[Climate Change and Human Health Seed Grants](#): "Small grants to promote the growth of new connections between scholars, practitioners, educators, and/or communicators working to understand, spread the word about, and mitigate the impacts of climate change on human health." **Funding: \$2,500-50,000. Deadline: Oct. 13, 2022.**

"[The Investigators in the Pathogenesis of Infectious Disease \(PATH\)](#) program provides opportunities for assistant professors to bring multidisciplinary approaches to the study of human infectious disease." **Funding: \$500k. Deadline: TBA.**

## Sage Advice

### **The Lion in the Room (i.e. So you received a grant from Columbia. What next?)**

[A few issues ago](#), we discussed some of the many opportunities available for Barnard faculty available from our neighbor next door, Columbia. They're a great and generous funder of our faculty, offering money for pedagogical experiments, conferences, and even our recent exhibition on the history of redlining in Morningside Heights. The relationship between Barnard and Columbia can get complicated, though. For our purposes, though, you only have to understand one point: **Barnard and Columbia are financially separate institutions.**

What does that practically mean?

Mostly, that Columbia can't just send you the money; Barnard's Finance department needs to invoice Columbia for the money. And that means that Finance needs to know what account or GL (General Ledger) string within Barnard to send the money to.

You might just think, "Great, I'll tell Finance to put it in my research account and call it a day." Unfortunately, you can't do this if Columbia is giving you money for a particular project or event. Why?

When you get a grant from any outside funder, Columbia included, Barnard needs to be able to show that funder the money was used for its intended purposes. That means we need a paper trail, documenting what every purchase was for, that it was in scope of the grant, and that the money was actually spent. The cleanest way to do this is to have a separate account that you can dedicate to a particular project. It gets too messy if you have to disentangle the funds for this conference from an unrelated plane ticket to a conference because they're all jumbled together in your research account. It's much easier to see all the expenditures and balances at a glance—both for Finance and for you.

Fortunately, creating an account for a Columbia grant is the same process as creating an account for any other grant. Email [me](#), CCing our new postaward expert, [Victoria Toro](#), and I'll loop in the appropriate people in Finance. I'll ask you for an award letter (an email from Columbia is fine) and a budget, if you have one. Then I'll send you a New Account Form for you to sign. Once I have that, Finance can set up the account, tell you the GL for reference, and invoice Columbia.

Hopefully the money comes quickly; with any funder, there can be hiccups. Once it arrives, it will be booked by Finance or Development, depending on the details of the grant (don't worry about it), and we'll let you know when it has arrived.

That's mostly it. There are a few things to watch out for, though.

Not everyone at Columbia knows this process, especially if you're receiving money from a Center that's not used to dealing with Barnard faculty. You might have an administrator at Columbia ask you for your department's chart string. That's a sure sign that they're thinking of Barnard as a department within Columbia. It won't work. Loop us in and we'll sort it out.

That brings me to my second point: Columbia is incredibly decentralized. Mostly, you'll just be dealing with the Center or Department that is awarding you the money, which is mostly fine but does mean that there's not really a way to run things up the chain if you run into problems. Again, loop us in.

The final point is that even if you get money multiple times from the same Center within Columbia, you need a new account every time it's a new project. This is about reporting and keeping records clean. It's not any different from getting multiple awards from Russell Sage. New awards need new accounts.

Don't be shy if you have any questions or if you run into any problems. We're here to help!

## The History of American Philanthropy

[Last issue](#), I spent some time talking about nineteenth-century charitable practices within the American-Jewish community as an example of the community-based charities so loathed by [Gilded Age reformers](#), who thought the patchwork of charitable services provided by religious organizations, immigrant communities, and neighborhood groups was unscientific, unsystematic, and prone to abuse. I want to spend a few more issues fleshing out who these communities were and what they did before we get to the Russell Sages and the Rockefellers of the philanthropic world. So today, let's talk about some of the details of the early Chinese American charitable landscape, using a 2020 book chapter by Yong Chen called "Chinese Charity in Early Chinese American History" in an edited volume called [Chinese Diaspora Charity and the Cantonese Pacific, 1850–1949](#).

Chen starts his chapter by stressing the national character of early Chinese American charity, but to my mind the national character of Chinese-American philanthropy is much less interesting than its *international* character and the way money flowed back and forth between China and America. Sometimes that flow of money blurred the lines between philanthropy and investment. Chen tells the story of émigré investment in a railroad in [Xinning \(later renamed Taishan\)](#), a mountainous, isolated region in the Pearl River Delta. Huge numbers of Chinese people, often men, emigrated from Xinning to the United States and by the 1870s they were the single largest group of Chinese immigrants in the United States. The diaspora community was faithful to Xinning and in time money sent back to the region became one of its primary sources of income. So in 1905, after the United States community learned that the Chinese government had scrapped plans to build a railroad in the region, they held a fundraising campaign to pay for the railroad themselves.

A sixty-year-old man, [Chen Yixi](#), was the most important investor. He had come to the United States at 15 and worked his way from day laborer to a successful merchant in the Seattle Chinese community. Unfortunately the railroad flailed, costing more and more money, until he was forced to move back to Xinning and died nearly penniless. Yet while he might have died penniless, the article stresses, he died a respected member of the community in a way that would have been impossible in racist America.

Money didn't solely flow back to China, though; there were plenty of local organizations, especially in San Francisco, called "*huiguan*" that functioned essentially as mutual aid societies. Everyone in the local community was involved through voluntary donations and less voluntary fees. Huiguans did all the usual things you might expect, like caring for widows and fundraising for hospitals, but they also devoted some of their money to shipping the dead back to China for burial.

This was a complicated task that American authorities were ambivalent about. Often, communities would bury their dead in local plots, then exhume their bodies to send the bones back to China in large batches when they found a willing ship. Sometimes American authorities charged extra for shipping bones across the ocean; sometimes, when they wanted the real estate where Chinese burial grounds were located, they would pay the community to exhume bodies, up to \$10 per corpse.

The American government wasn't the only authority interested in the Chinese expat community. In the 1880s, the Chinese General Consul purchased land outside of San Francisco's Chinatown for a hospital but was overruled by the city when American officials learned that the hospital would only provide Chinese medicine. The Consul eventually aborted the plan and opened a hospital in a new location, raising funds from Chinese community members and a small number of white San Franciscans. It's not quite clear how they settled the issue of Chinese vs. American medicine, but in 1900 the Tung Wah Hospital in San Francisco finally opened.

It was hardly the decentralized landscape that the "scientific philanthropists" fretted about—but, then, cultural nuance wasn't always the strong point of nineteenth-century social sciences.

### More Early-Stage Investigators Supported in FY 2021

“Last summer, we [reported](#) that in fiscal year (FY) 2020 NIH supported 1,412 [early-stage investigators \(ESIs\)](#) as first-time Principal Investigators (PIs) on R01-equivalent awards. This all-time high was seen after several years of steady growth in the number of ESIs supported since implementing [NIH’s Next Generation Researchers Initiative \(NGRI\)](#) five years ago. Today, we take a look specifically at how ESIs and other targeted groups fared last fiscal year. For more historical NGRI-related data as well as how the various career stage groups and applicants/awardees are defined, please refer to [our earlier post](#).

In FY21, NIH supported 1,513 new ESIs as first-time PIs on R01-equivalent awards. This new all-time high level of support for ESIs represents a 7.2% increase over FY 2020. As there were 5,410 total applicants, this represents a funding rate of 28.0%.” [<<more>>](#)

#### NSF grant decisions reflect systemic racism, study argues

The ERC PoC Grants aim at maximising the value of the excellent research that the ERC funds, by funding further work (i.e. activities which were not scheduled to be funded by the original ERC frontier research grant) to verify the innovation potential of ideas arising from ERC funded projects.

We look for work that appeals to an informed general audience, gives evidence of high standards in editing, design, and production, and promises a reasonable shelf



life. The grants, ranging roughly from \$1,500 to a maximum of \$15,000, are awarded twice annually with application deadlines of March 1 and September 1. Funds apply to such specific publication components as writing, research, editing, indexing, design, illustration, photography, and printing and binding.

Book projects to which a university press, nonprofit or trade publisher is already committed and for which there is a feasible distribution plan are usually preferred. Recipients of Furthermore grants are located throughout the U.S. and abroad but mainly in New York City and New York State and its Hudson Valley." [<<link>>](#)
