Featured Funders

The Robert Wood Johnson Foundation

Robert Wood Johnson II, the founder of The Robert Wood Johnson Foundation, was born in 1893 in New Brunswick to Robert Wood Johnson I and Evangeline Brewster Armstrong Johnson. His father, Robert Wood Johnson I, was one of the three brothers who had founded Johnson & Johnson of Band-Aid and baby powder fame. He was also by all account the dominant Johnson brother in the business, owning half the shares and leading the business.

Robert Wood Johnson II, *our* Johnson, seems to have known from an early age that he would inherit the family business. He went to a prestigious prep school in New Brunswick but soon dropped out to work his way through the business, spending time in every department, like the hero of an Ayn Rand fairytale. In 1918, he became Vice President of Johnson & Johnson and then in 1932 he was elected president. The Foundation's website insists that it was Robert Wood Johnson II who brought Johnson & Johnson to international fame and while that may well be true other reports I have seen estimated the value of the company at \$60 million at the point of the elder Johnson's death. Whatever the truth, RWJII and the company thrived, especially during WWII, when RWJII was placed in charge of the government agency responsible for giving out manufacturing contracts to smaller companies and given the rank of brigadier general. His success in wartime government was mixed, though; smaller companies complained that they weren't receiving sufficient contracts and as the war drew to a close, Johnson insisted on overriding specific military requests and substituting cheaper alternatives that could be made more quickly, explaining that his business experience gave him unique insight into the needs of production. Eventually, his conflict with the military came to a head and he was forced to resign "for health reasons."

His philanthropy was more successful. He first became interested in philanthropy during the Great Depression, when he saw the need for helping local workers and gave the equivalent of \$5 million to the Johnson New Brunswick Foundation. After the war, he returned to the foundation, renaming it the Robert Wood Johnson Foundation and transforming it into the national source of public health funding that it remains today. The foundation offers policy and research grants, including the following:

["Evidence for Action: Innovative Research to Advance Racial Equity"](#) prioritizes research to evaluate specific interventions (e.g., policies, programs, practices) that have the potential to counteract the harms of structural and systemic racism and improve health, well-being, and equity outcomes ... This funding is focused on studies about upstream causes of health inequities, such as the systems, structures, laws, policies, norms, and practices that determine the distribution of resources and opportunities." **Funding: varies. Deadline: rolling.**

["Pioneering Ideas: Exploring the Future to Build a Culture of Health"](#) seeks proposals that ... address any of these four areas of focus: Future of Evidence; Future of Social Interaction; Future of Food; Future of Work... We want to hear from scientists, anthropologists, artists, urban planners, community leaders— anyone, anywhere who has a new or unconventional idea that could alter the trajectory of health, and improve health equity and well-being for generations." **Funding: average \$300k. Deadline: rolling.**

["Policies to Build and Sustain Economic Security and Wealth for Families and Communities of Color:"](#) The goal of this P4A call for proposals is to build the evidence base investigating how national, state, local, or private-sector policies and practices can reduce growing levels of racial inequality in wealth, and significantly improve the financial wellbeing and economic security of families and communities that have been systematically subject to disinvestment, and therefore are unable to enjoy a fair and just opportunity to be healthy." **Funding: \$30k-450k. Deadline (LOI): September 7, 2022.**

The Guggenheim Career Narrative

Every year, September rolls around and one or two faculty members come to us ready to try for the big one—[The Guggenheim](#). And that's great! Barnard has had plenty of winners and will have plenty in the future. You should absolutely apply for it, as many times as it takes. In some respects, the Guggenheim is like any other fellowship you might apply for. There's a three-page statement of plans, where you detail the project you want to work on during your fellowship year ([single-spaced is fine; no need to worry about a budget unless you advance to the next round](#)), there's a comprehensive list of your works, and there are work samples that you'll be asked to submit at a later date.

There's also the Career Narrative, though, and that is the application component that tends to trip people up. [Here's what the website tells you](#):

The Career Narrative is a brief prose account of your career, describing your previous accomplishments. Please do not substitute a resume. It should mention prizes, honors, and significant grants or fellowships that you have held or now hold, showing the grantor and the inclusive dates of each award. There is no page limit for the career narrative; however, most are no more than three to four pages in length.

Reading that description, you'd be excused for thinking that they want a CV in sentence form, but from everything we've heard and read, that's not true. A Career Narrative is exactly what it sounds like—it's a narrative, meant to shape your intellectual trajectory into a coherent story and, ideally, set up your proposed project as an interesting and logical next step in your career.

But don't take my word! A year or so ago, some colleagues at other liberal arts colleges put together a panel of Guggenheim winners. I would recommend watching the whole recording, which you can see [here](#), but in the meantime here are some tips from the winners.

1. Use the narrative as a chance to make sense of your career. If there are moments when your interests swerve in ways that seem confusing to outsiders, the narrative is a chance to contextualize those moves.
2. Relatedly, try to tie your career back to some big picture themes and interests. What are the questions that moved you to enter the field? What keeps you going back to it? What drove you to the field as an undergraduate?
3. Don't be shy about being personal or autobiographical.
4. Don't apologize for your work, especially if you're writing about or from marginalized communities.
5. Think of your narrative and your project proposal as two documents that work together to tell a cohesive story. Your project should feel like a satisfying next step to the reader.
6. Try making your narrative an interesting story. The readers have to review a ton of these, so make it vivid. Grant writing and good writing don't have to be two separate things!

If this sounds a little grandiose or abstract, don't worry—there's room for detail in the project proposal. Check out our old column on [“How to Make Your Fellowship Application More Concrete”](#) for suggestions on that front.

All that said, the Guggenheim is still a mystery. There were plenty of topics the panelists disagreed on. Is it more important to have your proposed project mark a novel turn in your career? Does it help to have Guggenheim winners serve as letter writers? Your colleagues will doubtless have their own Guggenheim lore, so don't be shy about pumping them for information (and please pass on any helpful tips to us!).

The History of American Philanthropy

If you go to the town of Midleton in County Cork, Ireland, there's a 20-foot high gleaming metal statue of feathers in a local park. The statue is called "[Kindred Spirits](#)" and was erected in 2017 to commemorate a gift of several hundred dollars that the townspeople received in 1847 from the Choctaw, at the height of the Irish Potato Famine. I want to use this story to pick up on the discussion of international charity that we started [last issue with our discussion of Chinese-American philanthropy](#).

1847 was an unlikely year for the Cherokee and Choctaw to be engaging in acts of international charity. In 1830, President Andrew Jackson signed "[The Indian Removal Act](#)," which granted the president the right to offer native tribes settled in existing states land west of the Mississippi in exchange for their homelands. Of course many of the communities didn't want to go, and in fact had good legal claims to stay, even on the U.S. government's own terms, having signed treaties a handful of years before giving them right to their lands, often in exchange for huge concessions. None of that mattered. From the 1830s-1850s, the U.S. government systematically hunted down Cherokee, Choctaw, Muscogee, Chickasaw, and Seminole, torching their homes and driving them out with what they could carry.

Conditions were brutal. Thousands died and starvation was widespread among those who survived the journey and the Cherokee, in particular, were riven with internal conflict afterwards, with some factions of the tribe bitterly blaming a small minority that had signed the [Treaty of New Echota](#) in 1835, agreeing to cede Cherokee land in the Southeast. But there was also remarkable resilience. Relatively quickly after arriving, Cherokee and Choctaw newspapers began springing up. In 1844, the Cherokee Nation government founded *the Cherokee Advocate*, a newspaper with the dual aim of building on the robust pre-existing Cherokee print culture and bringing news of the Cherokee to outside readers, while in 1848, missionaries founded The Choctaw Telegraph. Both newspapers, along with outside periodicals regularly brought in news from abroad, including the spreading famine in Ireland and Europe.

So in 1847, when United States Lieutenant Colonel Loomis stood in front of a crowd of Cherokee, missionaries, citizens, and soldiers, and invited a visitor to read an account of the Irish famine, he was talking to a crowd that had been hearing of the disaster for quite a while. Those gathered responded generously, as did later groups of Cherokee and Choctaw people, raising as much as \$800.

A number of white, Christian newspapers responded to the story with a mixture of condescension and delight, with one beaming that the tribes "are repaying the Christian world a consideration for bringing them out from benighted ignorance and heathen barbarism. Not only by contributing a few dollars but by affording evidence that the labours of the Christian missionary have not been in vain."

Cherokee and Choctaw representatives pushed back against this narrative, even at the time. John Ross, Principal Chief of the Cherokee at the time, attributed the gift in a speech to a culture of charity combined with the means at that moment to relieve the destitute in other countries. A 2015 article titled "[A 'Voice of Benevolence from the Western Wilderness': The Politics of Native Philanthropy in the Trans-Mississippi West](#)" by Anelise Hanson Shrou, argues that the situation was even more complicated than that. After all, she points out, there were plenty of other suffering countries. John Ross even implored his fellow Cherokee to focus more attention on the Scottish, as many of the Cherokee had historically intermarried with the Scottish. But most of their aid went to the Irish. Hanson Shrou argues that this was a coded way of identifying with the Irish as fellow victims of colonialism.

Today this subtext is text. If you go to [the website of the Choctaw Nation of Oklahoma](#), the second paragraph on the Irish connection explicitly links the two countries together. "Both the Choctaw Nation and Ireland were, in effect, colonized by outside powers." The story doesn't stop there; during COVID, the Irish raised \$2 million and sent it to the Navaho and Hopi, who were badly affected by the virus, as an act of memory thanks for the 1847 gifts.

Art Omi: Artists welcomes artists from all over the world who have been professionally active for at least the past 3 years. Disciplines include visual arts, sound art, performance, and social practice. Having studied art is not a requirement: we accept applications from self-taught professional artists. Applications for the summer residency are accepted each year Aug 15-Oct 15.

The Visitors Program enables residents to have conversations with visiting art critics, curators, gallerists and prominent artists. Direct engagement with the New York City art world is unmatched by similar residency programs. Art Omi's Monotype Project offers artists-in-residence an opportunity to work with a master printer. Together they create beautifully printed
