Featured Funders

The W.K. Kellogg Foundation

Do I even need to introduce the fortune behind today's Featured Funder? That's right, today we are talking about the Boss of Bran Buds, the Capitalist of Corn Flakes, the Fat Cat of Fruit Loops, the Mogul of morning breakfast: William Keith Kellogg.

William Keith Kellogg was born in 1860 in Battle Creek Michigan to John Preston Kellogg and his second wife, Ann Janette Stanley. His father owned a broom factory and was something of a spiritual seeker, at time joining the Baptists and the Congregationalist Church (a type of Presbyterian), before ultimately settling down as Seventh Day Adventist. He raised his many, many children as Seventh Day Adventists, a fact that famously shaped the Kellogg brand.

William Keith Kellogg began working early; at the age of seven, he was already paying for his own clothing and by fourteen, he was employed full-time as a traveling broom salesman. At eighteen, he was hired to help run a broom factory in Dallas Texas. A year later, in 1879, his brother, Dr. John Harvey Kellogg, invited William Keith to join the sanatorium he was directing in Battle Creek.

The sanatorium was a cross between a luxury hotel and hospital. It was funded by fellow Seventh Day Adventists and run in accordance with vegetarian principles. It was there that one of the Kelloggs invented Corn Flakes. Was it John Harvey after careful experimentation? His wife Ella, in a dream? William Keith by reverse engineering an accident? No one exactly agrees on the story.

Whatever the origin, Corn Flakes were the origin of the Kellogg fortune...eventually. There were various mishaps, as a sanatorium patient by the name of Post stole the recipe and went on to found his own cereal brand, and family feuds between William Keith and John Harvey Kellogg over whether to sell the cereal to customers outside their sanatorium. Eventually William Keith bought out John Harvey and began marketing the cereal on a national scale. The company expanded and William Keith grew rich. John Harvey, however, grew to feel betrayed by his brother and a number of lawsuits followed.

The brothers never reconciled in life. John Harvey kept on practicing medicine and became a leading proponent of a staggering number of truly terrible ideas—eugenics and segregation, [among others](#). William Keith mostly devoted his time to breeding Arabian horses and philanthropy. In 1930 he founded the W. K. Kellogg Child Welfare Foundation and four years after that donated close to a billion dollars to it in today's currency.

Today, the Kellogg Foundation focuses on child welfare and funds programs in the following areas:

- **“Thriving Children:** We support a healthy start and quality learning experiences for all children.”
“To ensure that children thrive, we focus on improving access to high-quality early education and education systems, where families are engaged in schools and practices rooted in a community’s languages and cultures.”
- **“Working Families:** We invest in efforts to help families obtain stable, high-quality jobs.”
“We work alongside grantees and employers to widen paths to stable, high-quality jobs and more equitable employment opportunities.”
- **“Equitable Communities:** We want all communities to be vibrant, engaged and equitable.
“Making communities more equitable requires all of us to confront how racism and bias affects our history and present-day experiences, to heal from the resulting fractures to our relationships, and to begin reshaping systems that hold so many of us back.”

Deadlines are rolling for all areas and grant amounts vary.

Sage Advice

Is it better to apply for a project you've just started or have almost finished?

We hear a lot from faculty looking for funding for their SAPL year. (Curious why you should look for funding if your SAPL year is already funded? Check out last month's issue.) More often than not, faculty who are eligible for SAPL, particularly if they're from book fields, tend to find themselves between two projects. They are usually fairly close to done turning their dissertation into a book, or at least can see the end coming, and they're already starting to think about a second project.

All of which leads to a common question: **Which project should you use when applying for funding?**

The good news is that funding agencies mostly don't care how far along you are in a project. If you read through the ACLS, NEH, IAS, or any other big fellowship funders, they don't give explicit guidelines on that point. They just want to promote good work and give scholars the support they need to push their scholarship forward. Obviously, you don't want to straight-out lie to a funder about your progress, but if you are genuinely torn between two projects, there are some practical considerations.

Do you actually have enough work left on your first project to sustain a fellowship?

If you're just working on the index, maybe dust off that second project idea you've been mulling over? Writing the grant will help you get a firmer idea of what you want to do, anyway. (Also, consider hiring someone to deal with the index. Life is short.)

Do you have a research question for your second project?

We met with a faculty member recently who confided that she always urged her students to start with a topic that makes them exclaim, "That's so weird!" I think this is a delightful way to go through life—it's actually why I just finished reading a book about Johnny Appleseed upon learning that he was a Swedenborgian—but she was quick to add that the project can't stay there. A good project needs a reasonably detailed research question to progress. The same is true for a grant proposal. There's a lot that you don't need to know in advance to write a persuasive proposal, but what exactly you want to find out and why is the bare minimum. If you don't have that, you need to give yourself more time.

Do you have a first guess about what you would need to do to write your chapters?

One of the things you can fudge? The arguments of your individual chapters. You don't need to say what you're going to conclude for each chapter, but it helps a lot when proposing a second project to say, "I plan on analyzing problem x through the architecture of Beijing/New York/London/Lahore, drawing on the following archives..." Or, "By using oral histories of population X, I will interrogate Y." If you've gotten that far in thinking about your second project, tally-ho!

Can you explain why you're focusing on a particular object, archive, population, or site?

Your archives might turn out to be a bust! You might settle down to your ethnographic work and discover that no one in your village of choice cares about media/tourism/AI. It makes you look credible if you can explain why you would reasonably expect the objects or sites you've chosen to be fruitful.

Do you need to travel as part of the fellowship?

If you've basically written your book and are just working on revisions, it might be hard to justify that Fulbright. It can be done—maybe you want to consult on interpretations or review a manuscript in person—but it might be easier to make a case for travel for that new project, if it's sufficiently advanced.

The key point is that you have to give funders the sense that you have a concrete plan about what you'll do with your time.

The History of American Philanthropy

[Last issue](#), I began the story of George Peabody, a wealthy banker, merchant, and philanthropist who founded what is arguably the first educational foundation in America in the immediate aftermath of the Civil War. Today, I want to pick up that story with the early years of the Peabody Education Fund.

When George Peabody first set out to give away his vast fortune, oppressed by “aches and pains [that] made me realize that I was not immortal,” he initially intended to give it to the poor of New York City ([Parker, 112-114](#)), where he had gotten his start, but came to believe after the Civil War that the real need lay in the South. He appointed a handful of men to work as trustees. Charles Winthrop, former Speaker of the House of Representatives, became President of the Board. Barnas Sears, former President of Newton Theological Seminary, Secretary of Massachusetts Board of Education and President of Brown University, became the first agent in charge of dispersing funds.

A charitable organization consisting entirely of Northerners might have raised hackles among white Southerners, but the Peabody Fund secured a key endorsement from Robert E. Lee early on, after Lee and Peabody met in 1869. This seems like a good moment to pause and note that the scholarship on the Peabody Education Fund that I dug up was relatively old and not entirely reliable. One of the most prolific scholars, writing in 2003, seems [generally hostile to Reconstruction](#); the [other, more critical article](#) of the Peabody Education Fund’s racial politics is older than I would like, dating back to 1966.

That said, there are common points of agreement. Both scholars agreed that the Peabody Education Fund was designed to help Black and white impoverished people. In establishing it, George Peabody explicitly requested that funds “be distributed among the entire population, without other distinction than their needs and the opportunities of usefulness to them” ([West, 4](#)). These funds went largely to building schools and funding scholarships. Both agree that the Fund targeted communities with demonstrated need, where funds could do the most good. And both scholars do agree on the common structure of the gifts the Fund made. They were meant to go to private institutions, after the Peabody Fund tried and failed to create a partnership with the state legislature of Tennessee. Communities had to show that they were committed to sustaining schools after the Peabody Fund left. Most importantly, communities had to raise funds to match the Peabody Education Fund’s gifts.

In essence, the Peabody Fund invented in the late 1860s the idea of cost share—that is, the idea that the recipient of a grant needs to kick in some amount of funds to show that they “have skin in the game.” For the Peabody Fund, the demand for matching gifts was based on a whole worldview about the “industrious poor” and the belief that “God helps those who help themselves.”

There were two practical problems with this plan, both of which collided with racial reality on the ground. First, at the time Barnas Sears first started building schools in the South, the [Freedmen’s Bureau](#) was still in operation. Running from 1865-1872, the Freedmen’s Bureau was a government agency that provided clothes, fuel, food, and other resources to formerly enslaved people, in addition to establishing schools where they could be educated. Earle H. West observes in his 1966 article that aid from the Freedmen’s Bureau and missionaries made recently enslaved populations seem more prosperous and less in need than they really were, which would turn out to be a huge problem when the Bureau closed in 1872.

The second problem was that people who had just been freed from bondage simply didn’t have the funds to match the Peabody gifts. This is one of the ongoing inequities around cost share and why some organizations refuse to accept it. The National Science Foundation, for example, prohibits applicants from writing in any form of cost share when applying for a grant precisely because it unfairly disadvantages those institutions with limited resources. The end result was that [only about 6.5% of Peabody funds went to schools specifically designated as serving Black students](#).

“Important Information and Revision Notes.

- “A pilot track in the Directorate for Biological Sciences and Directorate for Geosciences has been added that extends PI eligibility to include Full Professors (or equivalent) at Primarily Undergraduate Institutions (PUIs) only.
- The page limit of the Project Description has been reduced from 15 pages to 12 pages.
- A 2-page Impact Statement, uploaded as a Supplementary Document, is now required.

In addition to the PI, each Partner must also complete the Collaborative and Other Affiliations ([COA](#)) template and upload the document as a Single Copy Document. Budget details have been clarified.” [<<more>>](#)

Data on Number of Research Project Grants per Principal Investigator

“Earlier this year, we posted a blog about inequalities in Research Project Grant (RPG) support for extramural principal investigators (PIs). The blog was based on a paper we published in which we showed, among other things, that well-funded PIs not only were supported by more money but also by a larger number of distinct grants. Over 80% of the PIs in the top centile (top 1%) of funding were supported by two or more grants, compared to only 33% of the PIs in the bottom 99%.

“Many comments to that post requested data on time-related trends of number of RPGs supporting individual PIs. Figure 1 shows exactly that. In Fiscal Year 1985, approximately 80% of designated RPG PIs were supported on just 1 RPG (line with triangles at the top); that proportion has fallen over time to 67% in Fiscal Year 2021. Note the vertical dotted lines correspond to the NIH doubling (Fiscal Years 1998-2003) and budget sequestration (Fiscal Year 2013).” [<<more>>](#)

- What works: The primary aim must concern evaluating the effectiveness of programs designed to promote positive cognitive and/or achievement outcomes for children (birth

through 18 years) with the goal of informing ways to close the educational opportunity gaps associated with race, ethnicity, and income.

Secondary aims may also focus on one or more of the following:

- What works for whom, under what conditions: Investigate variations in program effects; that is, test for moderation effects that inform whether effects are stronger for certain groups and/or under certain conditions than other groups or conditions.
- Reasons for effects: Investigate mechanisms through which effects occur; that is, test for mediation effects that inform why the program is effective.
- Cost-benefit analyses: Compare the total costs of the program (start-up and ongoing operational costs) with its estimated monetary benefits to determine the net cost or benefit associated with the program.
