NEH's American Tapestry: Weaving Together Past, Present, and Future

As you may or may not have heard, the National Endowment for the Humanities received a new Chair last October, when President Biden appointed Shelley C. Lowe (Navajo) head of the agency. Under her direction, the NEH recently released a new initiative called "American Tapestry: Weaving Together Past, Present, and Future." So what is this new initiative, what does it mean for the agency, and what does it mean for those of you seeking funding?

The NEH's announcement described American Tapestry as an agency-wide initiative to "leverage the humanities to strengthen our democracy, advance equity for all, and address our changing climate."

"As Americans we are the inheritors of a uniquely rich and vibrant history, a magnificent tapestry of diverse cultures, beliefs, experiences, and intellectual movements, bound together by the warp and weft of American ideals of progress and opportunity," said NEH Chair Lowe. "NEH's new agency-wide initiative, *American Tapestry*, draws upon the insights of the humanities to help us connect the American future with the American past, and cherish this inheritance for future generations by providing funding for humanities-based programs that foster a thriving democracy, expand opportunity and access for all Americans, and help us understand our relationship to the natural world."

The initiative offers a few funding opportunities for institutions looking to adapt their infrastructure to climate change (don't worry, we're looking into them!), but it also includes new opportunities for individual scholars and those working with local communities.

- [***"Dangers & Opportunities of Technology: Perspectives from the Humanities"***](#) Many of today's global challenges, such as climate change, pandemics, wealth inequality, and artificial intelligence, are driven in part by the complex relationship between rapidly evolving technology and the people and institutions it affects. This new NEH grant program asks researchers to tackle these key societal challenges through the lens of the humanities to help gain a better understanding of not only the promises of technology, but its dangers as well. (Application deadline: February 2, 2023).
Funding: Up to \$150,000.
- [***"Spotlight on Humanities in Higher Education"***](#) A new NEH grant program that supports the development of small projects that benefit historically underserved populations through the teaching and study of the humanities at two- and four-year colleges and universities and higher education nonprofits. (Application deadline: November 1, 2022).
Funding: \$25,000 for Exploration, \$60,000 for Development.
- [***"Cultural and Community Resilience Program"***](#) A new NEH grant program that supports efforts to mitigate the impact of climate change and health crises on communities while safeguarding their cultural resources, especially among historically disadvantaged communities, as outlined in the Biden-Harris [administration's Justice40 initiative](#). (Application deadline: January 12, 2023).
Funding: Up to \$150,000.

Sage Advice

New NIH Data Management and Sharing Policy (Effective January 25, 2023)

NIH investigators and applicants, you've likely heard about the [new Data Management and Sharing Policy](#), set to go into effect on January 25, 2023. For those of you planning submissions to NIH on or after that date, we've prepared a short list of the key points. (By the way, there's no plan at this time to make the policy retroactive to grants submitted before the policy goes into effect.)

Goals	The goals of the new policy are to promote rigorous and reproducible research as well as to ensure that the results of NIH-funded research are shared broadly.
Scope	All proposals that generate scientific data (defined in the policy) will be subject to the new policy—not just proposals over a certain dollar threshold.
Extent of Sharing	NIH expects that data sharing will be maximized (although the policy does take into account that there may be valid reasons to limit sharing – where it might impact the privacy or safety of participants, for example).
When to share	Data will need to be shared no later than the time of publication, or at the end of the grant's period of performance.
Data Management and Sharing Plan	Applicants will be required to submit a Data Management and Sharing Plan (2 pages maximum) as part of their proposals. This plan will need to cover: Data Type Related Tools, Software and/or Code Standards Data Preservation, Access, and Associated Timelines Access, Distribution, or Reuse Considerations Oversight of Data Management and Sharing There is a template available from the NIH for use in developing your plan.
Plan Review and Enforcement	Plans will be reviewed and approved by Program Officers at the time of submission. PIs will need to report on progress and compliance with their plans in their annual reports to the NIH.
Budgeting	PIs will be able to include certain costs for data management and sharing in their grant budgets.
Repositories	NIH encourages the use of established repositories appropriate for your data types. Your NIH Institute, Center, or Office—or even the Funding Opportunity Announcement – may require the use of a particular repository. If not, you are free to choose an appropriate repository (including an institutional repository)

The History of American Philanthropy

[Last issue](#), we continued the story of the Peabody Education Fund, arguably the oldest education foundation in America. As I discussed last week, drawing on [an older article from Earle H. West](#), despite being theoretically colorblind in its mission statement, the Fund's insistence that all communities receiving Peabody money to start schools needed to raise matching funds from the local community wound up systematically disadvantaging Black communities, where there simply wasn't enough money to go around.

The Peabody Education Fund's racial politics continued to be defined by tepid support for equality punctuated by hypocrisy in the years that followed. Still, the Fund gradually increased its support of Black education, eventually deciding to loosen its requirements for matching funds in 1868, and providing a set amount of money to commissioners from the Freedmen's Bureau in Virginia, North Carolina, and Georgia. The funding was never equal, though. While white schools received a standard grant size of \$300, Black schools only received \$200 from the theory that it cost less to maintain them (West, 11).

The most damning test came with Louisiana's state constitution of 1868. The state had drafted a new constitution four years prior, in the immediate aftermath of the Civil War. That constitution—the Constitution of 1864—had abolished slavery but didn't extend the vote to Black or mixed-race men. A year later, the state passed the ["Black Codes"](#) restricting movement of Black people and criminalizing signs of "impudence." The Black and mixed-race communities of Louisiana immediately pushed back against it and in 1866, Republicans succeeded in calling a new state constitutional convention to draft a new constitution. That constitutional convention ended in tragedy, when ex-Confederate soldiers massacred a group of largely unarmed Black marchers who were there to support the convention. 38 people were killed, 34 of whom were Black, and another 146 were injured in what became known as [the New Orleans Massacre of 1866](#).

Nonetheless, the constitutional convention did succeed in passing the Constitution of 1868, finally extending the vote to Black men, formalizing a Bill of Rights, disenfranchising former Confederate soldiers, and integrating public schools. The provision integrating schools offered a test of the Peabody Fund's values.

Up until then, the Peabody Fund had remained agnostic on the question of integration, preferring to adapt to the preferences of local communities. In 1867, Barnas Sears, who ran the fund, visited Louisiana and met with the soon-to-be-former State Superintendent of Education, Robert Mills Lusher. Lusher had refused to run for an office that required him to oversee racially mixed schools. It's not clear how much influence Lusher had as Sears contemplated different responses, but eventually Sears decided that Black children would be provided for by the state, when their schools were integrated, and it was white children whose parents refused to send them to integrated schools who really needed support. He appointed Lusher head of Peabody's efforts in Louisiana.

Sears insisted that his opposition to mandatory integration had nothing to do with racism and that if Black communities had refused to integrate with white communities, he would have just readily provided aid to them. He remained insistent that mandated integration would only alienate key white constituents, even after the Fund's experiment in Louisiana went down in flames. The reception of the Fund's efforts was so bad, with many painting (or accusing) it of trying to sabotage state-run schools, that Sears eventually pulled funding to the state of Louisiana in 1876. Even after doing so, though, he still visited Washington D.C. in 1875 to lobby against a national civil rights bill that would have integrated schools across the country, effectively scuttling that provision.

And that's where we'll leave the Peabody Education Fund.

NSF announces name changes to education directorate

To more accurately reflect and communicate the values and totality of the agency’s work with STEM education including supporting the [missing millions](#) — Americans from every background, in each state, who have the potential to participate in STEM — the directorate will now be known as the [Directorate for STEM Education](#), or EDU, and the division will be known as the Division of Equity for Excellence in STEM, or EES.” [<<more>>](#)

Where Should My Data Management and Sharing Plan Be Included in My Application for Funding?

“For applications being developed for due dates on/after January 25, 2023, Data Management and Sharing (DMS) Plans will be collected in a NEW field called “Other Plans” on the PHS 398 Research Plan and Career Development Award forms. See [Writing a DMS Plan](#) for the details on what to include in a Plan.

“Note that any costs to support data management and sharing should be accounted for in either the R&R Detailed Budget Form or the PHS 398 Modular Budget Form along with a brief justification of those costs. NSF to end cost-sharing mandate for some grants to level the playing field

“So this year, Congress directed the National Science Foundation (NSF) to eliminate the requirement in two of the five agency programs that require cost sharing and see what happens. For the next 5 years, NSF will no longer require universities and other organizations to cover 30% of an award from its major research instrumentation (MRI) program, which funds new equipment.
