## Featured Funders

### The Washington Center for Equitable Growth

Today's Featured Funder, the [Washington Center for Equitable Growth](#), was only founded in 2013, which makes it practically a baby, compared to some of the older funders we've covered through the years, but it's just as entangled with elite power brokers as the Rockefeller Foundation was in its day.

If there's any single person responsible for the Center, it's [John Podesta](#), Senior Advisor on clean energy to President Biden. Podesta was born in 1949 in Chicago to a working class family. His father was a factory worker of Italian-American descent. Podesta went to Knox College, then Georgetown Law School. Right from the beginning, he was enmeshed in Democratic politics. He met Bill Clinton in 1970 when they were both working on the Senate campaign of a now-forgotten politician named [Joseph Duffey](#). Upon graduating law school, he worked for a year at the Justice Department in the Honors Program in the Land and Natural Resources Division, then jumped into a political career that involved nearly every Democratic administration. He was Chief of Staff for President Clinton (and tasked with handling the fallout of the Lewinsky scandal), counselor to President Obama, chairman of Hillary Clinton's 2016 campaign, and is now responsible for dispersing clean energy funds.

Intellectually, Podesta is known for his support of policies that address climate change and his advocacy of greater government transparency. In 2003, he founded the [Center for American Progress](#), a left-leaning think tank explicitly created as a counter to the Heritage Foundation. Ten years later, in 2013, the Center for American Progress launched the [Washington Center for Equitable Growth](#). Today, it offers grants to scholars and policymakers to fund research that supports "evidence-backed ideas and policies that promote strong, stable, and broad-based economic growth. Our fundamental purpose is to determine the channels through which rising economic inequality affects economic growth and stability in the United States.

"Equitable Growth answers these questions by building a bridge between the academic and policy communities to research and analyze the effects of inequality, mobility, racial and gender inequities, and persistent institutional racism on U.S. economic growth and present those findings to policymakers, so they can create a more inclusive economy through evidence-based policy." Funding opportunities include the following:

"[American Economic Association Summer Economics Fellows Program](#) [...] seek[s] to promote efforts to increase diversity in the economics profession by supporting postdoctoral scholars and junior faculty pursuing academic research that explores how inequality affects economic growth and stability. The program includes opportunities for professional development and mentorship, trainings, and exposure to how to make research relevant to today's policy debates and accessible for the policymaking community." **Deadline: February 1, 2023.**

"[Academic Grants](#) are open to researchers affiliated with a U.S. university. The affiliated university must administer the grant. Academic grants are typically in the \$25,000 to \$100,000 range over 1 to 3 years...The Washington Center for Equitable Growth seeks to deepen our understanding of how inequality affects economic growth and stability. To do so, we support research investigating the various channels through which economic inequality, in all its forms, impacts economic growth and stability. Equitable Growth promotes efforts to increase diversity in the economics profession and across the social sciences... Equitable Growth supports research inquiry using many different types of evidence, relying on a variety of methodological approaches and cutting across academic disciplines. Our request for proposals is organized around four channels of growth: Macroeconomics, Human Capital & Well-being, Market Structure, and The Labor Market." **Deadline: January 23, 2023.**

### Key Points: NSF Changes Implemented with New PAPPG

The National Science Foundation has released the 2023 version of the Proposal and Award Policies and Procedures Guide (PAPPG), [NSF 23-1](#). The PAPPG becomes effective on January 30, 2023. This table summarizes the major changes being implemented with this version of the PAPPG.

Fastlane Decommissioned	Fastlane will no longer be an option for submissions.	We will still have access to submit proposal file updates, budget revisions, and to download submitted proposals.	January 27, 2023
New certifications for Biosketch and Current and Pending Support (CPS)	Investigators will be required to certify (by signature) that the information provided in their Biosketch and CPS forms is “current, accurate and complete.”	NSF will provide an updated template for this purpose. ## The History of American Philanthropy

Just about two years into this column, we are finally where I always imagined we would start, with the great fortunes and great foundations of the robber barons. I can't say how long this section will be, but to lead it off, I am going to talk today about [Russell Sage and Margaret Olivia Slocum Sage](#), his second wife who started the Russell Sage Foundation with his fortune (possibly) to spite her dead husband.

Russell Risley Sage was born in 1816 in Verona, New York, the youngest of six children. At 12, he left the family farm to work as an errand boy in his older brother Henry's grocery store in Troy, New York. Troy in those days was a shipping hub, located on the Erie canal, and that helped it become an industrial center and one of the wealthiest cities in the nation.

From a very young age, Sage was determined to become rich. He started investing in real estate early on, buying his first plot of land at age 13, and spending \$1.50 of the \$4 he earned every month to attend night school. Soon after that, he got into horse trading and used the profits to purchase even more land and even a sloop. By his late teens, his brother Henry had grown ill, so Sage pooled his funds with a third brother, Elisha, to buy their own store. At 23, he sold the grocery store for a profit and re-invested it in a trading company then, eventually, into banking. By 30, he was a respected businessman, worth several million dollars in today's money and elected to several local public offices. But when he clubbed together with several local elites to buy a struggling railroad and then promptly sold his shares for an enormous profit, his fortune grew to a different level altogether.

For a while, Sage dabbled in national politics, serving in the U.S. House of Representatives from 1863-1867, but his true love was business. He grew more and more interested in investing and railroads, eventually becoming the largest moneylender in the country. Everything he did seemed to bring him more money, with the exception of the Grant & Ward scandal of 1884.

The Grant & Ward scandal began with [Ferdinand de Wilton Ward Jr.](#), who was born in Geneseo NY to a pair of former missionaries. In 1873, at the age of 21, he began work as a clerk at the Produce Exchange. In fairly short order, he stole money from a Sunday School, laundered the money through a bank, and married an heiress. In 1880, he used his connections and new fortune to start a brokerage firm. Around the same time, he met Ulysses S. Grant Jr., son of the former president and general, when Grant happened to be rooming with Ward's brother at Columbia. Ward soon earned Grant Jr's trust and went into business with him, naming his firm Grant & Ward to capitalize on his partner's famous name. Money poured in, including the life savings of Ulysses Grant and funds from Russell Sage, and, at first, Ward grew rich by offering high, reliable returns. The bank turned out to be a Ponzi scheme, though, and in 1884 everything collapsed.

The scandal bankrupted former president Ulysses S. Grant and inconvenienced the much wealthier Russell Sage. It was the first great scandal that Sage was swept up in. The second happened in 1892, when an unknown man secured a meeting with Sage and his clerk, William Laidlaw. The man passed a note demanding \$1.2 million dollars and threatening to blow himself up if Sage refused. Sage did refuse and the man touched off a bag full of dynamite, blowing himself up, in what is allegedly the first suicide bombing in U.S. history. Sage grabbed Laidlaw and thrust him in the way of the blast as a human shield. Laidlaw spent years suing for damages and a court eventually awarded him \$44k in damages, but Sage kept fighting the lawsuit and never paid.

Sage also never served any time in jail [for violating the usury law](#) by charging 40-80% on short-term loans. His greatest social sin was his purported miserliness, though. *The New York Times* ran regular stories mocking him for cheapness, including one claiming that he let his mansion lawn turn to hay so he wouldn't have to pay to buy food for his horses. That's what makes it so surprising that his fortune became the basis of one of the greatest foundations of the time.

### **NSF appoints Charles 'Chuck' Barber as chief diversity and inclusion officer**

“The U.S. National Science Foundation has appointed Charles "Chuck" Barber to serve as chief diversity and inclusion officer, a newly created role included in the [CHIPS and Science Act](#). In this role, Barber will serve as NSF's senior advisor responsible for providing vision, strategic leadership and management for ongoing agency programs and new initiatives related to diversity, equity, inclusion and accessibility, or DEIA, in the NSF workplace and the STEM enterprise.

“As NSF CDIO, he will be responsible for leading the integration and sustainability of DEIA into the agency's culture and mission and all aspects of agency operations and decision making, including special emphasis programs, employee resource

groups and other related functions. He will ensure that DEIA remains a priority at NSF and provides an organizational channel for agency accountability. Barber will also be responsible for coordinating NSF's work to address the requirements of [Executive Order 14035: Diversity, Equity, Inclusion and Accessibility in the Federal Workforce](#). The EO includes assessing DEIA within NSF and developing and advancing a strategic plan to advance DEIA and remove any potential barriers to DEIA in the NSF workforce.” [<<more>>](#)

### **WHO’s departing chief scientist regrets errors in debate over whether SARS-CoV-2 spreads through air**

“Last week, Indian pediatrician Soumya Swaminathan [announced on Twitter](#) that she is leaving her post as chief scientist at the World Health Organization (WHO) at the end of this month. She plans to return to India to work on public health there.

“Swaminathan, 63, joined WHO in 2017 and in March 2019 was named the agency’s first chief scientist, a position created by Director-General Tedros Adhanom Ghebreyesus to make sure “WHO anticipates and stays on top of the latest scientific developments.” During the COVID-19 pandemic, Swaminathan became one of the faces of the agency’s global response, fielding reporters’ questions at countless press conferences. Communicating about COVID-19 science “wasn’t really considered one of the functions of the chief scientist,” she says—but she embraced the role. Her biggest regret is not acknowledging early in the pandemic that SARS-CoV-2 could be spread by aerosols.” [<<more>>](#)

### **Groups Seek Substantive Revisions to HHS Misconduct Regs, Investigations**

“Two organizations representing research institutions and integrity officials have called for a virtual rewrite of the regulations that govern misconduct in Public Health Service-funded studies.

“The Association of Research Integrity Officers (ARIO) and the Council on Governmental Relations (COGR) argued in a joint letter in response to a request for information (RFI) that the current regulations are 17 years old, which has given institutions “ample opportunity to see how [they] work in practice.”[1]

“Among the recommendations in their 12-page letter is to narrow “the scope of inquiries/ investigations and the circumstances under which an inquiry or investigation may be closed.” The HHS Office of Research Integrity (ORI), which enforces research misconduct regulations, has “interpreted [relevant] provisions to greatly expand the scope of investigations beyond what the allegations and evidence suggest,” the organizations wrote.” [<<more>>](#)

#### National Science Foundation Perception, Action & Cognition Research Proposals

Deadline: February 1, 2023

“The PAC program funds theoretically motivated research on a wide-range of topic areas related to typical human behavior with particular focus on perceptual, motor, and cognitive processes and their interactions. Central research topics for consideration by the program include (but are not limited to) vision, audition, haptics, attention, memory, written and spoken language, spatial cognition, motor control, categorization, reasoning, and concept formation. - Books can be written by any foreign language to any foreign language (not Arabic), Grant (\$50,000)
