Writing for a Broader Public

It's June. Hopefully your brain has started to recover from the semester and you're turning back to old and new projects with some feeling of optimism and pleasure. What better time of year to think about that book you've been dreaming of writing for a larger audience? That's why this month, rather than focus on a single funder, I am bringing you a collection of grants in support of open access publication and nonfiction written for a general public.

[“The 2023 Whiting Creative Nonfiction Grant](#) of \$40,000 will be awarded to as many as ten writers in the process of completing a book-length work of deeply researched and imaginatively composed nonfiction for a general readership. It is intended for multiyear book projects requiring large amounts of deep and focused research, thinking, and writing at a crucial point mid-process, after significant work has been accomplished but when an extra infusion of support can make a difference in the ultimate shape and quality of the work. Whiting welcomes applications for works of history, cultural or political reportage, biography, memoir, science, philosophy, criticism, food or travel writing, graphic nonfiction, and personal essays, among other categories.” **Deadline: TBA. Previously April 25th. Funding: \$40,000.**

[The Alfred P. Sloan Foundation](#) supports “authors in the research and writing of a wide range of books aimed at public understanding of science and technology [...] Supported books tend to fall into the following categories: Books that elucidate important subjects where the science is confusing or controversial; Books that profile important figures in science and technology; Books relating science and technology to daily life; Books exploring the numerous connections between science, technology, and art; Books about the relationship between women and science and technology; Books about the culture and philosophy of science.” **Deadline: January 1, May 1, September 1 annually. Funding: Varies.**

[The Public Scholars Award at the National Endowment for the Humanities](#), “offers grants to individual authors for research, writing, travel, and other activities leading to the creation and publication of well-researched nonfiction books in the humanities written for the broad public. Writers with or without an academic affiliation may apply, and no advanced degree is required.” **Deadline: November 29, 2023. Funding: Up to \$5k/month for 6-12 months.**

The NEH also offers [The Fellowships Open Book Program](#), which is “a limited competition designed to make outstanding humanities books digitally available to a wide audience. By taking advantage of low-cost e-book technology, the program will allow teachers, students, scholars, and the public to read humanities books that can be downloaded or redistributed for no charge.” **Deadline: July 14, 2023. Funding: \$5,500.**

The American Council of Learned Societies and Arcadia have teamed up to create the [Open Access Book Awards](#), which “recognize and reward the authors and publishers of exceptional, innovative, and open humanities scholarship. In the initial competition, two open access monographs will receive dual awards. Authors will receive the \$20,000 ACLS Open Access Book Prize. Publishers of the winning titles will receive the Arcadia Open Access Publishing Award in the amount of \$30,000 to support forthcoming books that would not otherwise be published open access.” **Deadline: September 1, 2023. Funding: \$20,000.**

Sage Advice

No Country for Misplaced Commas, or Cormac McCarthy's Writing Advice

Note: This seemed a timely moment to rerun this article.

Have you ever wondered what Cormac McCarthy would make of your research articles? Neither have I, truthfully, but faculty and postdocs at the Sante Fe Institute have spent the last twenty years finding out. When he's not busy writing Pulitzer-winning novels, it turns out that Cormac McCarthy has a thriving side hustle editing scientific articles. Two of the scientists who have worked with him, theoretical biologist Van Savage and evolutionary biologist Pamela Yeh, co-wrote a delightful article titled, "**Novelist Cormac McCarthy's Tips on How to Write a Great Science Paper**" in the September issue of *Nature: International Journal of Science*.

So what does Cormac McCarthy have to say?

Predictably, a great deal of his advice is concerned with building a narrative, like the following points.

- “• Decide on your paper's theme and two or three points you want every reader to remember. This theme and these points form the single thread that runs through your piece. The words, sentences, paragraphs and sections are the needlework that holds it together. If something isn't needed to help the reader to understand the main theme, omit it.
- Don't slow the reader down. Avoid footnotes because they break the flow of thoughts and send your eyes darting back and forth while your hands are turning pages or clicking on links. Try to avoid jargon, buzzwords or overly technical language. And don't use the same word repeatedly — it's boring.
- And don't worry too much about readers who want to find a way to argue about every tangential point and list all possible qualifications for every statement. Just enjoy writing.”

Other advice is more stylistic, like the following points.

- “• Use minimalism to achieve clarity. While you are writing, ask yourself: is it possible to preserve my original message without that punctuation mark, that word, that sentence, that paragraph or that section? Remove extra words or commas whenever you can.
- Commas denote a pause in speaking. The phrase 'In contrast' at the start of a sentence needs a comma to emphasize that the sentence is distinguished from the previous one, not to distinguish the first two words of the sentence from the rest of the sentence. Speak the sentence aloud to find pauses.”

Some of his advice is specific to the sciences and won't work in all fields.

- “• Avoid placing equations in the middle of sentences. Mathematics is not the same as English, and we shouldn't pretend it is. To separate equations from text, you can use line breaks, white space, supplementary sections, intuitive notation and clear explanations of how to translate from assumptions to equations and back to results.”

The overall advice applies equally well to grants as articles, though. Think of your proposal as a story people should want to read. A good story doesn't need everything you have ever read or thought in it. It does need enough information to be compelling and easy for the reader to follow. (So think Guy de Maupassant, not Italo Calvino. No one at the NSF wants to read a postmodern proposal.)

The History of American Philanthropy

[Last issue](#), we discussed Andrew Carnegie's Gospel of Wealth and his underlying philosophy of giving. That philosophy could be crudely summarized as "a-rising-tide-lifts-all-boats"; Carnegie thought it was better for society as a whole for huge degrees of inequality to exist, if it allowed the basic standard of living and education for everyone to improve. To justify that inequality, though, the wealthy had to give away their fortunes to causes that would allow the less privileged to better themselves. And just as importantly, they had to give away that money while still alive.

So what did he actually give his money to?

The short answer is lots of things. There was the Carnegie Corporation (more on that in a future issue), Carnegie Mellon University, and the Carnegie Endowment for International Peace in 1910 to "hasten the abolition of international war." But Carnegie was best known for founding libraries. From 1889, when he first started building libraries, and 1919, when he died, Carnegie gave away \$41 million to construct 1,679 libraries across the country. The story goes that, as a young boy, Carnegie couldn't receive formal schooling because he had to work, and instead educated himself mostly by reading books lent out by a local philanthropist, Colonel James Anderson. Anderson's generosity was so formative that Carnegie decided to use a huge portion of his fortune to offer the same opportunities to others.

It's a nice story and even seems to be true, but the reception of his generosity was considerably more complicated in practice. Sometimes local towns couldn't afford the upkeep of a Carnegie library. [In one article from 2014](#), a local historian from Wilmington, North Carolina named Jennifer Daugherty recounted the story of how Wilmington city officials initially declined a Carnegie library grant when offered it in 1901 because the city would be obligated to spend \$2,500 per year in upkeep and services. At that point, a women's club, the North Carolina Sorosis, started lobbying the city to accept the funds, eventually convincing them to commit \$1,200 per year.

In the South, in particular, many white officials feared that Carnegie libraries would be integrated public spaces and turned down the money altogether, rather than accept a space that allowed for racial mixing. It actually wasn't true that Carnegie insisted on integrated libraries. There are several examples of Carnegie funding libraries specifically for Black communities, including one branch in Houston, which was established in 1913 when local Black community members secured a grant from Carnegie after they were turned away from the existing, all-white Carnegie library. In an essay titled, "[Autonomy and Accommodation: Houston's Colored Carnegie Library, 1907–1922](#)," Cheryl Knott Malone recounts the story of how the community successfully lobbied the City of Houston to let the community create an all-Black Board of Trustees for the library, only to have the city disband the Board eight years later and absorb the previously autonomous library into its existing, segregated network of libraries. Other Black communities were more ambivalent about segregated libraries. Wayne A. Wiegend cites in [Part of our lives: a people's history of the American public library](#) one Black assistant librarian who observed that when the Louisville Public Library opened its Coloured Branch in 1905 that "there were some of our race seriously opposed to the project[...] The segregation idea was repulsive." Yet she also felt that it was impossible for an integrated library "to give us the service that one of our race can give in an atmosphere where welcome and freedom are predominant" (cited in Wiegend, 84-5).

Mostly, according to Wiegend, the issue was class. The working class citizens, who made their living under the Gilded Age robber barons sometimes simply didn't want the charity of the men who had so thoroughly won the game of capitalism. When voters rejected a Carnegie grant in one West Virginia town, one union representative noted with satisfaction that, "There will be one place on this great green earth where Andrew Carnegie can't get a monument with his money" (Wiegend, 95).

That's where I want to leave the story of American philanthropy, to be resumed in November.

NSF highlights availability of Earth observation data for NSF-funded researchers

NSF announces investment in research infrastructure to improve life-saving weather predictions and climate projections

“The U.S. National Science Foundation announced \$91.8 million in funding for a Mid-scale Research Infrastructure-2 award to the University Corporation for Atmospheric Research (UCAR) to create the Airborne Phased Array Radar. APAR will be a state-of-the-art radar that will be attached to the outside of an aircraft and flown over land and oceans to get remarkably close 3D views of what is going on deep inside clouds and severe storms. It will provide a generational leap in understanding the formation of rain, hail and snow, as well as severe convective systems and tropical cyclones. This will help researchers improve models used for weather prediction and climate projections.”

Safeguarding Integrity and Collaborations: Not “Either-Or” but “Both-And”

“Today *Science* published [our letter](#) “Safeguarding integrity and collaborations,” which summarizes our perspectives on NIH efforts to address long-standing foreign interference threats, many stemming from foreign malign talent recruitment programs. We are grateful to *Science* for publishing our letter and for [endorsing our efforts](#) to “talk more openly”[...]

“The main points we make in our letter are:

- NIH began addressing foreign interference concerns in May 2016, long before the Department of Justice launched its entirely separate “China Initiative.”
- We understand concerns about racial, ethnic, or political targeting. The disproportionate number of cases (which altogether account for < 1% of all NIH-funded principal investigators) linked to China likely stem from the extensive reach of Chinese talent recruitment programs, which explicitly target ethnic Chinese scientists.
- There should be no conflict between rigorous integrity oversight and international collaborations. This is a false dichotomy. As we write, “Proper collaborations do not entail stealth employment, duplicative funding, undisclosed financial conflicts of interest, or the repeated recitation of lies to institutional or government officials.” These behaviors, which deny funding to scientists who act with integrity, have often occurred at the instigation of foreign talent recruitment programs.” [<<more>>](#)

Update on Simplifying Review Criteria: Analysis of Comments from the Request for Information

“As discussed in the blog, “[Update on Simplifying Review Criteria: A Request for Information](#) (RFI),” NIH issued an RFI—from December 8, 2022, through March 10, 2023—seeking feedback on its proposed plan to revise and simplify the framework for the first level of the peer review of research project grant (RPG) applications.

“NIH received more than 800 [responses](#) to the RFI: 780 from individuals, 30 from scientific societies, and 30 from academic institutions. The vast majority were supportive of the proposed changes, although a minority were in favor of Factor 3 (Investigator, Environment) being scored, and a smaller minority advocated for a blinded or partially blinded review process. Most of the respondents highlighted the need for strong training resources for reviewers, study sections chairs, and scientific review officers.” [<<more>>](#)

House Republicans Want NOAA to be an Independent Agency

Groups Working on Reparations for Black Americans Get Boost From New Philanthropic Funding

Biden wants new national lab to study impact of climate change on disadvantaged communities

DOE officials did not request the money, *Science* has learned, and the proposal has gone largely unnoticed by the research community.”

Business Sector Increases Funding for Basic Research

“Expenditures on the performance of basic research funded by the business sector have increased dramatically over the past 2 decades. Based on the institutions that performed the work, funding from the business sector for basic research has increased from \$10.4 billion in 2000 to an estimated \$36.0 billion in 2021 in constant 2012 dollars. Although federal funding for basic research

performance increased in real terms from \$31.1 billion in 2000 to \$40.6 billion in 2005, little has changed since. Subsequently, federally funded basic research performance has essentially remained near or below \$40 billion. The longer-term trends in funding shares follow a similar pattern of decreased relative importance of the federal government as a funding source.”

National Science Foundation Law & Science

“The Law & Science Program considers proposals that address social scientific studies of law and law-like systems of rules, as well as studies of how science and technology are applied in legal contexts. **Council of American Overseas Research Centers
Multi-Country Research Fellowship**

Deadline: August 10, 2023

“The Multi-Country Research Fellowship enables US scholars to carry out trans-regional and comparative research in countries across the network of Overseas Research Centers as well as other countries. The fellowship supports advanced research in the humanities, social sciences, and allied natural sciences for US doctoral candidates, who are all but dissertation, and scholars who have earned their PhD. Applicants are eligible to apply as individuals or as teams. Scholars must carry out research in two or more countries outside the US, at least one of which must host a participating Overseas Research Center. Approximately nine awards of \$12,000 each will be awarded. Funding is provided by the US Department of State's Bureau of Educational and Cultural Affairs.” [<<link>>](#)

**American Academy of Religion
Collaborative Research Grants**

“Collaborative research grants are intended to stimulate cooperative research among scholars who have a focus on a clearly identified research project and for interdisciplinary work with scholars outside the field of religion.
