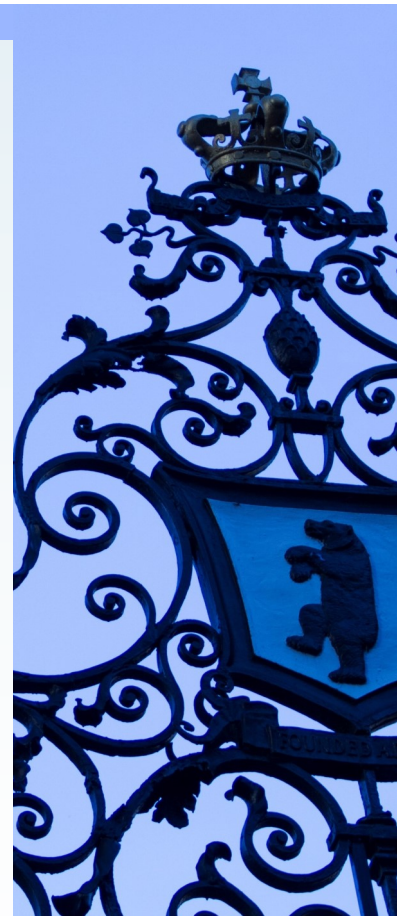

Featured Funding Opportunity

A Primer on the National Institutes of Health

“The National Institutes of Health (NIH), a part of the U.S. Department of Health and Human Services, is the nation’s medical research agency — making important discoveries that improve health and save lives. “ The NIH encompasses 27 Institutes and Centers (ICs), from the National Cancer Institute (NCI) to the National Library of Medicine (NLM). For a list of all 27, click [here](#).

The NIH uses overarching “activity codes” to designate grants according to eligibility and purpose that span the NIH’s 27 ICs. The NIH provides a summary page of all activity codes [here](#). Below are highlighted a few grant types of particular relevance to Barnard Faculty. Please note individual ICs may develop divergent dates for specific grants within the activity code.

R03 Small Research Grants: “The R03 grant mechanism will support small research projects that can be carried out in a short period of time with limited resources.” R03s fund “a project period of up to two years and a budget for direct costs of up \$50,000 per year.”

Deadlines: Standard dates — February 16, June 16, October 16 <<more>>

R01 Research Project Grant Program: “The Research Project Grant (R01) is the original and historically oldest grant mechanism used by NIH. ... [It] is an award made to support a discrete, specified, circumscribed project to be performed by the named investigator(s) in an area representing the investigator's specific interest and competencies, based on the mission of the NIH.” R01s do not designate a budget limit, but budgets must reflect the needs of the project. They fund up to 5 years of a project.

Deadlines: Standard dates for new grant applications — February 5, June 5, October 5; for renewal, resubmission, and revision grant applications — March 5, July 5, November 5 <<more>>

R13 and U13 Support for Scientific Conferences: “In order to promote the most efficient use of NIH funds towards meeting the mission and program goals of the ICs, each conference grant application is required to contain a permission-to-submit letter from one of the participating ICs (see [IC Contact and Special Interests](#) website)... This program supports both domestic and international conferences; however, an international conference can be supported only through the U.S. representative organization of an established international scientific or professional society.”

Deadlines: Standard dates — April 12, August 12, December 12 <<more>>

R15 AREA—Academic Research Enhancement Awards: “The AREA Program is implemented through the R15 funding mechanism... [to s]upport meritorious research, expose undergraduate and graduate students to hands-on research in eligible environments, strengthen the research environment of schools that have not been major recipients of NIH support.” Direct costs are limited to \$300,000 over the entire project period, and project period is limited to three years. R15s are renewable.

Deadlines: Standard dates — February 25, June 25, October 25 <<more>>

R21 Exploratory/Developmental Research Grant Award: “The R21 grant mechanism is intended to encourage exploratory/developmental research by providing support for the early and conceptual stages of project development.” Direct costs for one year are limited to \$200,000 and \$275,000 for

two years, the maximum project period. R21's cannot be renewed.

Deadlines: Standard dates — February 16, June 16, October 16 <<more>>

General Interest and Cross Disciplinary

Institute for Research on Innovation and Science (IRIS) IRIS Researcher Awards

Deadline: November 1

IRIS “seeks to fund researchers who will use the IRIS data to address questions about the social and economic returns to investments in research. IRIS seeks to enable fundamental research on the results of public and private investments that support discovery, innovation, and education on the campuses of U.S. universities. We accomplish that goal by: (1) collecting and curating data from universities around the country; (2) cleaning, integrating and protecting that data in our capacity as an IRB approved data repository; (3) partnering with the U.S. Census Bureau to link university data to restricted federal micro-data; and, (4) making the resulting datasets as broadly available to research users as the law and responsible research practice allow.... Proposals submitted for IRIS Researcher Awards must emphasize the use of IRIS data in projects that address open issues in the study of science and technology and in science policy.”

“Up to \$15,000 for dissertation awards and up to \$30,000 for early career and established researcher awards will be disbursed to the recipient’s institution.”

National Geographic Society Grants Program

Deadlines: Standard grant—October 3, 2017, January 3, 2018, and ongoing quarterly. Early Career Grant — September 24, 2017, November 29, 2017 and ongoing quarterly.

“The National Geographic Society awards grants for conservation, education, research, storytelling, and technology through its Committee for Research and Exploration. All proposed projects must be novel and exploratory, and be of broad interest. National Geographic Society grant-funded projects should be bold, innovative, and transformative.”

Grants types include Early Career Grant and

Standard Grant in the following areas: The Human Journey, Wildlife and Wild Places, Our Changing Planet.

“The Committee will not usually consider applications that support strictly laboratory or collections work. Grants are awarded on the basis of merit and exist independent of the Society’s other divisions.” [<<more>>](#)

Earhart Foundation Fellowship Research Grants in the Humanities & Social Sciences

Deadline: rolling

The Earhart Foundation offers grants ranging from \$520 to \$20,200, averaging \$8,919, to “Professional established individuals who are associated with educational or research institutions. The effort should lead to advancement of knowledge through teaching, lecturing, and publication. Emphasis is on disciplines from the social sciences and humanities such as economics, philosophy, international affairs, and government/politics.” [<<more>>](#)

Arts and Humanities Funding

American Philosophical Society Franklin Research Grants

Deadlines: October 2, 2017, and December 1, 2017

“Since 1933, the American Philosophical Society has awarded small grants to scholars in order to support the cost of research leading to publication in all areas of knowledge. In 2016–2017 the Franklin Research Grants program awarded \$470,000 to 89 scholars, and the Society expects to make a similar number of awards in this year’s competition. The Franklin program is particularly designed to help meet the costs of travel to libraries and archives for research purposes; the purchase of microfilm, photocopies, or equivalent research materials; the costs associated with fieldwork; or laboratory research expenses.” Maximum funding is \$6,000. Within the Franklin Research Grants, the APS offers two special programs—The British Academy Fellowship for Research in London, and the Institute for Advanced

Studies in the Humanities Fellowship for Research in Edinburgh. <<more>>

CLAGS Center for LGBTQ Studies The Robert Giard Fellowship

Deadline: November 15 for photography based work

“An annual award named for Robert Giard, a portrait, landscape, and figure photographer whose work often focused on LGBTQ lives and issues, this award is presented to an emerging or mid-career artist, from any country, working in photography, photo-based media, or moving image, including experimental, narrative, or documentary forms of these media. The award now alternates annually between artists working with still image (photography) and those working with moving image (video or film).

In either case, this award will support the development or completion of a project, one that is new or continuing, that addresses issues of sexuality, gender, or LGBTQ identity. The Foundation is receptive to a variety of projects and approaches to these topics.” <<more>>

Institute for Advanced Study Historical Studies Memberships

Deadline: November 1, IAS recommends turning in proposal by October 15 to allow time for references to be contacted and letters submitted by the November deadline.

IAS “is an independent private institution founded in 1930 to create a community of scholars focused on intellectual inquiry, free from teaching and other university obligations. Each year scholars from around the world apply to come to the Institute to pursue their own research. Those who are chosen are offered a membership for a set period. Members receive access to the extensive resources of the Institute, including offices, access to libraries, subsidized restaurant and housing facilities, and some secretarial services.

THE SCHOOL OF HISTORICAL STUDIES supports scholarship in all fields of historical research, but is concerned principally with the history of western,

near eastern and Asian civilizations, with particular emphasis upon Greek and Roman civilization, the history of Europe (medieval, early modern, and modern), the Islamic world, East Asian studies, art history, the history of science and philosophy and modern international relations. **The School also offers the Edward T. Cone Membership in Music Studies.** Each year the School welcomes approximately forty Members selected on the basis of both external and internal review. Most are working on topics in the above mentioned fields, but each year the School also selects some scholars working in other areas of historical research. Members in the School are appointed for either one term (first term Sept. 24 to Dec. 21, second term Jan. 14 to April 12) or for two terms, amounting to a full academic year.” <<more>>

Education

Brady Education Foundation

Deadline: December 1, 2017

“The Brady Education Foundation seeks to close the achievement/opportunity gap for children at risk for poor school outcomes due to environmental factors associated with living in poverty.” The Foundation funds two types of projects—one-year Program Development and Existing Program Evaluation for up to three years. Both of them are intended to “develop and test the feasibility of new programs for promoting positive cognitive and/or achievement outcomes for children (birth through 18 years) from underserved groups and/or low-resourced communities (minority ethnic groups, low-income families).” Grants should promote “collaboration between researchers and educators via the funding of program development and program evaluations in education. Currently, the Foundation is particularly focused on the development and evaluation of programs that are consistent with a strength-based approach and show promise of being feasible, effective and sustainable.” They favor projects that “leverage other funding.” <<more>>

Social Science

Institute for Advanced Study School of Social Science Memberships

Deadline: November 1, IAS recommends submitting applications by October 15 to give time for references to be contacted and reference letters to be received.

“Each year, between 20 and 25 scholars are selected as Members in the School of Social Science. A completed doctorate or equivalent is required by the application deadline. Memberships are awarded at both the junior and senior levels. They are for the full academic year only unless the scholar is from a country with an academic calendar that is substantially different than the one in the U.S., in which case we will consider single-term Memberships. Scholars may be considered for a second residency if a sufficient amount of time has passed since their initial Membership. Members are expected only to pursue their own research and participate in the seminars. The theme for 2017-18 is "The Social Sciences in a Changing World" but applications outside the theme are also welcomed. An interdisciplinary dialogue will be fostered and applications are strongly encouraged from scholars across the social sciences, *whether or not their research corresponds to the theme.*” Emphasis theirs.

STEM (Science, Technology, Engineering, and Mathematics) Funding

American Chemical Society Award for Encouraging Women into Careers in the Chemical Sciences

Deadline: November 1, 2017

“Nominees for the award may come from any professional setting: academia, industry, government, or other independent facility. The award is intended to recognize significant accomplishments by individuals in stimulating women in elect careers in the chemical sciences,

and engineering, and in generating a broader appreciation of chemistry as the central science.”

NASA Hubble Fellowship Program

Deadline: November 2, 2017

Formerly three separate fellowships—Einstein, Hubble, and Sagan—The NASA Hubble Fellowship Program “supports outstanding postdoctoral scientists to pursue independent research in any area of NASA Astrophysics, using theory, observation, experimentation, or instrumental development.

The new NHFP preserves the legacy of NASA’s previous postdoctoral fellowship programs; once selected, fellows are named to one of three sub-categories corresponding to NASA’s “big questions:”

How does the Universe work? – Einstein Fellows

How did we get here? – Hubble Fellows

Are we alone? – Sagan Fellows”

“NHFP fellowships are tenable at U.S. host institutions of the fellows' choice, subject to a maximum of two new fellows per host institution per year” [<<more>>](#)

Chemical Heritage Foundation Beckman Center Fellowships

Deadline: January 15, 2018

“The Beckman Center offers fellowships on an annual cycle for scholars doing research in the history and social studies of chemistry and related sciences, technologies, and industries. Fellows are expected to participate in biweekly informal writing groups and give at least one lunchtime lecture. They also have the opportunity to take part in a variety of outreach activities while in residence at CHF. About 20 fellowships are given out annually, making the Beckman Center the largest private fellowship program in the history of science in the United States.” Barnard faculty might consider applying for the Short-Term Fellowships, “available to researchers whose work requires use of collections housed at CHF. Stipends are \$3,000 per month. Short-term fellowships can

last from 1 to 4 months." Longer term Postdoctoral Fellowships are also available.

Institute for Advanced Study Natural Sciences Membership

Deadline: November 15

"The School of Natural Sciences will have several openings for members in theoretical physics, astrophysics, and biology for the academic year 2018-2019. The positions are at a postdoctoral or higher level in the areas of astrophysics, theoretical biology, cosmology, mathematical physics, quantum field theory, particle phenomenology, string theory and quantum gravity. Postdoctoral members are selected on their ability to conduct independent research but they frequently collaborate with each other, with faculty members at the Institute or Princeton University, and with researchers at other institutions.

Postdoctoral appointments are for three years with full salary support. We also have openings for long-term (5 year) members and Bahcall Fellows. Salary is above post-doctoral level and is commensurate with qualifications. In addition to exceptional qualifications for pursuing his or her individual research, the successful candidate for a long-term membership should be interested in talking to, and possibly collaborating with, other post-doctoral members. Women and minorities are encouraged to apply.

We also offer Junior Visiting Professorships.

Applicants should hold a faculty or equivalent position and normally should be within ten years of receiving their Ph.D. Support will be provided to spend a period between one term and one year at the Institute. Junior Visiting Faculty are expected to conduct their own research and to help make the research environment at the IAS stimulating to the other members of the school." [<<more>>](#)

News Items

From the NSF — Dear Colleague Letter: Implementation of "No-Deadline," Full-proposal Submission Process for Most Programs in the Directorate for Biological Sciences

"In order to promote interdisciplinary research that crosses biological scales and traverses current divisional boundaries, BIO will implement a "no-deadline," full-proposal mechanism for receiving and reviewing proposals submitted to core programs in the Division of Environmental Biology (DEB), the Division of Integrative Organismal Systems (IOS), the Division of Molecular and Cellular Biosciences (MCB), and to the programs in the Research Resources Cluster of the Division of Biological Infrastructure (DBI).

"By accepting proposals at any time, investigators will have greater opportunities to prepare their proposals, build strong collaborations, and think more creatively, thereby resulting in more complex, interdisciplinary projects that have the potential to dramatically advance biological science. ...

"For these changes to take effect, the core programs in DEB and IOS are discontinuing use of the preliminary proposal mechanism in 2018. **There will be no call for preliminary proposals in January 2018.**

"All four divisions will release new solicitations to replace these in the middle of calendar year 2018, inviting proposals to be funded with FY 2019 funds. **There will be no deadlines for submissions to any of the new solicitations.**"
