We hope your fall semester is off to a good start.

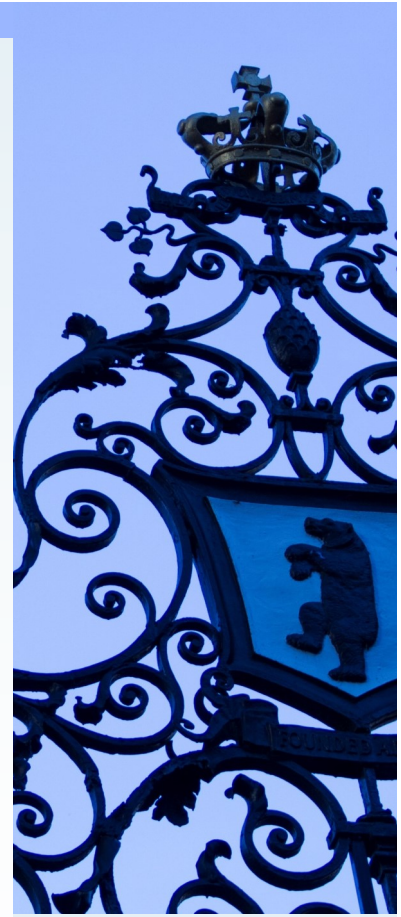

Featured Funding Opportunity

The Obama Foundation Fellowship

“A Wave of Civic Innovation”

Now out of the White House, Michelle and Barack Obama are putting their prodigious energies into non-governmental efforts for broad social change.

To this end, they have created the Obama Foundation whose “mission is to inspire and empower people to change their world.” The Foundation is offering Fellowships to “individuals who are working to solve important public problems in creative and powerful ways. We are inspired by a broad vision of what it means to be ‘civic,’ one that includes leaders tackling a range of issues, in both traditional and unconventional ways.”

They itemize five qualities they want to support in grant-seeker—“civic innovators,” “discipline diverse,” “at a tipping point in their work,” “talented, but not connected,” and “good humans.”

“This fellowship is for organizers, inventors, artists, entrepreneurs, journalists, and more... [who] have already demonstrated meaningful impact in their communities, gaining recognition among their peers for their contributions. Now, they stand at a breakthrough moment in their careers. They’re poised to use the Fellowship to significantly advance their work, perhaps by launching new platforms, expanding to broader audiences, or taking their work to a national or global stage.”

“Our two-year, non-residential Fellowship will offer hands-on training, resources, and leadership development. Fellows will also participate in four multi-day gatherings where they will collaborate with each other, connect with potential partners, and collectively push their work forward. Throughout the program, each Fellow will pursue a personalized plan to leverage Fellowship resources to take their work to the next level.”

A funding range is not mentioned, but airfare to and from Fellowship gatherings, lodging, and all meals are paid for during the events.

Global Grand Challenges Grants

Deadline: November 8, 2017

Funded by USAID, the Bill and Melinda Gates Foundation, and Grand Challenges Canada, “[T]he Grand Challenges family of initiatives fosters innovation to solve key health and development problems.” Three challenges are open this fall.

1. **Innovations for Integrated Diagnostics Systems:** The challenge is to make technological and process improvements in Digital Tracking & Connectivity, Simplified/Streamlined Workflow, Sample Collection & Specimen Processing, and Transportation & Distribution of Samples. “The Academic Writing residency is for university and think tank-based academics, researchers, professors, and scientists working in any discipline. Successful applicants will demonstrate decades of significant professional contributions to the field or show evidence of being on a strong upward trajectory for those earlier in their careers. ... The Center has a strong interest in proposals that align with the Rockefeller Foundation’s efforts to promote the well-being of humanity, particularly through issues that have a direct impact on the lives of poor and vulnerable populations around the world. These issues include, but are not limited to, health, economic opportunity, urban resilience, as well as food and agriculture.”

The James Marston Fitch Charitable Foundation Mid-Career Fellowship

Deadline: October 25, 2017

“Research grants of up to \$15,000 will be awarded to one or two mid-career professionals who have an academic background, professional experience and an established identity in one or more of the following fields: historic preservation, architecture, landscape architecture, urban design, environmental planning, architectural history and the decorative arts. The James Marston Fitch Charitable Foundation will consider proposals for the research and/or the execution of the preservation-related projects.” [<<more>>](#)

The Fitch Foundation Richard L. Blinder Award

Deadline: October 25, 2017

“The Richard L. Blinder Award will be presented biennially to an architect or other professional in a related historic preservation field for a proposal

exploring architecture and preservation. The proposal may focus on a real project or it may be a polemical exercise; in either case, originality is highly valued. The proposal must advance architectural preservation in the United States. The product can be graphic, text-based or a combination of both and must be able to be shared with the architecture and preservation community. New York State Council on the Arts/New York Foundation for the Arts NYSCA/NYFA Artists’ Fellowships

Deadline: January 24, 2018

“NYSCA/NYFA Artist Fellowships, awarded in fifteen different disciplines over a three-year period, are \$7,000 cash awards made to individual originating artists living and working in the state of New York for unrestricted use. These fellowships are not project grants but are intended to fund an artist’s vision or voice, regardless of the level of his or her artistic development.”

2018 media categories include fiction, folk/traditional Arts, Interdisciplinary Arts, Painting, and Video/Film. Media categories change on a three year cycle. [<<more>>](#)

Children’s Literature Association Faculty Research

“[I]ndividual awards may range from \$500 to \$1,500, based on the number and needs of the winning applicants. The grants are awarded for proposals dealing with criticism or original scholarship with the expectation that the undertaking will lead to publication and make a significant contribution to the field of children's literature in the area of scholarship or criticism.”

Rutgers University Louis O. Kelso Fellowships

Deadline: December 31, 2017

Supported by the Employee Ownership Foundation, the Kelso Fellowships "are awarded to outstanding scholars studying the topic of broadened ownership of capital in a democratic society in the United States. Ph.D. candidates, postdoctoral scholars, or visiting professors in the areas of business/economics/labor studies/management, history, law, philosophy, political science, psychology, public policy, or sociology may apply. The general theme of the fellowship includes the study of the idea and practice and public policy of broadening the ownership of capital assets in society such as the Employee Stock Ownership Plan (ESOP), which broadens the ownership of corporations, as well as approaches whereby consumers may have capital ownership of enterprises and individual citizens may have access to opportunities for capital acquisition. The relevance of these and other related ideas to the concept of economic democracy and democratic capitalism can also be pursued." <<more>>

STEM (Science, Technology, Engineering and Mathematics) Funding

The Nature Conservancy NatureNet Science Fellow Program

Deadline: November 1, 2017

The NatureNet Science Fellows Program "aims to bridge academic excellence and conservation practice to confront climate change, and to create a new generation of conservation leaders who

combine the rigor of academic science with real-world application. Within this framework, the program goals are to:

- Support innovative and impact-oriented research that help deliver TNC outcomes;
- Invest in the talent potential of a new generation of climate change leaders;
- Recruit scientists who bring a diversity of culture, experience, and ideas into conservation; and
- Provide partner universities and fellows with access to real-world conservation issues."

The two overarching themes are "Halting Climate Change" and "Adapting to Climate Change."

National Academies of Sciences, Engineering, and Medicine Postdoctoral Fellowships

Deadline: December 7, 2017

"Through its program of Fellowships, the Ford Foundation seeks to increase the diversity of the nation's college and university faculties by increasing their ethnic and racial diversity, to maximize the educational benefits of diversity, and to increase the number of professors who can and will use diversity as a resource for enriching the education of all students." <<more>>

National Science Foundation/Intel Partnership on Foundational Microarchitecture Research

Deadline: January 12, 2018

This solicitation seeks microarchitecture technique innovations beyond simplistic, incremental scaling of existing microarchitectural structures. Specifically, FoMR seeks to advance research that has the following characteristics: (1) high IPC techniques ranging from microarchitecture to code generation; (2) microarchitecture techniques that marshal chip resources and system memory bandwidth to accelerate sequential or single-threaded programs; and (3) techniques to support efficient compiler code generation. Advances in these areas promise to provide significant performance

Pershing Square Sohn Cancer Research Society Prize for Young Investigators in Cancer Research

Deadline: November 6, 2017 for Letter of Intent.

The prize "provides New York area-based early career scientists the freedom to take risks and pursue their boldest research at a stage when traditional funding is lacking. Prize winners each receive \$200,000 a year for up to three years. At least six grants are awarded annually. The Pershing Square Sohn Cancer Research Alliance (PSSCRA) is dedicated to accelerating cures for cancer by advancing the pursuit of innovative cancer research and by facilitating collaborations between the science and business communities. PSSCRA seeks to guide philanthropic funds to feed critical scientific discoveries, attracting like-minded investors to the cause of fighting cancer and creating a pipeline for early-stage biomedical investments." Department of the Interior Fish and Wildlife Service—Neotropical Migratory Bird Conservation Act Grants

Deadline: November 7

Grants between \$10,000 and \$200,000 will be awarded "to support projects that promote the conservation of neotropical migratory birds and their habitats in the United States, Canada, Latin America and the Caribbean." [<<more>>](#)

National Science Foundation Industry-University Cooperative Research Centers Program

Deadline: October 18 for preliminary proposal, December 20 for full proposal

This program "develops long-term partnerships among industry, academe, and government. The Centers are catalyzed by an investment from the National Science Foundation (NSF) and are primarily supported by industry Center members, with NSF taking a supporting role in the development and evolution of the Center. Each

Center is established to conduct research that is of interest to both the industry members and the Center faculty. An IUCRC contributes to the nation's research infrastructure base and enhances the intellectual capacity of the engineering and science workforce through the integration of research and education." News Items

From the NIH — Next Generation Researchers Policy Now Posted

"As described in the policy, NIH institutes and centers (ICs) will prioritize meritorious applications that request funding for Early Stage Investigators (ESIs) and for Early Established Investigators (EIs) who are at risk for losing all NIH funding or who have only one active NIH award. Here are some key definitions:

Early Stage Investigator (ESI): A Program Director / Principal Investigator (PD/PI) who has completed their terminal research degree or end of post-graduate clinical training, whichever date is later, within the past 10 years. Furthermore, these applicants would not have competed successfully as a PD/PI previously for a substantial NIH independent research award. A list of NIH grants that a PD/PI can hold and still be considered an ESI can be found at <https://grants.nih.gov/policy/early-investigators/list-smaller-grants.htm>.

Early Established Investigator (EEI): a PD/PI within 10 years of receiving their first substantial, independent competing NIH R01 equivalent research award as an ESI." [<<more>>](#)

"...[T]o be fair to all concerned the NIH will consistently apply standards for application completeness and for compliance with all submission requirements and NIH policies. NIH may withdraw any application identified during the receipt, referral, and review process that is

incomplete or noncompliant with instructions in the SF424 (R&R) Application Guide, the Funding Opportunity Announcement, and relevant NIH Guide Notices.” <<more>>

National Science Foundation Directorate for Education and Human Resources announces call for proposals “to support fundamental research on methodologies that support valid inferences in STEM education.”

The deadline will be mid-September. There’s a rolling deadline for Conference and EAGER proposals.

The ECR “invites proposals on the development, application, and extension of formal models and methodologies for STEM education research and evaluation, including methods for improving statistical modeling, qualitative modeling, measurement, replication, and learning analytics. This includes research on methodological aspects of new or existing procedures for data collection, curation, and inference in STEM education. Similarly, ECR seeks proposals related to collection of unique databases with cross-boundary value, particularly when paired with innovative developments in measurement or methodology (standard statistical modeling, qualitative research, measurement, replication and learning analytics). Proposers must demonstrate how advances in the methodology will support important theoretical insights in STEM education

research or evaluation.” The ECR is offering three levels of funding from \$500,000 to \$2,500,000. In addition, NSF is interested in supporting capacity building proposals through synthesis projects, conference proposals, and Early Concept Grants for Exploratory Research (EAGER) proposals.
